## APPIDAVIT FOR ARREST WARRANT

The undersigned affiant, being a peace officer under the laws of the State of Texas, duly authorized, and having been duly sworn, on his path would state as follows:

Affiant is employed by the Besar County Sheriff's Office, Currently assigned to the Violent Crimes Section, Human Trafficking Unit and has been so office, Currently assigned to the Violent Crimes Section, Human Trafficking Unit and has been so employed for 17 years. Your affiant has probable cause for the said belief by reason of the following facts and tryklence to believe that DEFENDANT committed Sex Trafficking of a Minor, Sexual Performance of a Child, and Sexual Assault of a Child of said complainant.

1.) Affiant found that on or about March of 2009, a 14 year old female, who is known to me, hereinafter referred to as VICTIM, was kidnapped from San Antonio, Texas. The VICTIM then was taken over a course of several days to various locations in Bexai County. One of the locations the VICTIM was taken to was 2650 Thousand Oaks #3302. The DEFENDANT

along with his wife lived at 2650 Thousand Oaks #3302, during this time period.

- Affigut found that the DEFENDANT and his Wife Conspired with another suspect known to Affiant, to have the VICTIM engage in sexual acts with persons willing to pay money.
- 3.) Affiant found that the VICTIM was taken to a location where a person willing to pay money in exchange for sex with a young girl would be. The DEFENDANT, his wife and another person known to Affiant had the VICTIM change clothes into something more revealing. Then the DEFENDANT'S wife and another person known to Affiant transported the VICTIM to where a person willing to pay for sex was waiting.
- 4.) The DEFENDANT on a superste occasion, along with another person knows to Affiant, digitally penetrated the VICTIM'S vagina and anus. The DEFENDANT committee this act while the VICTIM was showering after just having been forced to have sex with another person known to Affiant in exchange for money.
- 5.) The DEFENDANT further conspired with a person known to Afflant: to have the VICTIM engage in sex with another person known to Afflant, then extert money from that person for having had sex with a minor.
- 6.) Affiant respectfully requests issuance of warrants for the arrest of the said Alvin C. Robertson, charging him with the offenses of Sex Trafficking of Minor, Sexual Performance of a Child, and Sexual Assault of a Child. In Violation of Texas Penal Code Section 20A.02, 43.25, and 22.011 against the peace and dignity of the State of Texas.

Your affiant believes the facts in the above stated paragraphs set forth sufficient evidence to establish probable cause that the offense of Sex Trafficking of a Minor, Sexual Performance of a Child, and Sexual Assault of a Child have been committed by the DEFENDANT.
