Arkansas's Preferential Primary & Nonpartisan Judicial Election

Voting Guide

REGISTRATION

Citizens must submit an Arkansas Voter Registration Application by the **April 19, 2010** deadline to participate in this election. (The deadline actually falls on April 18, 2010, but since that is on a Sunday, the deadline is extended to the next day.) The application is available in both [English](#) and [Spanish](#). The original application must be submitted to your county clerk or the Secretary of State in person or by mail.

Even if you are already a registered voter, it is important to keep your voter registration information current. Verify your information using [Voter View](#) available at www.votenaturally.org. If you see anything that needs to be updated, please contact your county clerk immediately. [Click here](#) for a listing of contact information for county clerks.

PARTY PREFERENCE

When filling out the voter registration application, you'll notice a box to list party affiliation. Listing this information is not required, but if you do choose to list a party, you are still free to vote in another party's primary election since Arkansas has open primaries. (An open primary is a preferential election in which voters do not have to be registered with a particular party in order to participate in that party's election.)

BALLOT CHOICE

You'll have a choice among three different ballots in this election: Democratic Party, Republican Party, or Nonpartisan Judicial. While the judicial races are included on the party ballots, only the nonpartisan judicial races in your district will appear on the nonpartisan judicial election ballot.

POLITICAL RACES

You may want to review which offices are up for election in your district, and who has filed to run in those races before making your ballot choice. [Click here](#) to view a list of the seats up for election and the certified candidates for each race. Voters in participating counties may view their precinct-specific sample ballot online by searching [Voter View](#) and selecting "View Sample Ballot."

ABSENTEE VOTING

If you know you will be unavoidably absent from the polls on the **May 18, 2010** Election Day, you may request an absentee ballot from your county clerk. The clerk must receive the mailed absentee ballot request application by **May 11, 2010**. Voters must mail back their ballot by Election Day.

EARLY VOTING

Early voting will be available from **Monday, May 3 - Monday, May 17** statewide from 8:00 am to 6:00 pm Monday through Friday, 10:00 am to 4:00 pm on Saturday, and ending at 5:00 pm on the Monday before the election. Each county will provide at least one early voting location (usually the county courthouse), and some will offer additional satellite locations. See the listing beginning on page 3 for early voting locations in your area. Polling locations for early voting and election day can also be found by searching your voter registration on [Voter View](#).

AT THE POLLS VOTING

The Preferential Primary and Nonpartisan Judicial Election is **Tuesday, May 18, 2010**. Polls are open statewide from **7:30 a.m. to 7:30 p.m.**
