Title: STRUCTURE FIRE

Report Type: I

On 11-27-2010 at approximately 0039 hours, I was dispatched to a structure fire at 701 Dreher Cut Off. Upon arrival I observed the residence fully engulfed in flames. Arch Street Fire Department arrived on scene and began fighting the fire. Firefighters were able to finally get the fire put out when they located the charred body of an unknown male in the north east corner of the residence. We then secured the perimeter, and I began a crime scene log.

Sgt. Anderson arrived on scene soon after the body was found, and contacted the Investigations Sergeant. A short time later Investigator Stubenrauch, Investigator Massiet, Sgt Blain and Investigator Holt arrived to process the scene. The crime scene log was transferred to Investigations.

The residence was a total loss with estimated damage being \$50,000.00.
