All documents referenced in any reported testimony, trial or hearing, inclusive of field notes made by law enforcement, whether or not same were admitted into evidence in said prosecution; and

The transcripts of witnesses' testimony in the two jury trials in the Dunn case and in the concluded State v. Kevin Jones case.

4) Defendant is a public employee, a specially appointed prosecuting attorney, and has custody and control of the records, has responded that the "case is still under investigation" and refused to allow access.

5) The records are public records as defined by the FOI Act, specifically A.C.A. §25-19-103(5)(A) because they are records maintained by a public employee within the scope of defendant's employment.

6) The subject records have been referenced in two public trials that ended in mistrials.

7) The records have been disclosed to Gary Dunn and his attorneys.

8) The records are not exempt by A.C.A. §25-19-105(b) which only applies to "undisclosed" records.

9) A justiciable issue exists.

WHEREFORE, plaintiff prays that an order issue declaring the records, supra, to be public records, ordering plaintiff's access thereto and awarding plaintiff costs and attorney fees.


