19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 *SECTION 1. Arkansas Code §§ 7-2-102 - 7-2-105 are amended to read as*
22 *follows:*

24 *(a) The First Congressional District shall be composed of:*
