Harrelson stated he is in the process of getting a divorce from his wife, Lori Harrelson. Harrelson stated he had his daughter for the weekend and was attempting to drop her off at 1800 hours. Harrelson stated he went inside the house, without anybody's objection, with his daughter to help her set up her new I-Pod, while his soon to be ex-wife gathered their daughters belongings out of his vehicle. Harrelson stated he walked into the house and saw Mrs. Harrelson's new boyfriend, Cary Pessel, sitting in his chair. Harrelson stated he told Pessel that he did not think it was right to be inside the house, in front of their daughter, because their divorce was not yet final. Harrelson stated Pessel then jumped out of the chair and verbally challenged him and then started attacking him. Mr. Harrelson did not clarify exactly how the fight ended. Mr. Harrelson was advised that the police department was not able to make Mr. Pessel leave. Mr. Harrelson stated that he understood that and that he wasn't asking for the police department to do that.

I observed that Harrelson's face was swollen on both sides, both eyes showed signs of bruising, and he had a small cut on the tip of his nose. There was also a scratch on Mr. Harrelson's left cheek approximately 3 inches long. Harrelson stated his wife filed for divorce approximately 9 months ago and he also has paperwork on file. It should be noted I asked Harrelson if he would like Life Net to come take a look at his injuries, Harrelson refused.

I then spoke to Cary Pessel who stated he was sitting in a chair in the living room when Harrelson walked in. Pessel stated as Harrelson walked through the living room he observed Harrelson hand witness, Brent Smith, his glasses. Pessel stated Harrelson then walked over to where he was sitting and attacked him. Pessel stated he was still sitting down in the chair when Harrelson tried hitting him 5-7 times in the face with a closed fist. Pessel stated he was able to avoid being hit but had to defend himself by wrestling Harrelson to the ground. Pessel stated he gained control of Harrelson by getting on top of him, taking him to the ground and then struck him several times in the face. Pessel stated he has been dating Mrs. Harrelson since January 2011. Pessel did not have any visible injuries. Mr. Pessel was very upset and stated he would have been more than happy to fight Mr. Harrelson if that's what Mr. Harrelson wanted but could not believe Mr. Harrelson attacked him in front of both of their 6 year old daughters. When asked if he wanted to file charges Mr. Pessel stated that he did.

I then spoke to witness Brent Smith who took us into the living room. Smith stated that he was sitting on the couch when Harrelson walked through the front door. Smith stated that Harrelson handed him his glasses and told him to hold onto them. Smith stated he had no idea why Harrelson was handing him his glasses. Smith stated Harrelson then walked over to were Mr. Pessel, who he refereed to as "that guy", was sitting and attacked him. Mr. Smith had to ask Mrs. Harrelson what Mr. Pessel's name was. Smith stated Harrelson attempted to strike Mr. Pessel several times in the face, Mr. Pessel then wrestled Mr. Harrelson to the ground and struck him several times in the face. Mr. Smith saw Mr. Pessel stop hitting Mr. Harrelson as Mrs. Harrelson came inside the residence screaming. Mr. Smith advised that Mr. Harrelson then picked up his 6 year old daughter and stated he was leaving with her. Mr. Smith told Mr. Harrelson to stop as Mrs. Harrelson was yelling for him to put their daughter down. Mr. Harrelson put his daughter down and exited the residence. Mr. Smith stated that he thought Mr. Harrelson acted out in anger as an emotional response to seeing Mr. Pessel in the residence. Mr. Smith stated that he was shocked about Mr. Harrelson's actions and referred to the incident as totally uncalled for and unprovoked.

I then spoke to Lori Smith Harrelson who stated her and Harrelson had been separated for

approximately 9 months. Mrs. Harrelson stated that she was cooking in the kitchen when Mr. Harrelson pulled into the driveway to drop their daughter off. Mrs. Harrelson stated she went out to his vehicle to help gather their daughters belongings. Mr. Harrelson then told Mrs. Harrelson that he was going to go inside to help their daughter set up an I-POD he had just purchased for her. Mrs. Harrelson stated she told Mr. Harrelson no and that she didn't think that was a good idea. Mr. Harrelson then went into the residence and a few seconds later Mrs. Harrelson heard a bunch of commotion. Mrs. Harrelson stated when she walked in the living room Mr. Harrelson and Mr. Pessel were fighting. Mrs. Harrelson stated she started to scream at them, telling them to stop and was pushing both of them. Both Mr. Harrelson and Mr. Pessel stopped fighting. Mrs. Harrelson then saw Mr. Harrelson pick up their daughter and say he was leaving with her. Mrs. Harrelson then grabbed her daughter and told him that he could not take her. Mrs. Harrelson stated her and Harrelson had been getting along fine and she never thought this could have happened. Mrs. Harrelson added that Mr. Harrelson has never been violent and that he has never even been involved in a fight in his whole life. It should be noted that Mrs. Harrelson had two splotches of blood on her shirt that appeared to be transferred from Mr. Harrelson due to the fact that nobody else was bleeding.

While speaking to Mrs. Harrelson inside the living room, where the incident occurred, I observed a knocked over vase on an end table next to the chair where Mr. Pessel was sitting. I also saw a broken vase on the ground next to the chair.

It should be noted that I interviewed all parties involved separately.

I issued Harrelson and Pessel a VIG/CCN and explained follow up procedures to them.
