The amortization will not be charged to Client as a Direct Cost or an Allocated Charge. Notwithstanding the foregoing, the amortization expense of the Financial Commitment shall be included as a Direct Cost solely for purposes of determining ARAMARK's Entitlement as set forth herein. Upon expiration or termination of this Agreement by either party for any reason whatsoever prior to the complete amortization of the 2009 Financial Commitment, Client shall reimburse ARAMARK for the unamortized balance of the 2009 Financial Commitment on the date of expiration or termination."

At the beginning of each semester, Client shall furnish ARAMARK with a list of all persons entitled to meals at Board Plan rates and shall advise ARAMARK weekly in advance of any changes in the list. Billings to Client for each week of the Accounting Period will be based on the number of persons listed on the Monday morning of such week before breakfast. No allowance will be made for meals or days which contract patrons miss, and partial days will be considered full days for billing purposes.

**C. Casual Meals:** ARAMARK shall provide casual meals to Client's students, faculty, staff and guests at the following rates:

Breakfast:	\$3.93
Brunch:	\$4.84
Lunch:	\$4.84
Dinner:	\$5.03
Premium Dinner:	\$6.07

**G. Pre-Function Meals:** ARAMARK shall provide pre-function meals as directed by Client at the rate of \$11.20 per day during August 2004. Sales with respect to such meals shall not be subject to the commission calculation set forth in Paragraph 10.D hereof."

2. The parties hereby agree that the amount of ARAMARK's Financial Commitment to be committed during the first operating year of the Agreement, which amount of "\$280,000" is referenced in item (i) of Subparagraph L of Paragraph 13, "FINANCIAL TERMS," shall be revised to read "\$291,960.23". All other terms of such Paragraph and the Agreement, except as otherwise set forth herein, shall remain in full force and effect.

In all other respects, the Agreement shall remain in full force and effect. This Letter Amendment shall be attached to, and become part of, the Agreement.




