On 9-5-11 at 0810hrs officers along with fire rescue and MEMS were dispatched to 16 Village Way concerning a drowning in a hot tub. Upon my arrival I knocked on the front door and I identified myself, I then began to open and enter and announce my presence again when I heard a voice behind me say "It's inside". I turned around to observe a w/m, later identified as Christopher Barbour (w/m DOB 5-13-75), he escorted me inside and informed me that the person was in the bathroom. I entered the back bedroom and then into the adjoining bathroom where I observed a jacuzzi bathtub in the corner. As I approached I observed no water in the tub, I then observed a naked w/m lying on the floor of tub. The subject was lying on his right side in a fetal position, his face was blue and purple in color with a chain around his neck. The chain was silver in color and consistent with what I believed to be a dog collar. A check of vitals on the subject was met with negative results, the subject was also cold to the touch. I also observed a small ring of blood around the bottom of the tub. Fire rescue arrived along with Sgt. Collins and Ofc. Mayfield. I then made contact with Mr. Barbour who stated that he did reside at this address and that the deceased did not. He further explained that he only knew the deceased person as Dexter and that he arrived last evening accompanied by Brett Cummins. CID was notified along with Chief Williams. Chief Williams arrived on the scene and spoke with Mr. Barbour who gave verbal consent to check the home, he was also verbally read his Miranda Rights by Chief Williams. This officer did observe Chief Williams perform these duties. It was at this point that Mr. Barbour explained the events from last evening. He stated that last evening he called his friend Brett Cummins (w/m DOB 12-1-77) and invited him to his home. Mr Cummins arrived at approx. 2000hrs and was accompanied by his friend Dexter, (he would later be identified by this dept. as Dexter Williams w/m DOB 7-5-87), they then began to drink and use illegal narcotics. Mr Barbour stated that he was not sure of the drugs that they were using but that they were snorting them. He then stated that at approx. 2200 hrs. Brett and Dexter entered the hot tub (jacuzzi), he later followed them into the tub where they continued to drink. He then stated that he exited the tub and went to sleep on the couch in the living room at approx. 2300 hours. He then stated that he awoke this morning at approx. 0800hrs and overheard Brett snoring very loudly. He entered the bedroom and observed that it appeared that no one had slept in the bed, he then entered the bathroom where he observed Brett and Dexter in the tub which had no water in it. He observed that Dexter's head was lying behind Brett's left shoulder. He began to gather glassware that had been left in the bathroom and awaken Brett. After Brett awoke they discovered that Dexter was not conscious and his face was a different color. He then explained that Brett screamed and became ill and left the bathroom and vomited on the carpet in the living room. This was done at the end of the couch and he advised that they cleaned the vomit prior to our arrival. We did observe a bottle of carpet cleaner and a washcloth on the coffee table. Mr. Barbour then explained that Brett left the home and stated that he was going to return. Mr. Barbour obtained Brett's lpn (AR 329LEZ) in the event that Brett did not return. Mr. Cummins did return to the residence and gave a statement to investigators. Mr. Barbour then stated he then notified this dept. for assistance. CID arrived and the scene was taken over by Det. On 09/05/11 at approx. 08:10 hours officers including myself responded to 16 Village Way in Maumelle in reference to the report of a deceased person. Dispatch relayed to me that the complainant had found the subject in the bath tub unresponsive. I then contacted Lt. Hansard and on duty CID units to inform them of the situation. I also advised dispatch to start medical personnel. Upon arrival I made contact with Ofc. Roussie who was first on scene inside the residence. Ofc. Roussie was speaking with the responsible party for the residence who was visibly shaken. The residence was secured and Ofc. Mayfield was assigned to conduct a crime scene log by myself. I then went to the master bedroom where I noted a khaki pair of cargo shorts and a pill bottle on a storage ottoman at the end of the bed, I did not disturb or touch either. I then went to bathroom area and noted a white male who appeared to be in his mid twenties in a fetal position inside the tub, it was obvious that he was deceased. The w/m had lividity to his extremities and blood pooling to the head. The deceased was later identified as Dexter Williams w/m 07/05/87. I looked around the room and noted no obvious mechanism of death. The male subject also had what appeared to be a metal chain collar around his neck. I did not note any type physical injury to the subject in the position that he was laying. I returned to the living area and found it to be extremely clean. A short time later Chief Williams and Det. Keller arrived on scene and took charge of the investigation. I along with patrol officers stayed on scene to assist as needed. I did contact Patrick Moore of the Pulaski Co. Coroner's office in reference to reporting the incident, he arrived on scene to photograph and removed the deceased.---144---

Roussie in the master bathroom where I observed a deceased white male in the hot tub laying in the fetal position. While on scene I maintained a crime scene log that included all persons that entered or left the residence upon police arrival with their times. LM 640
