## STATUTORY SENTENCES

**PWID** - Not more than 20 years incarceration in the Bureau of Prisons (BOP) with a possible fine of up to \$1 million and not less than 3 years supervised release

PWID/Conspiracy 50 grams methamphetamine mixture/5 grams methamphetamine actual - Not less than 5 years to Not more than 40 years BOP; fine of up to \$5 million and not less than 4 years supervised release

PWID/Conspiracy 500 grams methamphetamine mixture/50 grams methamphetamine actual - Not less than 10 years to Not more than Life BOP; fine of up to \$10 million and not less than 5 years supervised release

**PWID Methamphetamine on premises where minor is present or resides** - Not more than 20 years BOP consecutive, a fine of up to \$250,000, or both.

**Possession of a firearm in furtherance of a federal drug trafficking crime** - NLT 5 years incarceration BOP, fine of up to \$250,000, and not more than 5 years supervised release. **Witness Tampering** - NMT life, \$250,000, or both, and not more than 5 years supervised release.
