Even though the unrestricted (\$565,113.01) is divided between the Foundation and Simmons, we may use both pools in a discretionary manner

The restricted must be allocated to the Howell Davis Endowed Scholarship (\$17,846.62) and the Lucy

Johnson Endowed Scholarship (\$11,897.75)

Again 50% of each scholarship fund will be returned to the U of A Foundation, Inc. and deposited in the respective scholarship account

I am meeting with Margarette Wallace of Simmons Bank to discuss how we may 1) access the unrestricted funds that remain at Simmons and continue to get a return on our investment; 2) get a check for the U of A Foundation, Inc., and 3) set-up accounts for the funds that will remain at Simmons. I will be sure to contact you with the details of my recommendation to you.

As one of the original program managers for the Endowment Challenge Grant Program, I have been asked to respond the many inquiries on how endowment income can be spent. In accordance to CFR Section 628.45, prior to the 20 year expiration of the grant, grantees are permitted to use 50% of the earned income for any educational purposes.

In accordance to CFR Section 628.45(1)(d), at the expiration of the 20 year grant period, grantees are permitted to spend the total endowment amount on any educational purposes, including improvements on the physical plant.

Section 331(3)(c) of the Higher Education Act (HEA), states that endowment funds can be used for academic programs, maintenance, renovation and construction, etc.

The program office interprets the cited section above to mean that, at the end of the 20 year period, spending of the endowment funds is at the discretion of the President/Chancellor.

Margaret – From your August 20/21 email to Dr. Davis it looks like \$317,378 (\$287,604) of the \$882,491 market value for 1985 and 1986 funds would represent Title III matching funds and private donations(to the Foundation?) for 1986 plus interest. Since the restrictions for 20 years would have expired why weren't half of these funds returned to the Foundation? Restrictions on the funds for the 1986 grant did not end until September 30, 2007.

As I understand it the \$170,000 (\$175,000) to the Alumni Association to pay the settlement with Coach Forte would have come from this \$317,378 (\$287,604) which (together with the \$297,429 remaining in the account from 1985 funds of which 5% was restricted to specific endowed accounts) were the only funds in the Simmons Title III account free of the 20 year restriction. The \$175,000 was taken from the 1985 funds remaining in the Simmons account.

I also understand that 50% of the \$317,378 (\$287,604) would have represented private donations and accumulated interest and the balance would represent what came from the federal matching grant and accumulated interest. Yes. Is all of that correct? It is correct with the corrections noted. Fred

UAPB has been approved for matching funds from the federal government—U. S. Department of Education, Office of Postsecondary Education, Title III, (HBCU Initiatives). The funds from the Foundation that will be used to make the match are derived from UAPB Foundation Fund—George Jones Endowment account (\$18,075); UAPB Foundation Fund—New Millennium Leaders Account (\$62,252). The amounts listed were calculated approximately 6 weeks ago and may be different at this time.

Though only the donations, not the interest, can be matched with federal funds, we request that both interest and donations be deposited in the same account to facilitate better management and tracking.

Dear Margaret:

You have requested that we advise you as to the transfer of certain funds to an account for UAPB in The University of Arkansas Foundation, Inc. ("Foundation").

I will review the situation. For a number of years UAPB has participated in a program under Title III for strengthening your endowment and pursuant to the program private funds have been raised through the Foundation to be matched by federal funds and your funds have been held in an account in Simmons Bank as an endowed fund established by UAPB and invested in accordance with federal regulations. The federal regulations as to the use and restriction of these funds last 20 years and have now expired as to endowed funds established in 1985 and 1986. The 1985 Fund consisted originally of \$240,188 and the 1986 Fund consisted of \$116,130. Half of each amount represents private funds transferred from the Foundation and half represents federal grant funds under Title III. The 1985 Fund has now grown to approximately \$587,650 and the 1986 Fund has grown to \$284,105.

Since the federal restrictions on the investment and use of this endowment with respect to these funds have currently expired or will soon do so, you now propose to transfer the amount of these funds representing the original private donation to an account for UAPB in The University of Arkansas Foundation, Inc. which would be unrestricted as to use although the law requires they be used "for any educational purpose."

There are two dimensions to your question. First, purely as matter of state law, whether funds which were originally donated to the Foundation from private sources and subsequently were transferred to the University for the Title III program, may be returned to the Foundation to be held as unrestricted funds. The answer to this in part is based upon the policy of the Foundation to accept and hold only private donations and not public funds, although you only propose returning to the Foundation the amount originally held by it as private donations. The second dimension to the question is whether there were any restrictions on these funds when they

originally were donated to the Foundation. I believe you have previously advised that 20 years ago these funds were donated to the Foundation as unrestricted funds although they subsequently were used by UAPB to meet the matching requirements for the Title III program to strengthen endowments. Under the law (20 U.S.C. § 1065(a)(2)(B)) these matching funds became a part of the "endowment fund corpus" and after 20 years could be used "for any educational purpose." I know of no document creating the Title III endowment other than the grant application and there are no restrictions on the use of these funds other than those contained in federal law and regulations governing the program.

Based on the foregoing, I think it is within Dr. Davis' discretion to have what originally were private funds transferred back to an unrestricted account in the Foundation subject to the requirement that they may be expended "for any educational purpose."
