Report Type: I

On 05-19-2012, I responded to Spring Hill Baptist Emergency Room to make contact with John Jacob Mosley, who was the victim of the shooting incident.

Upon arrival, I made contact with the emergency room nurse, Shawn Gassaway, who advised me that John J. Mosley had succumbed to the gunshot wound and that he passed away at approximately 2232 hours. Gassaway advised me that John A. Mosley's doctor was Dr. Swindle. Gassaway stated that John J. Mosley had one gunshot wound to the upper right part of his chest.

I made contact with John A. Mosley who advised me that he was the uncle of John J. Mosley and that he was the one who drove him to the emergency room. John A. Mosley stated that they were attending an annual party at 7925 Bayou Drive when he heard three gunshots. John A. Mosley stated that he ran towards the crowd and observed that John J. Mosley was lying on the ground holding his chest. John A. Mosley stated that he loaded him into a vehicle and rushed him to the Springhill Baptist Emergency Room. John A. Mosley stated that John J. Mosley's girlfriend, Rhonda Tucker, was also in the vehicle en-route to the emergency room.

I made contact with John J. Mosley's father, Robert Edward Mosley, who advised me that he was at the party earlier in the day, but had left before the incident took place. R. Mosley stated that he was the next of kin.

I remained on scene until Investigator Garrett arrived. Upon his arrival, the scene was turned over to him.

Title: SHOOTING

Report Type: I

On May 19, 2012 I Deputy Walker responded to an active shooting call with injuries at 7925 Bayou Drive in Scott Ar.

While in route to the location, dispatch advised that one victim has been shot and is being transported to the Emergency Room by a personal vehicle. Dispatch then stated that suspect was still on scene with the handgun, wearing a green shirt and shorts. Dispatch later stated the suspect possibly got into a red passenger car driven by a white female. While in route to the scene I observed a red passenger car driven by a white female on Bayou Road. I made contact with the driver and observed there was only one person in the vehicle. I was then advised by dispatch that the callers are currently stating they believe the subject is still in the area.

Upon my arrival I made contact with Tommy Mosley, who stated Terry Deathrow was the shooter and left the scene prior to our arrival in an unknown direction. Tommy then stated that there is another subject on scene that has been assault and possibly shot by Terry. I then made contact with both subjects and advised dispatch to have MEMS in route to our location. While awaiting for MEMS to arrived, Tommy advised he believes Charles Wilmoth has been shot in his right eye when Terry discharged his firearm.

MEMS Unit 505 and Lieutenant Swagerty arrived on scene. Lieutenant Swagerty then notified the on call Investigator. MEMS Unit 505 started assisting the two injured subjects, who both refused to be transported to the Emergency Room. MEMS Unit 505 advised neither subject was shot, but did have minor lacerations.

Investigators arrived and started processing the scene which was turned over to them.
