On 03192012 Bryce Allen was driving southbound on State Highway 161 approaching an accident scene, at 8411 Highway 161, where Off. DiMatteo, and Jacksonville Fire Department Fire Fighters were located. As Allen drove to the scene he went around Emergency vehicles, and struck Off. DiMatteo and two Jacksonville Fire personnel with his vehicle. Off. DiMatteo was severely injured from the vehicle striking him. One Jacksonville Fire Fighter was severely injured, and one Jacksonville Fire Fighter was killed by the vehicle striking him. The accident scene revealed no signs of Allen attempting to brake prior to striking persons. Also, investigation revealed that Allen appeared to be aiming towards the Fire Fighters and officer. Off. DiMatteo stated, while on scene, that the vehicle that struck them accelerated prior to striking them.
