PETITION FOR WRIT OF MANDAMUS AND INJUNCTIVE RELIEF

Comes the petitioners Adam Lansky and Kaitlin Lott and for their petition states as follows:

- 1. The petitioners Adam Lansky and Kaitlin Lott are citizens and qualified electors residing in the City of Little Rock, Arkansas.
- 2. The respondent Susan Langley is the City Clerk for the City of Little Rock and is charged with the responsibility of accepting and certifying petitions of candidates for the City of Little Rock Municipal Offices as well as verifying petitions and signatures on petitions.
- 3. The respondents Ozell Snider, Phil Wyrick and Susan Inman are the members of the Pulaski County Board of Election Commissioners and are responsible for conducting and overseeing all elections within Pulaski County.
- 4. Ark. Code Ann. § 14-47-110 requires that 50 qualified electors sign a petition to nominate an individual to the position of city director.

- 5. Adam Lansky submitted a petition for nomination for City Director position no. 8. A copy of Mr. Lansky's petition is attached hereto as exhibit 1. Mr. Lansky's petition contains the signatures of 51 qualified electors in the City of Little Rock.
- 6. Kaitlin Lott submitted a petition for nomination for City Director position no. 10. A copy of Ms. Lott's petition is attached hereto as exhibit 2. Ms. Lott's petition contains the signatures of 50 qualified electors in the City of Little Rock.
- 7. Mr. Lansky's and Ms. Lott's petitions for nomination both meet the minimum requirement set forth in Ark. Code Ann. § 14-47-110 to be certified as candidates.
- 8. The respondent Susan Langley informed Mr. Lansky's and Ms. Lott's on Monday August 20 that their petitions do not meet the requirement of having 50 qualified electors.
- 9. Mr. Lanksy and Ms. Lott checked the individuals that the City Clerk indicated were not registered voters and discovered that two of the individuals not counted by the City Clerk on Mr. Lansky's petition were in fact registered voters and three of the individuals not counted by the City Clerk on Ms. Lott's petition were registered voters. In addition there was one individual on Mr. Lansky's petition that the City Clerk simply failed to count and one individual on Ms. Lotts's petition that the City Clerk failed to count. At 4:48 PM on Tuesday August 21 a letter was sent to the City

Clerk enclosing information to show that Robert Webb, Elizabeth Gould, Barbara Jones and Angela Gardner were in fact registered voters in the City of Little Rock, pointing out the failure of the City Clerk to correctly count the number of registered voters and requesting that the City Clerk certify Mr. Lansky and Ms. Lott as candidates. A coy of the letter is attached hereto as exhibit 3. On Wednesday afternoon the City Attorney informed counsel that Mr. Lanksy and Ms. Lott would not be certified as candidates because the addresses listed by Robert Webb, Elizabeth Gould, Barbara Jones and Angela Gardner on the petitions did not match the addresses on their voter reaistration records. The names and the birthdates of the individuals did match and all the individuals were registered to vote in the City of Little Rock. The City Clerk would not accept the information submitted to show that these individuals were in fact registered voters. Attached to the letter faxed to the City Clerk is print outs from the Secretary of State's Voter View web site. individual's status as registered voter was easily verified simply by placing their name and birth date into the web site. Robert Webb who signed both Mr. Lanksy's and Ms. Lott's petitions has been certified to run for the position of director in the City of Little Rock by Ms. Langley. In order to be certified to run for the position of director in the City of Little Rock Mr. Webb is required to be a qualified elector. Despite the fact that Mr. Webb is a qualified elector to run for the position of director he is not being counted as a qualified elector on the petitions of Mr. Lansky or Ms. Lott. Despite the fact that Ms. Gould, Ms. Jones and Ms. Gardner are registered voters in the City of Little Rock they are not being counted as qualified electors.

- 10. Attached hereto as exhibit 4 are print outs from the Voter Verification system of the Pulaski County Clerk which indicates that Robert Webb, Elizabeth Gould, Barbara Jones and Angela Gardner are in fact registered voters. This is in addition the information obtained from the Secretary of State's Voter View system.
- 11. Upon information and belief other candidates have been given the opportunity to provide addition information to the City Clerk in order to verify that the individuals who signed their petition are registered voters. It would be a violation of the petitioners' constitutional rights to be treated differently than any other potential candidate.
- 12. The drawing for positions on the ballot is to be held on Friday August 24, 2012 and the petitioners request that the Pulaski County Board of Election be enjoined from drawing for ballot positions and taking any further action which may or will affect the rights of the petitioners to be considered as candidates for the offices they seek until such time as this petition is heard.
- 13. Pursuant to Rule 65 of the Arkansas Rules of Civil Procedure the petitioners request that the Court enter a preliminary injunction or

temporary restraining order preventing the City Clerk or the Pulaski County Election Commission from taking any action which will or could affect the petitioners' rights to be candidates for the position of Little Rock City Director. Due to the statutory deadlines regarding elections if the Court does not enter a preliminary injunction or temporary restraining order the petitioners could suffer irreparable harm.

WHEREFORE, the petitioners respectfully request that Susan Langley acting in her official capacity as City Clerk be compelled to certify Adam Lansky as a candidate for City Director position no. 8., that she be compelled to certify Kaitlin Lott as a candidate for City Director position no. 10 and that The Pulaski County Election Commission be enjoined for drawing for ballot positions or taking any other actions which may or will affect the rights of the petitioners to be candidates for office until such time as the petitioners are certified as candidates, that the Court enter a preliminary injunction or temporary restraining order and for all other just and proper relief to which they may be entitled.
