Pursuant to Rule 7.1 of the Arkansas Rules of Criminal Procedure, the undersigned Affiant (s) being duly sworn, deposes and says that he has reason to believe that the above named person has committed the offense of violating Arkansas code:

### **5-10-101. Capital murder. (3 counts)**

(a) A person commits capital murder if:

(1) Acting alone or with one (1) or more other persons:

(A) The person commits or attempts to commit:

(ix) Aggravated residential burglary, 5-39-204;

(B) In the course of and in furtherance of the felony or in immediate flight from the felony, the person or an accomplice causes the death of a person under circumstances manifesting extreme indifference to the value of human life;

(9)(A) Under circumstances manifesting extreme indifference to the value of human life, the person knowingly causes the death of a person fourteen (14) years of age or younger at the time the murder was committed if the defendant was eighteen (18) years of age or older at the time the murder was committed.

a Class Y Felony Violation, in violation of Ark. Stats. Ann.

on or about the 6th day of December, 2012, in Clark County, Arkansas, against the peace and dignity of the State of Arkansas.

### FACT CONSTITUTING REASONABLE CAUSE

On December 6<sup>th</sup>, 2012, officers of the Arkadelphia Police Department were dispatched to a residence located at 1032 South 11<sup>th</sup> Street in Arkadelphia concerning a 911 call received by Arkadelphia Police Dispatch. The caller stated that she had discovered her daughter (6 years of age) dead. While on the phone with the police dispatcher, the caller discovered her husband dead in a separate room of the residence. Officer Jason Jackson of the Arkadelphia Police Department arrived at the residence to find Mrs. Anna Galbraith standing in front of the residence. She reported to Officer Jackson that one

daughter and her husband were dead and another daughter was missing. Officer Jackson was soon joined by Sheriff Watson. Both Officers entered the residence and found an infant child in a crib in the rear of the house. They also discovered the body of a second dead child (4 years of age) under a bed in the same room as the first deceased child. After securing the residence, Sheriff Watson contacted Special Agent Scott Clark of the Arkansas State Police for assistance. SA Clark responded to the scene. The crime scene was processed by Clark and other assigned Officers. Within the crime scene several items of evidence were recovered including a patent palm print that was deposited in a substance consistent with blood. That particular print was recovered from the interior of the children's bedroom door.

On December 7<sup>th</sup>, 2012, the bodies of the deceased were examined by the Arkansas State Medical Examiner's office and all three deaths were ruled to be the result of homicide. The Pathologist of record stated that substantial injuries were suffered by the victims and would have resulted in extensive bleeding.

On December 8<sup>th</sup>, 2012, a report was made to Sheriff Jason Watson by a police officer concerning information on suspect Riakos Lizana. A set of known finger and palm prints from Lizana were secured and were compared to the patent print from the door of the children's room. The patent print was positively identified by a latent print examiner from the Arkansas State Crime Lab as belonging to Riakos Lizana.
