The undersigned affiant(s) being duly sworn, deposes and says That he has reason to believe that the above-named person has Committed the offense of: Theft by receiving Class D

Felony. In violation: of Arkansas stats Annotated.

Section(s) 5-36-106, on or about the 13 day of

January 2014. By unlawfully (State Statutory language)

5-36-106. Theft by receiving.

- (a) A person commits the offense of theft by receiving if he or she receives, retains, or disposes of stolen property of another person:
 - (1) Knowing that the property was stolen; or
 - (2) Having good reason to believe the property was stolen.
- (b) As used in this section, receiving means acquiring possession, control, or title or lending on the security of the property.

In Garland County, Arkansas, against the peace and dignity of the State of Arkansas.

On December 11, 2013 Kimberly Gornichec who resides at 115 Big Duke Trail in Hot Springs, Arkansas filed a theft report with the Garland County Sheriff's Department, on behalf of Charles Blackburn, who is the owner of the property reported stolen.

Gornichec reported that between December 9th, and 10th, 2013 an unknown person(s) stole a 2004 model Hot Springs Trailer that bared Arkansas License AA550962. The trailer was an enclosed type trailer which was white in color.

The value of the trailer was listed at \$1500.00

On January 13, 2014 investigators with the Garland County sheriff's department and Arkansas State Police received information that another trailer had been located at the residence of Andrea Davis. That trailer had also been reported stolen and the owner found items that were in the trailer for sale on craigslist. The ad on craigslist provided a telephone number which returned to the address of 251 Ledgerwood.

The owner of the trailer drove to the residence and located his trailer in the parking area of the driveway. He then contacted the investigator assigned to his case, Darrel Bridgewater.

Inv. Bridgewater and S.A. Russ Rhodes (AR. State Police) drove to the residence and located (2) cargo type trailers in the parking area of the residence. The trailer that led them to the residence was confirmed to be stolen (Victim-Mike Molloy). That trailer bared AR. License plate AA550962 (That license plate returned to and belonged to Charles Blackburn).

Upon their arrival, Inv. Bridgewater and S.A. Rhodes observed a female fully clothed walking through the residence. Inv. Bridgewater stated that he had knocked on the residence door numerous times but did not get a response.

Approximately 15 minutes later, a female known to them as Andrea (Andi) Davis opened the door. Davis stated that she was "sorry" and that she did not know they were there.

When questioned about the trailers, Davis stated that a person named Shawn Ross had dropped them off about 4 weeks prior. Davis then stated that Ross had given her a key and that he kept a key for the trailer belonging to Malloy. Davis later emerged and stated that she had to pick her children up and would

return shortly. She then provided S.A. Rhodes with a key in which she stated went to the trailer (Molloy). Davis left and never returned.

This affiant arrived on scene along with other investigators and agents with the 18th Judicial Drug Task force after a search warrant was obtained for the residence.

Once there, this affiant was able to locate a VIN to the second trailer. That trailer was confirmed to be the trailer reported stolen belonging to Charles Blackburn. However, the trailer license plate had been removed and placed on Molloy's trailer which Davis provided a key for which places her in possession of both trailers.

During the execution of the search warrant, there were several items located inside the residence that had been removed from the trailer that belonged to Molloy. One of the items was a SHOP VAC, which was posted on Craigslist for sale and was identified by Molloy as his. The SHOP VAC gave the telephone number which returned to Davis's residence.

This affiant spoke to all investigators to see if Davis had contacted this office to question the status of the trailers if in fact "Shawn Ross" had "Dropped" them off. All investigators stated that they have not spoken to Davis nor received any phone calls from her attempting to determine if they were stolen or not.

On January 14, 2014 Inv. Bridgewater spoke to Davis's attorney. Davis's attorney provided Inv. Bridgewater with the location of a trailer that according to Davis was in the possession of Shawn Ross and that she believed it to be stolen.

That trailer was located and confirmed to be stolen during the weekend of January 11, 2014 in Garland County.

This affiant is requesting a warrant of arrest for Andrea Lea Davis for one (1) count of Theft by receiving on behalf of the victim, Charles Blackburn.


