Facts Constituting Probable Cause

On January 2, 2014, Mark Fraiser reported a burglary at his home, located at Chincapin Street. Fraiser stated he left his home on December 27, 2013 and returned on January 2, 2014. Fraiser explained that he smokes "Marlboro" brand cigarettes and stated the suspect had to be the only one who could have left the "Newport" cigarette, due to the fact that no one has been in his home recently that smokes "Newport" cigarettes and the "Newport" cigarette was not there when he left his home on December 27, 2013.

On March 3, 2014, I received a return from the crime lab, which indicated that the DNA from the "Newport" cigarette, "hit" or matched against DNA from Andrea "Andi" Davis (DOB:).
