FELONY INFORMATION

Cody Hiland, Special Prosecuting Attorney, in the name and by the authority, and on behalf of the State of Arkansas charges Michael Frost with the crime(s) of COMMUNICATION FACILITY, ILLEGAL USE OF (OFFENSE DATE-JULY 30, 2006 AND THEREAFTER) and Delivery of Sched I/II Cont. Subs., < 2g (Not Methamphetamine/Cocaine) as follows:

COUNT 1: COMMUNICATION FACILITY, ILLEGAL USE OF (OFFENSE DATE-JULY 30, 2006 AND THEREAFTER) ARK. CODE ANN. § 5-64-404. The said defendant in SALINE COUNTY, did unlawfully and feloniously on or about June 5, 2013, knowingly use a communication device in committing or in causing or facilitating the commission of an act that constituted a felony under this chapter,

Thereby committing the offense of COMMUNICATION FACILITY, ILLEGAL USE OF (OFFENSE DATE-JULY 30, 2006 AND THEREAFTER), said offense being a CLASS C FELONY against the peace and dignity of the State of Arkansas.

COUNT 2: Delivery of Sched I/II Cont. Subs., < 2g (Not Methamphetamine/Cocaine) ARK. CODE ANN. § 5-64-426(c)(1). The said defendant in SALINE COUNTY, did unlawfully and feloniously on or about June 5, 2013, deliver less than 2 grams of Oxycodone, a Schedule II controlled substance,

Thereby committing the offense of Delivery of Sched I/II Cont. Subs., < 2g (Not Methamphetamine/Cocaine), said offense being a CLASS C FELONY against the peace and dignity of the State of Arkansas.

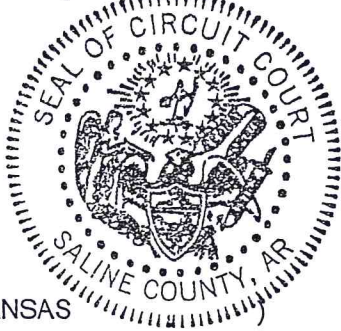

Pursuant to Rule 7.1 of the Arkansas Rules of Criminal Procedure, the undersigned Affiant (s) being duly sworn, deposes and says that he had reason to believe that the above named person has committed the offense of violating Arkansas Code:

FACTS CONSTITUTING REASONABLE CAUSE

During the course of this investigation a CHS (Confidential Human Source) was developed. This source gave information that in the past they had received various types of Schedule Narcotics from Michael Frost (former CID Lieutenant for the Saline County Sheriff's Office). Permission was granted by CHS to download text messages from their telephone. The text messages that are to be used in this matter pertain to entries numbered #46 and #47 that are documented on the spreadsheet marked Evidence item E-11. Entry #46 states the number was 501-831-9777 and the name is Mike Frost. The time and date of the text is 06/04/13 at 08:04 a.m. The status of the message is shown as being sent. The folder shown for this is outgoing. The message is (Ok, sounds good. Can i have cpl pp, when I come. And do u have foxe)? This text is a text message from CHS to Mike Frost. Entry #47 states the number is 501-831-9777 and the name is Mike Frost. The time and date of the text is 06/04/13 at 08:06 a.m. The status of the message is shown as read. The folder shown for this is incoming. The message is (Yes and I wil:). Have u got a car to drive)? The text is a text message from Mike Frost to the CHS. On June 5, 2013 this agent along with Will Lemaster of the FBI taskforce provided the CHS a ride to their home. After arriving at the CHS home at approximately 12:50 p.m. CHS received a text message from Mike Frost, which Frost told CHS he was on his way to CHS residence to supply him/her with the requested narcotics. This agent along with Lemaster parked at a neighbor's house near the CHS residence still in view of the CHS residence. At approximately 12:55 p.m. then Lt. Mike Frost arrived at the CHS residence in his issued Saline County Sheriff Office vehicle (Blue Dodge Durango). Frost spent approximately five minutes with the CHS on her front porch then left. This agent along with Lemaster made contact again with CHS. CHS provided us a small plastic wrapping material which contained two white tablets. The CHS stated that Frost had supplied the pills moment ago. The pills were sent to the Arkansas State Crime Lab for analysis. The results of that analysis stated the two white tablets were identified as Oxycodone, acetaminophen (CII). During an interview with the CHS they stated they had been getting pills from Mike Frost around 2012 and 2013. In the statement CHS said Frost knew if CHS got pills from him Frost in turn would get sex from the CHS.

I swear that the allegations contained herein are the truth, the whole truth, and nothing but the truth.
