On 06/15/2015, I was dispatched to 4120 West Maddox Road, Jacksonville, Arkansas, to an assist an agency call. Pulaski County Communications advised that Jacksonville Police Department, requested that I go to the residence concerning a crime that occurred in their city. I arrived in the area and observed a red mustang parked at the end of a long driveway with an electric fence across the drive. I did not observed a code box outside and it appeared that the gate code box was inside the residence.

Deputy Benson and Lt. Ameling arrived at the scene to assist in securing the residence. Lt. Ameling advised that there had been an incident at the Jacksonville Air Force Base and that the suspect vehicle's license plate returned to this address. Because of the unknown circumstances Lt. Ameling made a decision to stand by and await the arrival of the FBI.

Deputy Benson was able to see the license of the mustang which returned to Misty Chambers, Lt. Ameling observed a mail box clearly marked 4120 across from the residence. Mail belonging to Misty Chambers was located inside the mail box.

- Lt. Ameling talked to neighbors on both sides of the residence and stated that Misty Chambers lived at the residence with her husband. Both parties were said to be unemployed and that if the red mustang was parked at the residence Misty was usually inside the residence.
- Lt. Ameling was able to obtain several telephone number from previous reports at the residence and attempted several calls in an effort to contact someone inside the residence. Lt. Ameling left messages explaining who he was and that he need to speak to Chambers. Lt. Ameling also made several attempts over his vehicle's P.A. system to contact Ms. Chambers. See Lt.
