STATUTORY SENTENCES

Conspiracy to possess with intent to distribute and to distribute more than 50 grams of actual methamphetamine is punishable by not less than 10 years, not more than life, incarceration in the Bureau of Prisons with a possible fine of up to \$10,000,000, and not less than 5 years supervised release.

Conspiracy to possess with intent to distribute and to distribute more than 50 grams but less than 500 grams of a mixture or substance containing a detectable amount of methamphetamine is punishable by not less than 5 years, not more than 40 years incarceration in the Bureau of Prisons with a possible fine of up to \$5,000,000, and not less than 4 years supervised release.

Conspiracy to possess with intent to distribute and to distribute a mixture or substance containing a detectable amount of methamphetamine is punishable by not more than 20 years incarceration in the Bureau of Prisons with a possible fine of up to \$1,000,000, and not less than 3 years supervised release.

Distribution of more than 50 grams of actual methamphetamine is punishable by not less than 10 years, not more than life, incarceration in the Bureau of Prisons with a possible fine of up to \$10,000,000, and not less than 5 years supervised release.

Distribution of more than 5 grams, but less than 40 grams, of actual methamphetamine is punishable by not less than 5 years, not more than 40 years incarceration in the Bureau of Prisons with a possible fine of up to \$5,000,000, and not less than 4 years supervised release.

Distribution of more than 28 grams, but less than 280 grams, of crack cocaine is punishable by not less than 5 years, not more than 40 years incarceration in the Bureau of Prisons with a possible fine of up to \$5,000,000, and not less than 4 years supervised release.

Distribution of less than 28 grams of crack cocaine is punishable by not more than 20 years incarceration in the Bureau of Prisons with a possible fine of up to \$1,000,000, and not less than 3 years supervised release.

Possession of a firearm by a felon is punishable by not more than 20 years incarceration in the Bureau of Prisons with a possible fine of up to \$250,000, and not more than 3 years supervised release.

Use of a firearm during and in relation to a drug-trafficking crime is punishable by not less than 5 years, not more than life incarceration in the Bureau of Prisons, consecutive to any other charge, with a possible fine of up to \$250,000, and not more than 3 years supervised release.

Use of a communication facility to facilitate a drug trafficking crime is punishable by not more than 4 years incarceration in the Bureau of Prisons with a possible fine of up to \$250,000, and not more than 1 year supervised release.
