## **INCLEMENT WEATHER POLICY**

In the event of inclement weather on any day on which voting is held, the Garland County Election Commission will open at least one location. The designated location will be the Garland County Election Building, 649 A Ouachita Avenue, Hot Springs, AR 71901, during legal voting hours.

Other locations may open, depending upon conditions.

The Garland County Election Commission will notify County Officials and media outlets whenever the Inclement Weather Policy is in force.
