FACTUAL BASIS

On July 21, 2015, Justin Staton along with Hunter Drexler, and Connor Atchley, planned to rob and kill Robert and Patricia Cogdell at gunpoint in order to get money to help them run away from Arkansas. Hunter Drexler brought the guns that were used as the weapons that killed Robert and Patricia Cogdell. Justin and Hunter were armed with guns in the killing of Robert and Patricia Cogdell. Over \$3000 cash and various credit cards were taken from Robert Cogdell's body after he was deceased. After the Cogdells were shot, Hunter Drexler wrapped the body of Robert Cogdell in a rug and Justin used a front loader to move his body to the tree line on the property. The front loader was also used to move Patricia Cogdell's body to the tree line. Both bodies were dumped in the woods. After the bodies were left in the woods, Justin and Hunter Drexler drove in Hunter's Tahoe to the Walmart on Dave Ward Drive. While inside the Walmart, they went to the electronics department where Hunter Drexler paid over \$700 in cash for a cell phone and prepaid minutes. The money he used to pay for these items came from money Hunter had taken from Robert Cogdell by cutting the pockets of Robert Cogdell. Hunter Drexler also had possession of various credit cards belonging to Robert Cogdell in the console of his Tahoe. After leaving Walmart, Justin, Hunter Drexler, along with Connor Atchley and Anastasia Roberts, who were involved in the homicides, went to Justin's grandfather's house in Conway. Connor and Anastasia had expected to receive money and a vehicle. Justin was arrested the next day, and had Robert Cogdell's blood on his shirt and shoes.

ORDER OF COMMITMENT

Comes now before the Court the above matter, and the Defendant having entered a proper plea of guilty, and the Court, based upon the file, plea, and other matters and proof this Court doth find the following:

1. That the above-named defendant pled guilty on May 10, 2016, to the charges of 2 counts of Murder in the 1st degree, Y felonies; 2 counts of Aggravated Robbery, Y felonies; 2 counts of Theft of Property Obtained by Force, B felonies; and, 2 counts of Abuse of Corpse, C felonies.
2. That the Court imposed a sentence of 35 years in the Arkansas Department of Correction on each count of Murder in the 1st degree and on each count of Aggravated Robbery; a sentence of 20 years on each count of Theft of Property Obtained by Force; and, a sentence of 10 years on each count of Abuse of a Corpse, each count to run concurrent with the other.
3. That the Defendant was 14 years old at the time of the offense, and 15 years old on the day of sentencing. Defendant's date of birth is 11-05-2000.
4. That pursuant to Arkansas Code Annotated §9-27-510(b), the Defendant shall be committed to the custody of the Division of Youth Services until his 16th birthday. Upon his 16th birthday, the Defendant shall be transferred to the Arkansas Department of Correction.

WHEREFORE, it is ordered that the Division of Youth Services take custody of the Defendant until his 16th birthday.


