Facts to establish probable cause that a crime was committed:

On July 14, 2017, Officers were called to 548 W. Dickson in reference to what the caller assumed was an intoxicated person. Upon arrival, officers found a male lying on the ground. He had severe injuries to his head and face and was partially conscious. The male was transported to the

Washington Regional Medical Center, where he was treated for multiple fractures in his face and skull. The male was placed on a ventilator at the hospital and has since undergone multiple surgeries. During the investigation, investigators found the male had been beaten about his face and head. Weapons used during the battery were left at the scene. The victim's wallet, cell phone and money were stolen.

During the investigation it was found the robbery had been documented and transmitted via cell phone. The documentation included a digital image showing a black male standing over the victim. The injured victim is lying with his back on the ground. Documentation of that transmission was later provided to investigators by an anonymous source. Detailed information was provided about the incident which was not released or should not be known to anyone but investigators and the suspects. Information provided by the source was later corroborated through investigation and additional witness statements. The anonymous source identified the suspects as Lorenzo Green and Kayla Rolle.

Green and Rolle were found in Springdale and placed under arrest for attempted murder and aggravated robbery. They were both transported to the Fayetteville Police Department where they were both read their Miranda rights and spoke with detectives. During the interviews it was disclosed Green had been in an altercation with the victim. He admitted to punching the victim with his fists, but denied striking the victim with any weapons. Green admitted he was the person in the digital image with the victim after the victim was injured.

It was also disclosed the shoes Green was wearing during the incident had been thrown away in a dumpster. Statements made by Rolle led investigators to the dumpster where the shoes were located by investigators. The shoes appear to be the same as those worn by the suspect in the digital image provided to investigators.

Rolle admitted to detectives Green had taken her to the location where the incident had occurred. She observed the male unconscious on the ground and was the person who documented it with her cell phone. She stated after the fact she and Green left the area. She drove him from the scene. Rolle was unsure if the victim was dead or alive when they left the scene.

Rolle was transported to the Washington County Detention Center where she was charged with accomplice to attempted first degree murder, accomplice to aggravated robbery and tampering with physical evidence.
