## AFFIDAVIT FOR WARRANT OF ARREST

Pursuant to rule 7.1 of the Arkansas Rules of Criminal Procedure, the undersigned affiant(s), being duly sworn, deposes and says that he/she has reason to believe that the above named person has committed the offense of violating Arkansas Code(s): 5-3-401 Conspiracy to Commit Capital Murder, 5-3-301 Solicitation to Commit Capital Murder

On or about: 10-16-2018 in Drew County, Arkansas, against the peace and dignity of the State of Arkansas

FACTS CONSTITUTING REASONABLE CAUSE: On 10-16-2018 a confidential informant reported to the Monticello Police Department that Stephanie Rogers approached her about killing her husband's ex – wife, Debbie Rogers. The confidential informant stated that Stephanie Rogers told her that she also attempted to loosen the lug nuts on her husband's, Joe Rogers, vehicle but when she did he left their residence in another vehicle. The confidential informant stated that Stephanie Rogers advised her that she needed Debbie Rogers killed prior to her husband (Joe Rogers) due to her being the recipitant of life insurance policies and also obtaining control of a business that Joe Rogers owns. The confidential informant stated that after Debbie Rogers was killed that she (Stephanie Rogers) would take care of Joe and then received the life insurance and accident insurance polices along with the business owned by Joe Rogers.

On 10-17-2018 the confidential informant contacted Stephanie Rogers with S/A Bo Norris and I (Det. Kenny Cox) present with the conversation being recorded. The confidential informant advised Stephanie Rogers that she had an uncle that could "take out" Debbie Rogers. Stephanie Rogers asked the confidential informant if he could be trusted and advised her that she would meet her after she got off work to discuss it in more detail. During the phone conversation Stephanie Rogers also noted that she had talked to someone else about doing it this weekend.

At approximately 4:44 p.m. on 10-17-2018 Stephanie Rogers arrived at the confidential informant's place of employment. The conversation between Stephanie Rogers and the confidential informant was video recorded and voice recorded. During the conversation

Stephanie Hill asked the confidential informant if her uncle could be trusted to kill Debbie Rogers. Rogers also stated that she would want it to look like a robbery at her residence. Stephanie stated that she wanted Joe Rogers' death to "look like an accident, end of story", and "that she can handle that one". Stephanie Rogers also stated that "all she had to do was the truck front tires when he goes to his next doctors appointment". Stephanie Rogers continued to question the confidential informant about her uncle and if he knew who she was and how would he do it. Stephanie continued to state that she thinks the best way to do it is to make it look like a robbery at her (Debbie's) house. Stephanie continued on to say that Debbie Rogers goes to church tonight (10-17-2018) and insinuated it be done tonight. Stephanie also questioned the confidential informant about what her uncle would want in return if he "just did Debbie". Stephanie also strongly expressed that she needed to know when it was going to be done and that she "was ready for this lady to be gone". Stephanie Rogers then began describing Debbie Roger's residence, directions to the residence, number of doors at the residence and what type of vehicle she drives.

On 10-18-2018 S/A Bo Norris and I met with the confidential informant again. The confidential informant contacted Stephanie Rogers by text message and informed her that her uncle wanted to discuss details with her. Stephanie Rogers then called the confidential informant and stated that she did not want to meet with him face to face and was concerned about how much it was going to cost. Stephanie then stated that she "would just go the other route". This conversation was recorded and in the presence of S/A Bo Norris and I (Det. Kenny Cox).

This affidavit is intended for purposes of probable cause only. Furthermore it is not intended to be an exhausted summary of the complete investigation and evidence obtained.

I swear that the allegations contained herein are the truth, the whole truth and nothing but the truth.
