Pursuant to Rule 7.1 of the Arkansas Rules of Criminal Procedure, the undersigned affiant being duly sworn, deposes and says that he has reason to believe that the above-named person has committed the offense of violating: Ark. Code Ann. §5-10-101 Capital Murder on or about March 15, 2019 committed by:

- (a) A person commits capital murder if:
- (1) Acting alone or with one (1) or more other persons: (A) The person commits or attempts to commit:
- (vi) Aggravated Robbery, § 5-12-103
- (B) In the course of and in furtherance of the felony or in immediate flight from the felony, the person or an accomplice causes the death of a person under circumstances manifesting extreme indifference to the value of human life.

## FACTS CONSTITUTING REASONABLE CAUSE

I, Detective Michael Gibbons, hereby swear and affirm submit the following as my affidavit; I submit this affidavit in support of an arrest warrant for DREQUAN LAMONT ROBINSON. My belief that probable cause exists to arrest DREQUAN LAMONT ROBINSON for the commission of one or more criminal offenses is based on the following facts that I have learned from my own personal investigation of this matter, including interviews of witnesses, as well as from information supplied by other law enforcement officials. Since this Affidavit is for the limited purpose of establishing probable cause to support the arrest warrant, it contains only a summary of relevant facts. I have not included each and every fact known to me concerning the entities, individuals, and events described in this Affidavit:

I swear that the allegations contained herein are the truth, the whole truth and nothing but the truth.

On March 15, 2019, at approximately 2338 hours, North Little Rock Police responded to a shooting that occurred at the Valero Gas Station, 601 West Broadway. Upon arrival to the business, Officers located a white male, identified as Shawn McKeough, laying on the floor inside the store. He was bleeding

from the mouth and suffered from what appeared to be a single gunshot wound. McKeough was pronounced dead at the scene.

An investigation into the shooting revealed that two individuals armed with firearms, entered the Valero Gas Station, pointed guns at the customers in the store and demanded they lay on the ground. The two suspects waved their guns around at the customers and the store cashier as they demanded the cashier empty the cash register. During the robbery, Shawn McKeough attempted to intervene by tackling suspect # 1. Suspect # 2, then fired at least one shot, striking McKeough in the face. The two suspects fled the store.

During an interview with one of the Valero clerks, he advised that when the suspects entered the store, they were waving their guns around and ordered everyone to the ground. The suspects approached the counter and stated, "you think this is a fucking game, you think I am playing, open the drawer right now" The cashier told Detectives that while he was trying to open the drawer, he heard a click and then a gunshot. He saw the victim on the ground and then called 911.

There were at least eight customers and two employees in the business at the time. Suspect # 1 was wearing a dark colored sweatshirt, dark pants, white tennis shoes, a panda bear hat with a red cloth around his neck and face, and possessed a chrome firearm. Suspect # 2 was wearing a black Nike hoodie, black with white striped pants and white tennis shoes. The hood was pulled over his head, however, his face was partially exposed. He possessed a dark colored firearm with what appeared to be an extended magazine. The entire incident was captured on video.

On March 16, 2019, Detectives released segments of the video on social media in an attempt to obtain the identities of the suspects. Detectives received phone calls from five different individuals who all identified the suspect in the black hoodie as Drequan Robinson of North Little Rock. Each caller requested to remain anonymous, however, each person provided unique identifiers about Robinson and information regarding their long term relationships with him.

On March 17, 2019, witness # 1, positively identified Drequan Lamont Robinson from a photograph line up, as the person he recognizes in the black hoodie during the robbery. Witness # 1 has known Robinson for at least 7 years, attended school with him and identified where Robinson lives.
