#### **SUMMARY**

On Friday, February 22, 2019, at approximately 1104 hours, Detective (Ocean 52) was monitoring the license plate reader which is a system that tracks and detects stolen cars and license plates. Detective was alerted to a stolen vehicle being detected near 12<sup>th</sup> Street and Peyton Street. Detective saw that the vehicle was traveling westbound. Detective was able to verify in ACIC that the detected vehicle, a black 2018 Nissan Altima bearing Arkansas license plate 513WXF, was reported stolen out of the Bryant Police Department (Bryant Police Department Incident#19-000313 from January 4, 2019).

Detective began monitoring City of Little Rock traffic cameras mounted along 12<sup>th</sup> Street to track the stolen vehicle. Detective observed the stolen vehicle continuing westbound near 12<sup>th</sup> Street and Fair Park Boulevard (approximately 1105 hours). The cameras showed the vehicle continue to the area of 12<sup>th</sup> Street and University Avenue (approximately 1106 hours). Detective requested if there was a patrol unit in the area of 12<sup>th</sup> Street and University Avenue over Main Channel. Officer Zebulun Tyler, who was working 1X60 and driving 18C441 (which was equipped with a functioning body microphone and MVR), responded on main channel and Detective told him to go to Northwest PCOM channel.

Officer Charles Starks, who was working 1Y61 and driving 18C441 (which was equipped with a functioning body microphone and MVR), switched over to Northwest PCOM and advised

Detective continued to monitor the camera system advising Officer Starks the vehicle was still westbound on 12<sup>th</sup> Street through University Avenue. Detective advised Officer Starks the stolen vehicle had approached 12<sup>th</sup> Street and Rodney Parham Road where it made a left turn into a parking lot near 7305 Kanis Road (approximately 1108 hours). The stolen vehicle was observed backing into a parking space next to what appeared to be a white GMC Yukon (approximately 1109 hours). Detective relayed the information to Officer Starks on Northwest PCOM Channel and continued monitoring the camera until he observed a marked patrol unit arrive at the parking lot and stop near the stolen vehicle. Detective eft his desk to approach his Sergeant's office when he heard "shots fired" (shots fired on Main Channel radio traffic at 11:10:20 hours). When he returned to monitor the camera he could only view a portion of the patrol vehicle and the stolen vehicle was no longer in view. The camera mounted on the telephone pole to the south of the intersection was blocked when it pointed south to the parking lot of 7305 Kanis Road.

At approximately 1109 hours, Officer Starks made contact with the suspect vehicle. Officer Starks' body microphone, MVR, and emergency blue lights were engaged. The MVR and body microphone recorded Officer Starks approach the driver's side of the suspect vehicle with his service weapon drawn. Officer Starks ordered the driver to show his hands, roll down the window, and exit the vehicle. The driver did not comply with Officer Starks' commands.

At approximately 1110 hours, Officer Starks continued to give the driver commands as he moved from the driver's door side of the vehicle toward the front driver's side area of the vehicle. The Nissan Altima was seen moving forward at a slow speed. At that point, Officer Starks fired approximately three to four rounds on the driver's front side before and moving to the front of the vehicle and ending on the driver's side hood of the Nissan Altima. Officer Starks fired an additional ten to eleven rounds as the suspect vehicle continued to roll forward. All fifteen rounds were fired within approximately seven seconds. MVR showed that there were approximately forty-six seconds from the time Officer Starks gave commands to the suspect driver to when the first shots were fired.

Officer Michael Simpson, who was working Z71 and driving 15C323 (equipped with a functioning body microphone and MVR) responded to the scene to assist Officer Starks. Upon

entering the parking lot at approximately 1110 hours, Officer Simpson is seen striking the passenger side of the suspect vehicle with the front bumper of his patrol unit. After the impact Officer Starks came off the hood to the driver's side of the suspect vehicle. The Nissan briefly stopped before it began to roll slowly to a fence row at the south end of 7305 Kanis where it came to rest.

At approximately 1111 hours, the passenger identified as Desaray Clarke (WF 03/29/1998) exited through the front passenger window of the Nissan Altima. Ms. Clarke was handcuffed by Officer Starks as Officer Simpson continued hold the driver at gunpoint. Ms. Clarke advised Officer Starks that there was a gun in the suspect vehicle and Officer Starks conveyed that information to Officer Simpson. Officer Starks placed her in Officer Simpson's patrol unit.

At approximately 1112 hours, officers began attempting to get the driver, later identified as Bradley Blackshire (BM 10/20/1988), out of the vehicle. The front passenger door could not be opened due to the collision with Officer Simpson's vehicle and trees that were blocking the driver's door from opening.

At approximately 1113 hours, officers were able to remove Mr. Blackshire from the vehicle through the rear passenger seat and door and begin first aid. At approximately 1115 hours, MEMS was notified the scene was secure to enter. At approximately 1120 hours, an additional MEMS unit was requested to transport Officer Starks to the hospital for his injuries to his right leg.

At approximately 1130 hours, Homicide Detectives arrived on scene after being advised of the officer involved shooting. The area was searched for security cameras in the area of the incident. Witnesses were transported to Major Crimes to be interviewed by detectives who were gathering initial information from surveying the area and viewing the officer's MVR which had been downloaded. A black Beretta semi-automatic handgun was observed in plain-view on the passenger side front floorboard of the Nissan Altima. Fifteen shell casings were observed in the area northeast of where the Nissan came to rest and where Officer Simpson's patrol vehicle was parked. Approximately thirteen bullet strikes and holes were observed in front windshield and on carriage hood of the Nissan.

At approximately 1210 hours, detectives made contact with Officer Starks at Baptist Hospital. Officer Starks received treatment and medication for his injuries. Officer Starks' issued

uniform was taken and transferred to the Crime Scene Search Unit. Photographs were taken of Officer Starks at the hospital. Due to Officer Starks' injuries and prescribed pain medications, no statement was obtained from Officer Starks on Friday, February 22, 2019.

At approximately 1316 hours, Billy Zulpo, an off duty Conway Police Officer, provided a statement at Major Crimes. Mr. Zulpo stated he was southbound on Rodney Parham in his personally owned vehicle (Blue Ford Edge SUV) approaching the intersection of Rodney Parham and 12th Street. Mr. Zulpo said he observed a police vehicle with the lights on at the parking lot directly south of the location. Mr. Zulpo said an officer was at the front of a vehicle holding it at gunpoint. Mr. Zulpo advised another police unit was running code and went around his vehicle as he approached the stop light. Mr. Zulpo stated when he got up to the light he observed the vehicle moving slowly forward and the officer was up on the hood. Mr. Zulpo said he heard shots being fired and assumed the officer was shooting. Mr. Zulpo stated he continued across the intersection and drove to the right of the building in an attempt to enter the parking lot where the incident was occurring. Mr. Zulpo advised a fence blocked him from continuing around the buildings so he proceeded to the parking lot by driving around the front. Mr. Zulpo stated the officer who had been on the hood was handcuffing a female who was on the ground while another officer was holding cover with his weapon drawn. Mr. Zulpo approximated the time he continued through the intersection to the time he arrived at the parking lot where the incident occurred to be thirty seconds. Mr. Zulpo stated when he got back around to the parking lot the officer was handcuffing the female. Mr. Zulpo said the officer then moved her to a patrol vehicle. Mr. Zulpo observed the officer's leg appeared to be injured and approached the officer after identifying himself as an off duty police officer. Mr. Zulpo advised that he told the officer to stay where he was and he would stay with them. Mr. Zulpo stated he observed a black male on the ground and officers were attempting to render first aid to him prior to the ambulance arriving.

At approximately 1349 hours, Moises Solis was interviewed near the scene after he reported his 2018 Chevy Silverado was struck on the left side of the tailgate by a projectile due to the incident. A Terroristic Act report was generated (Little Rock Police Incident #2019-023119). Mr. Solis stated he was travelling on 12<sup>th</sup> Street approaching Rodney Parham. Mr. Solis advised he observed a police officer pointing a gun at occupants of a vehicle on a parking lot south of the intersection. Mr. Solis stated the vehicle was moving in an apparent attempt to get away. Mr. Solis

advised he was getting ready to turn north onto Rodney Parham when he saw a second police vehicle pulling onto the lot. Mr. Solis said his music was on so he did not hear any shots fired but thought he heard something hit his truck. Mr. Solis stated that when he got home he checked his vehicle and located an apparent bullet strike on the left side of the tailgate. CSSU processed the vehicle but due to the bullet going into the frame of the vehicle it could not be retrieved.

At approximately 1355 hours, the passenger of the Nissan Altima, Desaray Clarke was interviewed at Major Crimes. Ms. Clarke had minor scrapes and irritation apparently from small shards of glass. Ms. Clarke did not request medical attention when offered but asked to be able to remove pieces of glass from her clothing. Photographs were taken of the areas she advised were irritated and scraped. Ms. Clarke was searched by a female officer prior to giving a statement. Ms. Clarke stated she had been dating Bradley Blackshire and living at his sister's house. Ms. Clarke stated that she had went to jail and she broke up with him after she was released. Ms. Clarke stated she was homeless but had been staying at an older gentleman's house that goes by "Amos" on 28th Street. Ms. Clarke advised on Friday, February 22, 2019, she had been using a text application to communicate with Mr. Blackshire throughout the morning. Ms. Clarke stated earlier that morning Mr. Blackshire had come over in a black Nissan Altima to give her some cigarettes. Ms. Clarke said a light skinned black male that goes by "Red" was driving. Ms. Clarke entered the vehicle and they drove to a store near Fair Park where she said she bought Mr. Blackshire a bag of Hot Fries and a fruit punch drink. Ms. Clarke stated the fruit punch drink was still in the vehicle when the shooting incident occurred. Ms. Clarke stated while at the store, Mr. Blackshire pointed out a vehicle with a subject in it that goes by "Tweezy." Ms. Clarke advised "Tweezy" and Mr. Blackshire had been "into it." Ms. Clarke stated "Red" asked Mr. Blackshire if he wanted to "Go handle that." Ms. Clarke stated Mr. Blackshire told "Red" to drop her off first so she wouldn't be "caught in the middle of anything." Ms. Clarke stated Mr. Blackshire and "Red" had been smoking dope. Ms. Clarke advised Mr. Blackshire had dope and meth. Ms. Clarke said she was dropped off at the residence on 28th Street and approximately thirty minutes later Mr. Blackshire came back in the black Nissan Altima by himself to pick her up. Ms. Clarke said she thought they were heading to meet "Red" at the barbershop at 7305 Kanis Road. Ms. Clarke stated a black handled pistol she believed to be a 9mm was sticking out from under the passenger seat. Ms. Clarke stated she knew it was Mr. Blackshire's gun because he had it before she had gone to jail. Ms. Clarke said she believed there were more guns in the car because she knew Mr. Blackshire to have more firearms.

Ms. Clarke stated she knew Mr. Blackshire to have the 9mm she had seen on the floorboard as well as another handgun, a small .380 revolver, and an "old school chopper" (assault rifle). Ms. Clarke said that the 9mm handgun was the only gun she saw in the vehicle when she entered. She also advised that she believed there was dope in the car because Mr. Blackshire had a big bag of drugs earlier.

Ms. Clarke stated on the way to the barbershop they were stopped at a red light. Ms. Clarke advised that Mr. Blackshire had pointed out a car that didn't have any stickers on the license plate and told her it was the police. Ms. Clarke stated that Mr. Blackshire had been paranoid for quite some time and had been insistent that the "the Feds" (Little Rock Incident Report 2018-123120) were following him around because of charges he is facing. Ms. Clarke stated Mr. Blackshire told her that he was facing thirty years and he was worried about a case coming up soon.

Ms. Clarke advised as they began to pull into the parking lot at the barbershop (All Pro Styles at 7305 Kanis Road) she noticed a marked police vehicle behind them with its turn signal on indicating it was also going to pull onto the parking lot. Ms. Clarke stated she asked Mr. Blackshire if the police vehicle was pulling into the parking lot and he said that it was pulling in. Ms. Clarke advised Mr. Blackshire backed into a parking space.

Ms. Clarke stated the police vehicle pulled up directly in front of the car and turned on its blue lights. When asked how Ms. Clarke knew it was a police vehicle she replied, "He turned on his blue lights and it said LRPD on the vehicle, so it was no mistaking it." Ms. Clarke advised an officer immediately exited the police vehicle with his gun drawn, giving them commands, as he moved to the driver's window. She stated during this time there wasn't anyone outside around the parking lot. She stated as soon as the officer gave commands she put her hands up and the officer stopped pointing the gun at her. The officer continued to give commands to get out of the car and Mr. Blackshire refused. Ms. Clarke stated she repeatedly told Mr. Blackshire to comply and get out of the car.

She advised Mr. Blackshire was telling the officer "I don't got to go", "you can't shoot me", and "I ain't done nothing you can't shoot me."

Ms. Clarke stated while the officer was giving Mr. Blackshire commands Mr. Blackshire had one hand on the steering wheel and was reaching in his jacket pocket with his other hand. She

described his hand in the pocket as a "digging motion" like he was looking for something. Ms. Clarke stated she believed Mr. Blackshire was looking for a small .380 revolver she knows he carries. Ms. Clarke stated she believed Mr. Blackshire was looking for the gun in order to shoot the officer. Ms. Clarke advised that Mr. Blackshire had once told her that he shot at a police officer a couple of years ago.

Ms. Clarke advised Mr. Blackshire started the vehicle, turned the wheels toward the officer, and barely hit the gas. She stated the car slowly moved forward and hit the officer on the leg. Ms. Clarke said immediately after being struck by the vehicle, the officer began firing rounds into the vehicle. She stated she was leaning against the door trying to get out but could not open the door. Ms. Clarke stated she heard Mr. Blackshire say, "I'm gone", or "That's it I'm gone." At that time another police vehicle entered the parking lot and struck her side of the vehicle. She advised after being struck the Nissan Altima continued to roll slowly on its own and she believed Mr. Blackshire was dead.

Ms. Clarke stated when the vehicle came to a stop, she asked to get out. She advised when she got out she was handcuffed by the officer the vehicle had struck. Ms. Clarke stated she told the officer there was a gun in the car. Ms. Clarke advised she saw "Red" and he asked her where Mr. Blackshire was. Ms. Clarke said she told him she thought Mr. Blackshire was dead.

At approximately 1444 hours, Little Rock Police Officer Michael Simpson was interviewed at Major Crimes. Officer Simpson was separated from other officers and placed in the Cold Case Office until he was interviewed by detectives. Officer Simpson provided a statement after being Mirandized for Aggravated Assault with his attorney present.

Officer Simpson stated that he heard an Ocean Unit request an officer in the area of 12<sup>th</sup> Street and University. Officer Simpson heard another unit key up advising their location and they changed to another channel to exchange information. Officer Simpson heard the Ocean Unit advised he had observed a stolen black Nissan westbound on 12<sup>th</sup> Street. Officer Simpson said he was westbound on Markham Street when he heard that the vehicle had continued on 12<sup>th</sup> Street approaching Kanis Road and Rodney Parham. Officer Simpson said he began heading to that area by turning south on Mississippi. Officer Simpson said he heard Officer Starks yelling on the radio. At that point, Officer Simpson said that he activated all emergency equipment and continued to Officer Starks' location.

As Officer Simpson said that when he arrived on scene he saw Officer Starks' vehicle, with the blue lights on, in the parking lot of 7305 Kanis. Officer Simpson observed Officer Starks in front of the suspect vehicle with his hand out. Officer Simpson stated he saw the front of the suspect vehicle lift up as it accelerated toward Officer Starks. Officer Simpson said that the vehicle was continually pushing against Officer Starks. Officer Simpson stated that he felt the vehicle was going to run over Officer Starks so he entered the parking lot by driving over the curb at Kanis and Rodney Parham. Officer Simpson said that he observed Officer Starks going down slowly and felt he was about to be ran over by the suspect vehicle. Officer Simpson said that he heard several gunshots as he approached the suspect vehicle in his patrol vehicle but didn't know who was shooting. Officer Simpson said that he rammed the vehicle on the passenger side with the front bpush bar of his patrol vehicle to prevent the suspect vehicle from continuing forward and running over Officer Starks. Officer Simpson said that he was trying to push the vehicle to the side away from Officer Starks. Officer Simpson said that he did not observe the occupants of the vehicle before striking it with his vehicle. After striking the vehicle, Officer Simpson said that he observed a female passenger with her hands up. Officer Simpson said his original intention was to cut the vehicle off to prevent a pursuit due to the weather and traffic conditions in the interest of public safety.

Officer Simpson advised he exited his patrol vehicle after striking the suspect vehicle. He said he approached the driver's side of the suspect vehicle as the vehicle rolled to the fence line at the south end of the lot. Officer Simpson stated Officer Starks was holding his side in pain and told him the driver had a gun still in the vehicle. Officer Simpson stated he could see the driver who had been struck by rounds and had his eyes open. Officer Simpson said that he gave the driver commands at gunpoint but the driver did not comply. Officer Simpson stated he did not see a gun at any time. The suspect vehicle came to rest and Officer Simpson advised the female passenger began asking to get out. Officer Simpson said she exited the vehicle by crawling through the broken passenger side door window.

Officer Simpson moved to the passenger side of the suspect vehicle where he continued to hold the driver at gunpoint until other officers arrived. He said that he attempted to open the passenger door but was not able to because of the damage. Officer Simpson said that the driver's side was blocked by trees. Officer Simpson said that arriving officers pulled the driver out of the

vehicle through the rear passenger seat and door to assess and provide medical aid. Officer Simpson said that he checked on the condition of Officer Starks who appeared panicked and in pain. Officer Simpson stated he was approached by Lieutenant Jackson who separated him from other officers until he was transported to Major Crimes.

Officer Simpson was not injured during the incident and did not fire any rounds as determined by an inventory of his weapon and magazines.

At approximately 1739 hours, detectives responded to the John Walker Law Firm at 1723 Broadway Street after being advised that a witness to the shooting was present. Detectives were advised the witness only wanted to speak with an African American officer. Detective Lieutenant Sidney Allen responded with Detective Oncken to accommodate the request. Randy Armstrong provided a statement. He advised he was at Discount Tires near 7305 Kanis Road when he saw police vehicles pass by with the lights and sirens engaged. Mr. Armstrong stated he heard eight to ten shots rapidly being fired a few minutes later. Mr. Armstrong stated he walked outside to find out where the shots were coming from. He explained walking to an area behind 7305 Kanis Road that is part of the tire shop and south of a fence. Mr. Armstrong stated he observed officers around a car that had rolled into the fence. He stated he saw three white officers and one or two black officers. Mr. Armstrong stated the officers had their guns out and were telling the occupants to get out of the vehicle. Mr. Armstrong advised the only occupant he saw in the vehicle was a black male in the driver's seat and the black male did not appear to be moving. Mr. Armstrong said that he did not observe anyone get out of the vehicle. Mr. Armstrong stated he did not observe anyone shooting and did not know who did the shooting. Mr. Armstrong advised he did not believe any other witnesses were outside the building because nobody at the business came outside until after hearing the shots being fired. Mr. Armstrong said that he observed bullet holes in the vehicle and damage to the passenger side.

Detectives responded to area businesses throughout the morning of February 22, 2019, in search of video that might have captured the incident. McClelland Consulting Engineers located at 7302 Kanis Road provided a copy of their security camera that recorded an area of the incident but employees of the business did not witness the actual incident. Discount Tire and Brake located at 7325 Kanis Road advised they did not have cameras that cover the area of the incident and they did not witness the incident. The Big Red Valero located at 7200 W. 12<sup>th</sup> Street advised there was

video available that covered the area but contact needed to be made with their I.T. Department for retrieval purposes. Silver Eagle located at 7325 Kanis Suite H advised they did not have any security cameras and they did not witness the incident. All Pro Styles Barbershop located at 7305 Kanis advised there were cameras available but the owner who had access to the video was out of town and could not respond at the time. The owner, Jacob Profit, was contacted by phone and advised the cameras only retains video for seven days. Mr. Shine Detail Shop located at 7305 Kanis Road advised their cameras were not operational.

Officer Alex Sullivan (1X63), who had responded to the scene of the incident, provided an Officer's Report. Officer Sullivan advised he was operating vehicle 18C447 (which was equipped with a functioning body microphone and MVR) when he responded to the scene. Officer Sullivan stated that the driver's side door was blocked by vegetation and the passenger side door of the suspect vehicle was blocked by a red car. Officer Sullivan advised another officer to find out who owned the red car so it could be moved. Once the car was moved, Officer Sullivan advised he assisted another officer in removing the driver through the rear passenger seat and door. Officer Sullivan stated he administered a tourniquet to the driver's left arm and a chest seal on one of the driver's chest wounds. He advised other officers were assisting with applying first aid. Officer Sullivan advised he and another officer began CPR on the driver until MEMS arrived on scene.

Officer Devan Herring (1X52) provided an Officer's Report. Officer Herring stated he was operating vehicle 18C466 (which was equipped with a functioning body microphone and MVR) and he responded to the scene to assist. Officer Herring stated when he arrived on scene, officers had their guns drawn and pointing at the suspect vehicle. Officer Herring advised that a black male was in the driver seat. Officer Herring stated the driver was bleeding and was minimally responsive. Officer Herring advised once the driver was removed from the vehicle, he retrieved first aid supplies and assisted another officer with applying a chest seal and performing CPR until MEMS arrived.

Officer D. Swinford (1Y70) provided an Officer's Report. Officer Swinford stated he was operating vehicle 18C450 (which was equipped with a functioning body microphone and MVR) when he responded to the scene. Officer Swinford stated Adams Wrecker Service arrived on scene to load the 2018 Nissan Altima displaying Arkansas #513WXF. Officer Swinford advised he

followed the tow truck to the Little Rock Crime Scene Bays where the vehicle was secured in Bay #2.

On Friday, February, 22, 2019, a search warrant was approved for the 2018 Nissan Altima displaying Arkansas #513WXF, to be processed.

Friday, February, 22, 2019, Detective Sergeant Jarred McCauley made contact with Officer Stark's attorney, Robert Newcomb, to schedule a time for Officer Starks to be interviewed. Sergeant J. McCauley was advised they would be available for a statement before or after Officer Starks' appointment at Ortho Arkansas PA on Monday, February 25<sup>th</sup>, 2019.

On Saturday, February 23, 2019, at approximately 1056 hours, Detective Oncken and Sergeant J. McCauley responded to view the Crime Scene Search Unit conduct a search of the 2018 Nissan Altima. Contents of interest that were seized from the vehicle were a loaded black .45ACP caliber Beretta Pistol Serial #PK41281, a blue bag containing baggies of a white powdery substance appearing to be narcotics, gloves, a black facemask, binoculars, a digital scale, cut straws with white residue, three 7.62X39 live cartridges, and three bullet projectiles. The recovered Beretta handgun showed to have been reported stolen in an Auto Breaking and Entering in Little Rock on January 4<sup>th</sup>, 2019 (Little Rock Incident #2019-001512). Detective O'Neil who was assigned to that incident was notified of the recovered firearm.


On Saturday, February 23, 2019, at approximately 0845, Detectives received a video taken from Facebook featuring Desaray Clarke describing the incident. The video shows an unknown subject recording Ms. Clarke as she describes the incident. In the video, Ms. Clarke gives a narrative differing from the recorded statement she gave to Homicide Detectives on Friday, February 22, 2019. Ms. Clarke stated in the Facebook video that numerous officers were firing into the vehicle. A copy of the video was made and added to the file.

On Sunday, February 24, 2019, Sergeant J. McCauley contacted Mr. Newcomb via phone and inquired about conducting an interview with Officer Starks on Sunday, February 24, 2019. Mr. Newcomb and Officer Starks agreed to give a statement at 1330 hours. Mr. Newcomb advised that Officer Starks had taken a medical for injuries that he had received during the initial incident around approximately 1000 hours on February 24, 2019. Due to being a narcotic, the

interview was rescheduled to Monday, February 25, 2019. Mr. Newcomb inquired about if Communications monitors and record the Northwest PCOM Channel.

On Sunday, February 24, 2019, Narcotic Detective responded to Major Crimes at the request of Sergeant. J. McCauley and tested the white powder recovered from the black 2018 Nissan. The white powder was field tested for cocaine with negative results. The field test kit was photographed by CSSU before disposal. The white powder was stored to be sent to the Arkansas Crime Lab for further analysis.

On Monday, February 25, 2019, at approximately 0800 hours, Detectives responded to the Arkansas State Crime to view the autopsy of Bradley Blackshire conducted by Medical Examiner Frank Peretti, MD. Approximately four gunshots were observed



On Monday, February 25, 2019, inquiries were made to Communications to see if the NW PCOM channel was recorded. Communications advised that NW PCOM channel is not recorded. Each Patrol Division has a PCOM Channel that is used to relay information in order to not overwhelm the Main Dispatch Channel with radio traffic. Communications sometimes monitors PCOM Channels but the channels are not recorded.

On Monday, February 25, 2019, Officer Starks responded to Major Crimes with his attorney, Mr. Newcomb. Officer Starks was read his Miranda Rights and informed that he was a suspect in Homicide related offenses. Officer Starks waived his rights with his attorney's approval to give a recorded statement. Officer Starks stated that it had been approximately fourteen hours since he had taken any prescribed medication. Before Officer Starks' began his statement, Mr. Newcomb asked for Officer Starks to be allowed to view video of the incident. Mr. Newcomb was informed that Officer Starks would not be allowed to view video of the incident. Mr. Newcomb strongly objected for the record but allowed Officer Starks to continue on with his statement.

Officer Starks advised that he was working on Friday, February 22, 2019 in a marked Little Rock Police vehicle wearing an issued Little Rock Police uniform with equipment. Officer Starks said that he was also wearing an approved outer ballistic vest carrier. Officer Starks stated he was patrolling the area of Broadmoor when he heard a Special Investigations Detective (Detective ask for any unit in the area of 12th Street and University. Officer Starks stated he did not initially key up due to hearing another unit, Officer Zebulun Tyler, respond on Main Channel. Officer Tyler was in the area of Cantrell and University according to Officer Starks. Officer Starks stated Detective advised to switch to Northwest PCOM Channel to relay information. Officer Starks advised he switched his patrol unit radio to Northwest PCOM since he was also going to be advise Officer Tyler they were tracking in the area. Officer Starks stated he heard Detective a stolen black Nissan travelling west on 12th Street crossing over University Avenue. At that time, Officer Starks stated he keyed up on Northwest PCOM and advised he was in the area of Boyle Park. After being informed the suspect vehicle had continued westbound on 12th Street, Officer Starks took a paved trail that runs from Boyle Park Road, behind West Park Meadows Apartments, coming out at West Park. Officer Starks advised when he came to West Park, he observed what appeared to be the backside of a black sedan westbound on 12th Street at the intersection of 12th and West Park. Officer Starks stated he was not able to identify the vehicle as the stolen Nissan at this time. Officer Starks stated at the time it was raining and he was concerned about a pursuit taking place which could cause unsafe conditions for officers and the public.

Continuing westbound on 12<sup>th</sup> Street from West Park, Officer Starks stated he could not see the black sedan anymore. Officer Starks advised he believed the vehicle could have possibly turned into the gas station at 12<sup>th</sup> Street and Rodney Parham (Big Red at 7200 W. 12<sup>th</sup> Street). Officer Starks stated as he approached the intersection of 12<sup>th</sup> Street and Rodney Parham he advised Detective of his location and requested the description of the stolen Nissan in order to distinguish the suspect vehicle from other similar vehicles he may see on the parking lots in the area. Officer Starks stated Detective provided the vehicle description as a black 2018 Nissan Altima and the license plate number before further advising the vehicle had pulled onto a parking lot on the south side of the intersection of 12<sup>th</sup> Street and Rodney Parham. Officer Starks stated that he intended using the second entrance of the parking lot as it would give him a clearer view of the suspect vehicle and any occupants as he approached. Due to vehicles being in front of his

vehicle, Officer Starks stated he chose to use the eastern most entrance to the parking lot which is the first entrance closer to the Mr. Shine Detail Shop at 7305 Kanis Suite A.

Officer Starks stated as he turned southbound into the parking lot, he observed a white SUV on the western side of the detail shop. Officer Starks advised he observed a black sedan occupied by a black male and a white female passenger backed into a parking space south of where the white SUV was parked. Officer Starks advised a black male was the driver and the white female was the passenger in the vehicle. Officer Starks stated he quickly advised on Northwest PCOM that he was out with the vehicle on 12<sup>th</sup> Street and then advised through his portable radio on Main Channel that he was out with a stolen vehicle at 12<sup>th</sup> Street and Rodney Parham. Officer Starks advised that he did activate his blue lights but could not recall if he activated them as he pulled onto the lot or as he came to a stop. Officer Starks stated he positioned his patrol vehicle partially in front of the suspect vehicle which was backed into the parking space. Officer Starks explained he did this in an attempt to prevent a pursuit in the rain and because the vehicle was parked and not in motion. Officer Starks continued to explain that his vehicle was far enough away from the suspect vehicle as to allow him movement once he exited the driver's door. Officer Starks said that was in case of an ambush or if he would need an avenue to move behind the engine block of his vehicle for cover.

Officer Starks advised he exited his patrol vehicle covering the driver and passenger of the suspect vehicle at gunpoint. Officer Starks stated he moved in a southerly direction across the front of the suspect vehicle and around to the driver's window. Officer Starks could not recall his exact commands but advised it was something to the effect of "Show me your hands and get out of the vehicle." Officer Starks advised the passenger was immediately compliant and showed her hands. He described her reaction as having "sheer terror in her face." Due to being able to see her hands and her reaction, Officer Starks said he did not consider her a threat at that moment.

Officer Starks stated he turned his focus on the driver. Officer Starks advised the driver "had a completely blank thousand yard stare at me." Officer Starks stated out of all the subjects in the past he held at gunpoint for stolen cars and other things, he had never seen anyone look at him the way this driver did. Officer Starks said that he continued to give commands of "Show me your hands and get out of the vehicle." At this point, Officer Starks advised he could not tell what was going through the driver's mind as he continued to fail to comply with the commands. Officer

Starks positioned his body square with the driver's door in order to reduce the force if the door opened quickly on him and also to provide maximum vest protection should the driver present a firearm.

Officer Starks advised the driver's window was down six to eight inches. Officer Starks could not recall if the driver's window was already down six to eight inches or if the driver rolled it down as he approached. Officers Starks continued with verbal commands. Officer Starks stated the driver began saying things such as "What for" and "I didn't do anything." Officer Starks said that he couldn't remember the driver's exact words but stated the driver said "You're just gonna have to shoot me." Officer Starks stated at that point he realized this was going somewhere he didn't want. Officer Starks believed he told the driver that he didn't want to do that and to just get out of the car. Officer Starks stated during the brief verbal exchange the driver locked the door preventing him from forcing the driver out of the vehicle.

Officer Starks stated the driver locked the vehicle and reached his right hand over to the gear shifter located in the center of the vehicle. Officer Starks advised the driver put it in gear and said something. Officer Starks said the driver moved his hand from the gear shifter down to the side of his right leg. Officer Starks stated at this point he stepped backwards and began moving in a southwest direction. Officer Starks advised his movement was in an attempt to maneuver to the front of his patrol vehicle for cover. Officer Starks explained that his patrol vehicle could prevent him from being struck by the suspect vehicle and provide cover should the driver produce a firearm and begin firing. Officer Starks explained there was nothing to the south of his position that would provide any cover should there be an exchange of gunfire. Officer Starks stated the backdrop would have been 12<sup>th</sup> Street with traffic and businesses causing a safety risk to the public. Officer Starks advised as he moved backward he observed the tire of the suspect vehicle turn toward him and the driver again stated something about shooting him (the driver). Officer Starks stated he continued to give commands to the driver but the vehicle moved forward.

Officers Starks said he continued to move back but the suspect vehicle struck his leg with what he believed was the front driver's side quarter panel of the vehicle. Officer Starks stated the vehicle was not violently accelerating but it did strike him. Officer Starks stated he continued back and the vehicle struck him a second time. Officer Starks stated when he was hit again he felt an extreme sharp pain in his right leg. He could not recall at what point he ended up on the suspect

vehicle's hood but stated after feeling that pain, he felt he was going to be ran over and killed. He believed his right hand was pointing center mass at the driver and his left hand was on his portable radio. Officer Starks stated he fired an unknown number of rounds at the driver who he felt was going to kill him.

After firing, Officer Starks recalled looking to the passenger side of the windshield and seeing a bullet hole. Officer Starks said that he was extremely concerned the passenger had been struck. Officer Starks stated due to her total compliance with commands during the incident, she was not an intended target.

Officer Starks stated there was a period of time he did not remember or had blacked out.

Officer Starks describes this time period from when he observed the bullet hole in the passenger side windshield to being off the hood and seeing the suspect vehicle at the fence row.

Officer Starks recalled seeing Officer Simpson on scene with his gun drawn giving unknown commands to the driver. The female passenger was asking to get out of the vehicle. Officer Starks moved to the passenger side of the vehicle and did not recall if he removed the passenger or if she exited the vehicle on her own. Officer Starks said he led the passenger a short distance from the vehicle and took her into custody. Officer Starks stated the passenger advised him the driver still had a gun. Officer Starks advised he yelled to Officer Simpson advising him there was still a gun in the car.

After handcuffing the passenger, Officer Starks stated he observed an SUV that had entered the parking lot and a white male approached him. The subject identified himself as an off duty police officer and offered assistance. The off duty officer assisted with keeping civilians clear of the crime scene. Officer Starks said that he initially sat down in a patrol unit where the passenger of the suspect vehicle had been placed. Officer Starks said that at that point he separated himself from the scene by sitting in the off duty officer's vehicle until Lt. Jackson approached him and relieved him of his duty weapon.

Officer Starks stated that he had sustained an unknown injury to his right knee and was awaiting an appointment with Ortho Arkansas to find out the extent of the injury. Officer Starks was wearing a knee brace on his right knee. Officer Starks signed medical release forms so that medical records could be obtained for the file.

On Monday, February 25, 2019, at approximately 1530 hours, Detectives responded to All Pro Styles Barbershop at 7305 Kanis Road in an attempt to retrieve security video. Subjects were standing on the parking lot but the door was locked to the business and nobody answered the door.

At approximately 1600 hours, Detectives responded to the Big Red Valero at 7200 W. 12<sup>th</sup> Street to attempt to retrieve security video again. Detectives were advised the Big Red corporate office in Bryant, Arkansas was aware of the video request and to contact their I.T. department.

On Tuesday, February 26<sup>th</sup>, 2019, Detective Oncken responded to the Big Red Corporate office at 1511 N. Reynolds Road, Bryant, Arkansas, and retrieved a copy of the video from their store at 7200 W. 12<sup>th</sup> Street. The parking lot where the incident occurred was a substantial distance from the security video. It shows the stolen Nissan Altima enter the parking lot at 7305 Kanis Road and a police unit follows shortly after.

At approximately 1440 hours, an Authorization To Disclose Health/Confidential Information form signed by Officer Starks was submitted to Baptist Hospital to produce medical records for February 22, 2019. The records have not been received at the time of this summary and will be added to the file when received.

At approximately 1430 hours, Detectives responded to All Pro Styles Barbershop at 7305 Kanis to serve a search warrant in order to obtain any evidence captured by security video. Upon arrival subjects exited the business leaving it completely unoccupied. Detectives asked the subjects in the parking lot if there were any employees or if the owner of the business around. None of the subjects would answer the questions asked of them. A subject approached and introduced himself as Jimmy Morris. Mr. Morris advised he was an attorney. Mr. Morris was asked if the owner was present so the security video could be retrieved. Mr. Morris advised he had spoken with Mayor Frank Scott Jr. and he would turn the video in on Friday. Detectives advised Mr. Morris they had a search for the video. Mr. Morris entered the business and returned with a thumb drive advising it contained the video of the incident. Mr. Morris explained his client had monetary value in the video and asked if the video would be available for FOI (Freedom of Information Act). Sergeant J. McCauley advised Mr. Morris any information released at this time would be determined by the City of Little Rock or the Pulaski County Prosecuting Attorney's Office. Mr. Morris showed detectives available cameras locations that covered the incident. After returning to Major Crimes, it was found the thumb drive was password protected. Contact was made with Mr.

Morris via phone who provided a password however it was unsuccessful. Detectives responded back to the barbershop and made contact with Mr. Morris. After asking if a video could be downloaded directly from the hard drive detectives were allowed to do so. A password was provided and the video was available from two cameras. The original thumb drive with the invalid password was also stored.

On Tuesday, February 26<sup>th</sup>, 2019, Sergeant J. Plunkett and Officer M. Hill responded to the residence of Officer Starks. Officer Starks' replacement firearm, ammunition, and identification card were collected.

On Wednesday, February 27, 2019, the Little Rock Police Department Homicide Office was requested to produce a copy of all videos related to the shooting incident for the Federal Bureau of Investigations Little Rock Field Office. Detective Oncken prepared all available requested video.

On February 28, 2019, copies of the requested videos were signed over to the Federal Bureau of Investigations (FBI). Copies were also made and turned over for a Critical Incident Presentation.

Chief DPA John Johnson was contacted in reference to a request from Mr. Blackshire's family and Officer Starks to release items that were possibly personal property which had been stored as evidence. Both parties were denied the release of the property until the case file could be thoroughly reviewed.

On Monday, March 4, 2019, at approximately 1215 hours, Marcella Meyer was interviewed at Major Crimes as a witness to the incident. Ms. Meyer stated she was stopped southbound on Rodney Parham at the intersection of Kanis/12<sup>th</sup> Street at the stoplight on Friday, February 22, 2019. She observed a police vehicle with blue lights on and a black sedan. Ms. Meyer advised she believed it was a routine traffic stop but kept looking back and forth between checking on the stop light and the police vehicle. Ms. Meyer said she looked back and saw the black sedan moving forward and an officer was on the hood. Ms. Meyer said she heard gunshots and made a right turn onto Kanis. Ms. Meyer stated she did not remember seeing any other subjects or officers on the parking lot.

On Monday, March 4, 2019, a request was made for Communications to provide a copy of any radio traffic within ten minutes prior to the incident on Main Channel, Channel Eight, and Channel Nine. The copies were provided for Main and Channel Eight. Channel Nine was not in operation at the time. O52 (Ocean Fifty-two) can be heard on main Channel asking for units in the area of 12<sup>th</sup> Street and University as previously stated. The original copies of radio traffic during the time of the incident did not go back far enough to capture his traffic.

On Tuesday, March 5, 2019, an additional copy of the received radio traffic ten minutes prior to the incident was prepared for the FBI and Critical Incident Presentation.

On this date a request was prepared for the baggie of unknown white powder, residue on a cut straw, and white powder from a rolled dollar bill recovered in the stolen 2018 Nissan to be sent to the Arkansas State Crime Lab for drug analysis. A request for a swab, taken from the recovered .45 Beretta firearm, was prepared to be sent to the Arkansas State Crime Lab for detecting possible DNA. A request for the recovered latent fingerprints to be analyzed for identification was submitted to the Little Rock Police Crime Scene Search Unit for analysis.

On Wednesday, March 6, 2019, Detectives located the gas station where Desaray Clarke said Bradley Blackshire had went to get cigarettes prior to the officer involved shooting. Ms. Clarke said she was picked up on West 28<sup>th</sup> Street in the black Nissan Altima. Ms. Clarke said a black male name "Red" was driving, Mr. Blackshire was sitting in the front passenger seat, and she was in the rear passenger side seat. Ms. Clarke said they went to a gas station close to Fair Park and she went inside and purchased some cigarettes.

Detectives then responded to 3201 Fair Park Blvd., Fair Park Grocery Store, and made contact with the owner, Sung Park. Detectives asked Mr. Park if we could look at his surveillance video for the date of February 22, 2019, between the hours of 0900 to 1000 hours. Mr. Park pulled up the surveillance footage for the above listed date and time and detectives observed a black Nissan four door sedan, unknown license plate information, pull into the parking lot and Desaray Clarke exited out of the passenger side rear door. Ms. Clarke went inside the store and a short time later Bradley Blackshire is seen exiting out of the driver's side front passenger seat and goes inside the store. Detectives observe both subjects standing at the register talking. Mr. Blackshire is seen paying for their items and they exit the store. Ms. Clarke gets back into the rear passenger seat of the black Nissan four door sedan. Mr. Blackshire got back into the front seat passenger side

of the black Nissan four door sedan. Mr. Park said he could not give detectives the video due to him not knowing how to work the video. Mr. Park said his son, Pread Park, would be able to give detectives a copy of the surveillance footage on Friday, March 8, 2019. Once received the video will be added to the file. Detectives were able to record the display screen of the security footage with a city issued cell phone. A copy of that video will be added to the file.

On Wednesday, March 06, 2019, Detective at the request of Sergeant J. McCauley, obtained a ZTE cell phone that was recovered in the search of the 2018 Nissan from the Little Rock Property Room. Detective was unsuccessful in removing any data from the cell phone. The cell phone will be sent to the Arkansas State Crime Lab for further analysis.

#### **NARRATIVE**

FICERS MADE A TRAFFIC STOP IN THE PARKING LOT OF 12TH STREET AND RODNEY PARHAM ROAD, ON A CORTED STOLEN BLACK NISSAN ALTIMA BEING DRIVEN BY BRADLEY BLACKSHIRE. DURING THE STOP, MR. BLACKSHIRE REFUSED TO EXIT THE VEHICLE AND BEGAN TO DRIVE THE VEHICLE TOWARDS OFFICER STARKS. THE VEHICLE DRIVEN BY MR. BLACKSHIRE MADE CONTACT WITH OFFICER STARKS. OFFICER STARKS DISCHARGED HIS DEPARTMENTALLY ISSUED FIREARM, STRIKING MR. BLACKSHIRE. OFFICERS ATTEMPTED TO RENDER AID TO MR. BLACKSHIRE BUT HE SUCCUMBED TO HIS INJURIES ON SCENE. # **Incident Information**

**Date:** March 5, 2019

Incident Number: 2019-022984

On Wednesday, February 27, 2019, I was asked to create a time line of major events surrounding an Office Involved Shooting, Incident #2019-022984, between Officer Charles Starks and driver of a stolen Nissan Altima bearing Arkansas License Plate, Bradley Blackshire.

The following is a timeline based on the City of Little Rock Camera system, Officer Starks' and Officer Simpson's Mobile Video Recorder, Communications time stamps, and Crime Scene logs. Some timestamps are different than other time stamps on systems, so all times are approximate:

#### On February 22, 2019

At approximately 1104 hours, the City of Little Rock License Plate Reader alerted a stolen vehicle passed through the intersection of 12<sup>th</sup> Street and Peyton Street traveling west bound. The Arkansas License Plate was 513WXF. Detective received the alert and immediately ran the license plate through ATLAS/ACIC and confirmed the vehicle was stolen.

At approximately 1105 hours, Det. located the black Nissan Altima bearing Arkansas License Plate 513WXF, traveling west bound on 12<sup>th</sup> Street. Via Main Channel, Det. requested assistance from officers in the area. Officer Zebulun Tyler answered and was directed to Northwest P-Com (a secondary radio channel). Once on Northwest P-Com Officer C. Starks becomes involved in the conversation. The NW P-Com radio traffic was not recorded per departmental policy.

At approximately 1106 hours, the black Nissan Altima bearing Arkansas License Plate 513WXF was then located traveling westbound, stopped at the intersection of 12<sup>th</sup> Street and University Avenue. The black Nissan Altima bearing Arkansas License Plate 513WXF was observed continuing westbound through the intersection.

At approximately 1108 hours, the black Nissan Altima bearing Arkansas License Plate 513WXF was observed turning left off of 12<sup>th</sup> Street into a parking lot of 7305 Kanis Road (All Pro Styles Barber Shop).

At approximately 1109 hours, the black Nissan Altima bearing Arkansas License Plate 513WXF was observed circling the parking lot and then backing into a parking space on the east side of the parking lot, facing west.

At approximately 1109 hours, Officer Starks pulled into the parking lot and stopped in front of the black Nissan Altima. Officer Starks' City of Little Rock police marked vehicle was parked facing south. This is when Officer Starks' body microphone turns on. Officer Starks exited his assigned City of Little Rock police marked vehicle with his gun drawn and approached the black Nissan Altima on the driver's side.

Officer Starks tells the driver, Mr. Blackshire, to show his hands, roll the window down, and then step out of the black Nissan Altima. Mr. Blackshire did not get out of the car.

At approximately 1110 hours, Officer Starks moved forward to the front portion of the vehicles driver's side fender. Officer Starks continued to give Mr. Blackshire verbal commands to exit the black Nissan Altima. The black Nissan Altima then proceeded to move towards Officer Starks at a slow speed. The black Nissan Altima struck Officer Starks' left leg and according to Starks, causing injury to his right knee. Officer Starks fired four (4) rounds initially. With the car still moving, Officer Starks continued forward, eventually falling onto the hood of the black Nissan. Officer Starks fired an additional eleven (11) rounds as the black Nissan Altima continued to move forward. MEMS was requested to be put on standby.

All fifteen (15) rounds fired by Officer Starks occurred within seven (7) seconds.

From the time Officer Starks stopped his patrol vehicle and told Mr. Blackshire to show his hands and get out of the car until Officer Starks first fired his service weapon, was forty-six (46) seconds.

As Officer Starks is on the vehicle's hood and firing, Officer Simpson pulled into the parking lot and struck the passenger side of the black Nissan Altima with his City of Little Rock police marked unit, causing Officer Starks to fall off the hood of the black Nissan Altima. The black Nissan Altima stopped. Officer Starks and Officer Simpson then ordered Mr. Blackshire to exit the black Nissan. The black Nissan Altima then rolls south through the parking lot before coming to a stop against a fence.

At approximately 1111 hours, the passenger Desaray Clarke then exited out the passenger side front window of the black Nissan Altima. Officer Starks had Ms. Clarke lay down on the parking lot on her stomach and Officer Starks placed handcuffs on Ms. Clarke. As Ms. Clarke is being removed from the vehicle she advised officers there was a gun in the car.

At approximately 1112 hours, officers began to get Mr. Blackshire out of the vehicle but had trouble due to damage to the vehicle.

At approximately 1113 hours, officers were able to pull Mr. Blackshire out of the black Nissan Altima and began administering first aid.

At approximately 1115 hours, MEMS was notified that the scene was secure and they could come in.

At approximately 1119 hours, the first supervisor notified Communications they were on-scene.

At approximately 1120 hours, MEMS was requested to transport Officer Starks to the hospital.

At approximately 1125 hours, the first Major Crimes Division detectives began arriving on scene.

At approximately 1128 hours, Deputy Prosecuting Attorney John Johnson arrived at the crime scene.

At approximately 1135 hours, Officer Simpson was transported to the 12<sup>th</sup> Street Substation to be interviewed.

At approximately 1136 hours, the Command staff began arriving at the scene.

At approximately 1142 hours, witness Billy Zulpo was transported to the 12<sup>th</sup> Street Substation for questioning.

At approximately 1148 hours, Crime Scene Search Unit began arriving at the scene.

At approximately 1210 hours, detectives made contact with Officer Starks at the hospital, after he left the scene. Officer Starks was in the process of receiving treatment and medication for his injuries, and therefore no statement was able to be taken. Departmental issued clothing was taken by detectives from the hospital and transferred to Crime Scene Search Unit. Officer Starks was shortly released from the hospital and was to

contact Major Crimes Division concerning giving a statement at a later time.

At approximately 1213 hours, Internal Affairs sergeants began arriving at the scene.

At approximately 1215 hours, City Attorney Tom Carpenter arrived at the scene.

At approximately 1245 hours, Pulaski County Coroner's Office arrived at the scene.

At approximately 1316 hours, witness Billy Zulpo was interviewed by Homicide detectives at the 12<sup>th</sup> Street Substation, after notifying them he witnessed the incident.

At approximately 1349 hours, Moises Solis was interviewed by Homicide detectives at the 12<sup>th</sup> Street Substation, after notifying them his vehicle was struck by a stray projectile.

At approximately 1355 hours, Ms. Clarke was interviewed by Homicide detectives at the 12<sup>th</sup> Street Substation, after being transported from the scene.

At approximately 1444 hours, Officer Simpson was interviewed by Homicide detectives at the 12<sup>th</sup> Street Substation.

At approximately 1739 hours, Randy Armstrong was interviewed by Homicide detectives at the 12<sup>th</sup> Street Substation, after stating he witnessed the incident.

At approximately 1715 hours, the scene was released.

#### On February 25, 2019

At approximately 1108 hours, Officer Starks provided a recorded statement to Homicide detectives.

All times provided are approximate based on the time stamps of the devices checked. The above is just an overview of noted events during the investigation. I turned in this timeline to Detective Aaron Oncken and Sergeant Jarred McCauley.

Also present with me is Detective Aaron Oncken, Lieutenant Sidney Allen uh, Charles Starks and his attorney, Robert Newcomb. Um, we're here in relation to incident number 2019-22984. It's going to be an incident that occurred on Friday, uh, February 22<sup>nd</sup>, 2019 at 7305 Kanis Road. Uh, another location that was, was put out in the incident was 12<sup>th</sup> & Rodney Parham and that incident occurred approximately 1109 hours. Um, before we get started, I'm gonna go ahead and go through your Miranda Rights Form with you. Um, again today's date is the 25<sup>th</sup> and the time is 1108. It says I, Charles Starks, and correct me if I have your date of birth wrong. It's says date of birth

Have you worked Northwest Division your whole career?

STARKS:

Yes, uh, the only time I wasn't Northwest is I was in the class that rotated divisions and shifts through my FTO training. But once I

finished my FTO training I've been Northwest throughout.

McCAULEY:

Okay. You were Young 61 you said?

STARKS:

Yes, sir.

McCAULEY:

Do you remember what uh, patrol unit you were in that day?

STARKS:

It was an 8, it was a 2018 I know that. Uh, I don't, I don't recall.

McCAULEY:

Do you know what kind of car it was?

STARKS:

It was a Ford Explorer.

McCAULEY:

Was it a marked unit?

STARKS:

Yes, sir. 444, I just thought of it.

McCAULEY:

444?

STARKS:

Yes, sir.

McCAULEY:

So 18C444?

STARKS:

Yes, sir.

McCAULEY:

Okay. Is that the district ride?

STARKS:

No. It is, it is actually a uh, night shift car. Um, but we have quite

a bit of people on our shift and so at times we have to take the

other shifts cars.

McCAULEY:

Have you ever ridden in that unit before?

STARKS:

I don't know.

McCAULEY:

Okay. Um, that day that you, on the 22<sup>nd</sup>, was it equipped with a

functioning MVR?

STARKS:

Yes.

McCAULEY:

Was it equipped with functioning lights and sirens?

STARKS:

Yes.

McCAULEY:

What were you wearing that day?

STARKS:

Uh, my assigned duty uniform with the new approved and optional

outer carrier load bearing, bearing vest.

McCAULEY:

Just for the sake of what we took that day –

STARKS:

Yes, sir.

McCAULEY:

I believe this is a photograph of you in the hospital. Do you

remember that photo being taken of you?

STARKS:

I remember the detectives being there and taking photos.

McCAULEY:

Okay.

STARKS:

Uh, that specific picture, no.

McCAULEY:

Okay. That's fine. Um, would that have been a uniform shirt that

you might have been wearing that day?

STARKS:

Absolutely.

McCAULEY:

Okay. And is this the outer carrier that you were talking about?

STARKS:

Yes, sir. Yes, sir.

McCAULEY:

Uh, just for the sake of the record, these photographs were taken

uh, of you knee that day.

STARKS:

Yes, yes sir.

McCAULEY:

Do, does, does that, were you wearing the scrubs pants that day?

STARKS:

No, sir. No, sir not, not at all. Uh, once the detectives requested

my uniform for evidentiary purposes uh, the hospital provided me

with scrubs -

McCAULEY:

Okay.

STARKS:

To change into.

McCAULEY:

Got you. Are these, is this your knee?

STARKS:

Yes.

McCAULEY:

Okay. These photos were taken that day and I just wanted to

absolutely make sure that that was you. Um -

STARKS:

Yes, sir.

McCAULEY:

Now you, but you were saying that you can't recall if these photos

were actually taken of you that day.

STARKS:

I, I don't remember, I remember them being in the room and taking

pictures. I don't remember those exact –

McCAULEY:

Okay.

STARKS:

Pictures being taken.

McCAULEY:

That's fair. Um, okay. So, this is where from like a, kind of a birds

eye view. Can you kinda explain the events that lead to the

incident um, that we're here talking about today?

STARKS:

Do you want me to go all the way back to what lead me to begin –

McCAULEY:

Sure. I mean if you –

STARKS:

My, my, my -

McCAULEY:

Wanna start -

STARKS:

Route, my route to where -

McCAULEY:

Sure.

STARKS:

This occurred.

McCAULEY:

If you wanna start with the, the location and you were notified and,

and just kinda go from there.

STARKS:

Okay. Okay. Uh, working Young 61 I was 10-8 and I was patrolling the area of the Broadmoor area uh, which is in 61 and uh, is, is known to often have uh, uh, crime issues. Um, I believe, I don't, I don't remember the name of the street I was on. Um, I heard an SID officer on main channel request uh, a unit that was, that, asked if there were any Northwest units close to 12<sup>th</sup> and University. Um, I did not key up at and I was not the first officer to key up. Another officer that was near Cantrell and University keyed up first. Uh, the SID officer requested that officer to go to Northwest P Common uh, to relay the information he had. I

switched over since I was in the area as well.

McCAULEY:

For, for the sake of the record, can you tell me what Northwest P

Com is?

STARKS:

Yes, it is a channel that we use um, that each, each division has a P Com channel that that division uses to relay information from other officers to officers in that division uh, in order to and we go to that channel to do it in order not to tie up main channel and dispatch.

McCAULEY:

And for the sake of the record uh, uh, when I was speaking to your attorney yesterday, he had asked if that channel was recorded. I did ask our communications if it was Mr. Newcomb and they said where sometimes it is monitored, it is not recorded. Okay?

**NEWCOMB:** 

Okay.

McCAULEY:

So, continue on.

STARKS:

Okay. So I, I uh, changed my car radio over to P Com. I prefer for my safety that I don't use my portable for anything besides main channel and secondary requests when I'm on, on, on duty. Uh, so I used the car radio. Changed it over to Northwest P Common and I heard um, am, am I allowed to say the, the SID officer's name? I'm not trying to give up his name or anything.

McCAULEY:

I'm, I'm, I'm fine right now with just –

STARKS:

Just the SID -

McCAULEY:

Calling him the SID.

STARKS:

Okay. Okay.

McCAULEY:

Since he is in undercover status.

STARKS:

And, and that's why I was, uh, I, I heard uh, the SID officer informing Officer Tyler that uh, they had, they were tracking a stolen car. A black Nissan traveling west on 12<sup>th</sup> Street that through the LPR system uh, traveling west on 12<sup>th</sup> Street uh, crossing over University. At that time I was near or turn, I don't remember if I, I was near or turning onto Boyle Park off of a road that comes out of the Broadmoor area. Once I turned right onto that I also keyed up on Northwest P Common and informing the SID officer that I was near the area he was speaking of and asked if he knew if the vehicle had gone through 12<sup>th</sup> and Cleveland yet. Reason I asked that is I am approaching a trail that is commonly used to bypass the stop sign intersection at Cleveland and Boyle

Park and the stop light at 12<sup>th</sup> and Cleveland should we need to get to the area of 12<sup>th</sup> and Rodney Parham or 12<sup>th</sup> and West Park quickly.

McCAULEY:

Is that a paved trail?

STARKS:

Uh, there is a short uh, portion of it that is dirt that goes to the paved part and then that trail goes all the way around up onto a parking lot on West Park.

McCAULEY:

Okay. So did you end, so is that where you ended up?

STARKS:

Yes.

McCAULEY:

Okay.

STARKS:

Yes. So, I asked him if it had gone through 12th and Cleveland yet. Um, he advised it was westbound uh, headed towards 12th and West Park. It was raining. I fully anticipated like most stolen cars when you come into contact with them, if you come behind them it would flee. I did not wanna have a pursuit in the rain. Uh, that, that, that's a totally different ballgame when we start chasing cars in the rain uh, for an officer's safety issue and for a public safety issue. Uh, so at that time I informed him that I was taking the trail that went behind the apartments off of Boyle Park and West Park. I believe they're called West Park Meadows uh, West Park Apartments is what I refer to them as. Um, and I took, and I took the trail uh, coming out on the parking lot just north of the FedEx warehouse on West Park. It was a small parking lot and I'm not sure what the business is. Uh, he advised that the vehicle was going through 12<sup>th</sup> and West Park at that time. As I turned onto West Park there's a slight curve where you turn onto it, uh, from, from that parking lot. As I came around the curve, I caught the glimpse of a, of, of the backside of a black sedan. I, I couldn't identify it as the vehicle at that point, but I saw a black sedan traveling towards the very end of the intersection where I could see it from, from where I was.

McCAULEY:

And that was 12th and -

STARKS:

12th and West Park.

McCAULEY:

West Park.

STARKS:

Yes.

McCAULEY:

Okay.

STARKS:

Yes, sir. Uh, I continued north on, on West Park uh, turning west onto 12th Street. Um, I, I advised uh, the SID officer that I was approach, that I would be near 12th and Rodney Parham in a short amount of time. Um, I could see the intersection ahead of me. Um, I did not see the black sedan anymore. I asked, I asked him again for the information on the vehicle just in case as I approached that intersection it was, I was actually thinking it possibly had turned into the gas station at 12<sup>th</sup> and Rodney Parham where we have had numerous incidents occur over, over my career. Um, I did not want to pull into that parking lot and see two, three, numerous black vehicles and me having to start processing which vehicle I needed to go to. Uh, I asked for the vehicle information again and he provided it. Uh, he advised me that it was a 2018 black Nissan Sentra. Uh, he gave me the tag number and I don't remember that. Uh, he gave me the tag number on it and then he advised that it had pulled into the parking lot on the south side of the intersection of 12th and Rodney Parham, which has a barber shop to the west and a detail shop to the east on the parking lot. As I'm approaching 12<sup>th</sup> and Rodney Parham, I don't remember what color the light was, but I remember there being vehicles in front of me. uh, my ideal situation was to get to the intersection where there is a uh, an entry way into that parking lot from about midway to the western side of the parking lot so as I'm approaching the vehicle I have direct eyes on the suspect and what he's doing. Um, but due to the vehicles in front of me, I was unable to do that. Uh, I immediately turned into the parking, the uh, entryway of the detail shop, which is actually on the east side of that parking lot. Uh, and it's directly in, I wanna say it's directly in front of it. It's in the front of the business, the entryway and on the east side. as I turned into that uh, as I came around the corner of the uh, the shop uh, my vehicle turning south into the parking lot uh, from the front of the, the entryway to the parking lot uh, I saw a white SUV and then further back in parking space, the, the parking spaces run all the way alongside that building, further back from the white SUV I saw a black sedan with a black male, white female passenger uh, backed into a parking spot. Uh, I told on P Common uh, quickly that I was gonna be out with a vehicle at 12th and, that I was gonna be out with it and then I immediately, then, then I went to, to my portable on main channel advising them to show me out with a stolen vehicle at 12<sup>th</sup> and Rodney Parham. As I, as I pulled up to the vehicle uh, because of it raining, because of the positioning of the car, because of numerous things I've been taught and gone through as an officer uh, so far in my career I knew that I was within my ability, within policy to park my car in a manner to, to

attempt to block that subject in considering he was stationary. He was not moving. At that time the vehicle wasn't moving. It was stationary. In order to uh, avoid a pursuit and in a manner which would still leave him an avenue of escape, but it would not be easy for, for him to just drive off. I pulled my vehicle to where I was covering what I would say would be a half of the front portion of his car. Across about half of the hood with the front of my vehicle. But at the same time I also was far enough in front of the vehicle that should an issue arise as before I got out of my patrol vehicle or as I'm getting out of my patrol vehicle where a suspect were to attempt an ambush or, or anything like that I would have space to get out of my vehicle. Being in the vehicle in a situation like that is the most dangerous place I could be. Uh, and that would allow me, allow me an avenue to, to get around behind my vehicle for cover. Uh, as I stopped I, I don't know if it, if I turned my lights on after I stopped or just as I was pulling up in front of the vehicle, but I know for a fact I turned my lights on um, and was drawing my weapon as I exited the vehicle. As I exited my patrol car. Uh, I placed the driver and passenger at gunpoint as I'm crossing the front of the vehicle uh, walking right in front of it, but walking in a south direction to come around to the driver's window. Immediately I saw the passenger give immediate compliance to my commands. I could see her hands. I could see what I would describe as sheer terror in her face. Um, and, and I could tell at that point she was not going to be a threat to me at that moment. At that moment she was not a threat. My attention on the driver was a completely different story. He had what I would call a, a completely blank thousand yard stare at me. Um, other subjects that I have placed at gunpoint for stolen cars and other things I can't ever recall seeing that look being given directly to me back. Um, as I came around his side I, I cou, he, he would not comply with my commands of show me your hands, get out of the vehicle. I continued to give him commands. I don't know my exact wording at this point, but commonly it, it would equate get out of the vehicle, show me your hands and get out of the vehicle. Um, due to where he was parked instead of standing at an angle in front of the driver's door facing him, I squared my body, my chest, squared my body with the door in case he were to throw the door open quickly because he wasn't complying. I, I couldn't tell necessarily what, what, what was going through his mind at that point cause he was not doing what I was telling him to do. Uh, that was for my safety. For absolute maximum coverage should his hands come up with, with a firearm. That, I was absolutely covered at that point with my vest. Where on the sides there are gaps under your arms and they're vulnerable places to, to be injured uh, by gunfire. I, I'm pointing my firearm at him and the

window, I don't remember if he rolls it down or if it was down, I would guess, I would call it six to eight inches comes down and I'm yelling at him, show me your hands, get out of the car and he's saying, what for. I didn't do anything. I, I, and I recall, I don't, I don't remember his exact words, but I recall him saying, you're just gonna have to shoot me and at, and at that point in my mind I, I understand that this is, this is going somewhere I, I, I don't want. Um, I told him again get out of the car. I'm almost positive I, I said the words I don't wanna do that, just get out of the car. And he wasn't complying. At one point, I don't remember if it was after the window or what point in, in this short uh, verbal exchange I. I remember him locking the door where I couldn't open it to force him out of the vehicle. At that point I remember his right hand going over, the shifter's in the middle on that car, uh, it's an automatic but it's in the middle to where it goes down into gear and I remember him saying no and something else. Uh, he, he was talking to, he wasn't talking to me at that point. He said something to himself and he put it in gear and it, and his hand came back over not up, but over near his right leg. I could not tell at that point if he was reaching for something. If he was trying to grab anything. And at that point I immediately realized in my mind this, this, this guy's not staying here. Or this is about to become mobile uh, with his vehicle. With the manner I parked my vehicle in front of it, I knew for a fact he could not turn right and exit that parking lot without hitting my patrol car. He would have to turn left very sharply to avoid catching it with the front passenger portion of his, of his vehicle. If he drove straight forward, he would still strike my patrol car. so if his avenue of escape at this point is going to be him driving away, he's gonna be turning towards me because as he put it, after he put it in gear I began to step back away from where I was not square anymore with the window, but turning my body and backing away from the car to what would be the southwest. Just, just in a southwestern direction from where the car was, from where the driver's door was. And as I'm backing away I realized the tires are turned my direction. Not extremely sharp in, in which I would equate to he's gonna miss my patrol car or anything to get out of here basically. Uh, but they're turned in my direction. I'm still giving him commands uh, lawful orders to, to get out of the car, stop and he's just not complying. I, I remember him saying something about shooting him again. Uh, he, he said something again about uh, about me shooting him. Shooting him or killing him or something to that effect. And at that point he began to come forward. His vehicle started moving forward. I started backing up because once again, my main priority at this point is being able to get to my cover to where, to where I'm, I'm not gonna be struck by a vehicle or by whatever his right hand was

reaching for in the car. what, whatever his right hand was doing, I, I, that's my main two priorities at that point are, are, are not be hit by the car and not be hit by any possible weapon that he may have on him at that time in the vehicle. As he's coming forward um, I don't know how far back I went. I, I don't know. Um, I don't remember if the first bump against me was in front of my car or before we got in front of my patrol car. I, I just don't remember. But at some point I remember I, I keyed up on main channel and told them that he was refusing to get out of the car and that I needed people. I, I, I, I knew they were already holding main channel at the beginning when I said I'm checking, when I checked out with a stolen car. They, they do that automatically um, for our safety to get units to us quicker. And so it wasn't a matter of hold the net I'm in trouble. It was the nets already held and now I'm in trouble. I need you guys that are already coming to, to step on it because this is going somewhere I don't wanna go. I felt the car on the driver's what, what I, what I recall to be the, the driver's front quarter panel. So it would be the left front quarter panel of the car near the tire bumping into me. It wasn't uh, it was not a violent acceleration, but the car hit me. I continued back and as it hits me again I don't remember if I immediately went down and over the hood, but I know when it hit me the second time I felt a sharp pain that I've never felt before in my right leg. Go from my knee all the way up my leg. Immediately I knew something was wrong and as he pushed against me with the car, all I could, what immediately went through my head is my little girl growing up without her dad. My wife and I went through absolute hell to be able to have a kid and now I'm not gonna be able to watch her grow up. And she's so small and young that she'll never remember me. I was absolutely convinced in that moment that that's how I was gonna die. Is being run over by a car just trying to do my job by someone that was just passing up multiple commands to just do this the most peaceful way possible. Just get out and let me handcuff him and let's just address it as what it is. Just being in a stolen car. I don't recall at what point of that thought I started firing. I know the entire time as I was backing away I had him at gunpoint. I could see center mass on him and as we're taught in training, in the academy, in service every year, it's eliminate the threat and center mass. Knowing that I'd, I didn't wanna die. I didn't want my child to grow up not knowing her dad at all. I began firing. I'm sorry.

McCAULEY:

No, you're fine. Take your time.

STARKS:

Can I get a drink?

McCAULEY:

Absolutely. Take your time.

STARKS:

So, I began firing and I continued, I, I, I think I continued to walk back, but I know that I was also down a little bit from where I was originally standing straight up and I had at some point, whether it was immediately prior to shooting or while I was shooting, at some point I remember not being flat down on the hood, but over it. And I'm almost positive that my left hand wasn't on the hood, but it was on my radio. My, my mic. It was pinned my, my uh, uh, my load bearing vest. It was pinned to it. I don't know if I was keving up at that moment or not, but I re, I'm almost positive my hand was on my radio. I don't know how many times I fired, but I specifically, I, I'm looking straight at my target at, at, at this guy that wants to kill me and I don't know why and all of the sudden out of something just grabs my attention on the passenger's side of the car and I immediately see a bullet hole in the windshield on the win, on the, on the lower passenger's side of the car. And I go from oh my God, I'm about to die to holy hell she was completely compliant. What just happened that made a bullet go over there? I was terrified I had hit the woman that was completely compliant for me from the time I got out of the car. I remember backing, continue to back away and the car is coming forward and then there's a large portion that I don't recall after that. There, there's, there's, there's a, a, a space of time I don't know if I blacked out or if I'm just having problems remembering it or what happened. I don't know. Um, but the next thing I knew is I was further west of my car. Possibly on the other side of another patrol car and I saw off, and I saw the, the stolen vehicle at the very south end of the parking lot. On the passenger's side was a dumpster and it was. I don't know if it had hit or was near hitting a chain link fence that runs along the south side of that parking lot. I see Officer Simpson near the driver's door yelling. I don't know what he's yelling. I, my head felt like I was absolutely spinning in a circle as fast as I possibly could and stopped at that time. I remember the passenger. I see the, the passenger's side of the car is damaged at this point. And I hear the passenger screaming about asking permission or wanting to get out of the car. I remember her saying, sir numerous times and it just sticks in my mind that even through all of this she was still saying sir to, towards us. Towards me or Simpson or whoever she was yelling at about getting out of the car. I told her uh, I don't remember if I told her she could get out or if I went up and got her out. But I know she got out of the vehicle. I walked with her away from the vehicle a short distance, told her to get on the ground and, and my, my weapon has become I'm almost positive my weapon has become holstered at this point or I told, or I still had it out and told her to get on the ground, which she

complied like she had done through the entire process, complying, and I holstered my, my handcuffs on the load bearing vest are right below my lapel mic for a reason, it's the closest thing to me. I, I took out my handcuffs from that. Placed her in handcuffs and told her that I was going to put her in the back of a car for her safety and, and I would get with her in a couple minutes. I get her in the back of whatever car is, is there near me or sorry, I, I, I forgot, I forgot to, to tell something important there. Uh, while either, while she's going to the ground or while I'm putting handcuffs on the ground, I vividly remember her saying something about he still has his gun. I don't remember his exact, her exact words of that. She said something to the effect of the driver being in possession of a gun. I know Officer Simpson pretty well. Uh, he was there with me through, him and his wife both were there with us through the birth of my daughter. Through the hospitalization of my daughter immediately after us being allowed to go home and I've been there with him through the birth of his daughter. I see him at the driver's side of the vehicle and I think I've escaped being killed here, now he's gonna kill him and I'm gonna have to answer to that to his wife. I'm gonna have to make that call that nobody ever wants to make to, to one of their fellow officer's spouse. But at the same time there's so much else going on. Tons of people are showing up on scene. So the best thing I can do and I have her in my custody at that point, the best thing I can do is just vocalize it. I don't remember exact words, but it was to the effect of, of Mike there's still a gun in the car or there might still be a gun in the car. I get her in a patrol car. other units are showing up like crazy at this point and there's a, there's a large crowd gathering towards the front of the barber shop and I see this SUV, I don't remember what color or what kind it was, has come into the parking lot not right up in the middle of the core of the crime scene, but near everything that's happening. In front of this crowd that is steadily walking around cars near the barber shop with, getting closer and closer and I see a, a white male in a hoodie. I just remember he had a hoodie on or a sweatshirt. And I'm, I'm almost positive it was a hoodie and a, a ball cap, walking up towards me and immediately I, I don't know what he's doing. I've been on numerous crime scenes at this department. It's a large department, so it's not past me not knowing this guy, but I've seen the face of about everybody at least. I would know he, he was with our department and, and I didn't know him. I thank God he, he, he immediately said he was an off duty officer. At that point I think he saw not necessarily confusion or fear, but a very fast thought process start moving again in, in, in my head while I'm looking at him trying to assess what now. Like we're taught in the academy. Now what? He tells me he's, he's, he's a police officer. He told me the agency, I think,

but I don't remember what it was. And he said, what can I do? And as other officers from our agency are coming up and he's there I just told them get, get those people back. I, I didn't want even more confusion as people continue to show up. I've responded to an officer involved shooting before. It's chaos for the first few minutes while everything gets set up the proper way. It, there's a lot of people that respond and, and I don't want the confusion of people being up in the crime scene that, that weren't involved at all ended up in, being up, ending up being detained for no reason. I don't, I don't want any of the hundreds of possibilities to even take place if we can just keep them back. They take care of that. I don't remember if I'm told to sit down. I bel, I believe, almost positive uh, I, I spent all day thinking about this yesterday, who it was and they, they grabs me by the vest and says, are you okay. And at that point I didn't know if I was okay. The pain's there. My adrenaline, I can feel my heart absolutely beating out of my chest. I've been in car chases at crazy speeds. I've been in foot chases. I've been in uses of force that were intense. Never in my life have I felt my heart beating that hard. I'm almost positive it was, it was Stange that told me, just sit down. and that's when I, I start trying to walk towards the rear of a patrol car to put my, to put my weight up against it and try to slide down and just sit on the pavement. At that point I'm so out of breath. I'm so, everything's just going through the roof on me and I realize when I take a step there's, there's something wrong with my leg that, that, that wasn't just a pain that went away. There's something going on here. And every time I put weight on it and go to lift up, it's almost as I'm about to fall over. Uh, it, it hurts and it hurts severely. So I make it towards the rear of a patrol car and I put my weight against it and just slide down. I don't remember if I sat all the way on the pavement or if I slid down to where my left leg was under me to support my weight. But what I knew is I absolutely had to take the weight off my right knee because it hurt so bad I could not handle it. Um, at some point I remember being in the front seat of a patrol car with the door open and of course, people are coming up saying are you okay and I said, I, I, I think I hurt my leg. It's not, I remember telling someone I'm, I'm sure it's just sprained or something, worry about them. You worry about them. I'm, I'm, I'm here. I'll, I'll be okay. There's still other officers that might be in the fight, worry about them. And at that moment I hear a sir again, right behind me. And I turn and I realize I'm in the front seat of the patrol car that I put the passenger from the stolen vehicle in. And I don't remember what she's asking me. I remember her saying sir and I turned my head and I just said, I can't talk to you right now. I'm sorry, but I, I can't talk to you right now. And I got out of that patrol car. I didn't want to hear

anything that might alter an investigation. I didn't, I, at that point I. I wanted to separate myself. I knew there was enough people there at that point I, I was gonna be okay. But I didn't want anything being handled wrong at that point. So I separated myself from that patrol car and I don't remember if the civilian grab, or not civilian, I keep saying civilian, if the off duty officer from another agency grabbed me or one of our officers grabbed me, but next thing I remember is I'm sitting in the front seat of his car. And a very good friend of mine from the academy that lived just down the road from where I when, where I used to live, is standing near that car with me. Uh, I see my Lieutenant show up on scene. My Sergeant and our other Sergeant are in training, I believe that day, uh Friday. I think they had in service last week or something. So I knew they weren't there. I see my Lieutenant uh, and he asked me if I'm okay. I told him, you know, my legs hurt. Uh, but, but I'll be okay.

McCAULEY:

You said you were in the, this off duty police officer's –

STARKS:

POV.

McCAULEY:

Okay.

STARKS:

In the front seat. Uh, with, with my leg hanging out because it, it even hurts to bend it at this point. So, so I'm swung around just sitting on the side of the seat, the passenger's seat.

McCAULEY:

Well, who's your Lieutenant?

STARKS:

Lieutenant uh, Jackson, Dana Jackson.

McCAULEY:

So, he got on scene and you were in the –

STARKS:

And -

McCAULEY:

POV-

STARKS:

In the, in the POV. I remember talking to him while I'm sitting in the POV. He may have gotten there before, I don't know. But I remember speaking to him. Seeing him and speaking to him while I'm sitting in the passenger's seat of the, of the off duty officer's POV. And uh, I told him sir, I, I fired. Now this is in a very hectic manner that I'm saying this because I'm, I remember hyperventilating like I'd never hyperventilate, like I, I was trying to catch my breath like I've never tried to catch my breath before.

Uh, I can, I can still feel my heart beating out of my chest. My

hands feel like they're completely, there's a, there's a feeling that everybody understands like when you're leg or your foot goes to sleep and as you start to regain feeling in it, it gets this intense tingling and I, I remember both my hands being in, just intensely tingling. Uh, almost lost a, loss of feeling in it, but like, like I had lost circulation and they just and what we call, just gone to sleep. You know? And uh, sorry. I told Lieutenant Jackson I'd fired and I asked who do I give my weapon to. Uh, uh, uh, do I give it to uh, Officer Williamson since he's standing right here and more than likely I'm going to end up having him as my companion officer and he can get it to whoever it needs to go to. Do I give it to him since he's my direct supervisor? There's already people from DO showing up. Do I wait and them come get it? I didn't, I didn't know who to give it to.

McCAULEY:

Who took it?

STARKS:

Uh, Lieutenant Jackson did. Lieutenant Jackson took it. Uh, I remember him, he's, he told me to give, give him my firearm. I unholstered it, uh, took it by the, the, the slide and handed it to him. At that moment as I'm handing it to him it hadn't dawned on me that the slide is not locked back, which tells me I didn't fire all my rounds. It's still in the forward position. I hand it to him and I told him there are still rounds in there. He took it. He asked me, he said do you have a companion officer or is there someone I need to call? Uh, Williamson's standing right there.

McCAULEY:

And can, for the record you need to say his first name?

STARKS:

Wade.

McCAULEY:

So it's Officer Wade Williamson?

STARKS:

Yeah. Wade's and, and I just call him Wade most of the time. He and I are really good friends. Uh, Wade's standing right there next to me and uh, and I've always said that should I be in an officer involved shooting, I'm gonna use uh, I would, I would use someone else. A, a different officer. Uh, not, not Wade, but a, a another very close friend of mine that works here um, that has been through all of this stuff the past few years we've been, my wife and I have been through as a companion officer cause he knows me. He's in a class that day too. I know he's in a class that day. So that's why I asked Wade. I said, I, I just asked him, I said Wade will you do it? If not, it's okay. We can call somebody. He absolutely agree to do it. MEMS shows up. They start asking about my leg and when they start pushing it and doing their thing, I

realize that this hurts. It hurt so bad. But at the same time being on scene of an officer involved shooting before, but not when it happened but responding to it, helping work the crime scene and having to do the crime log, all that stuff that you do as a patrol officer on scene, I knew the amount of cameras, media, everything, the crowd that would keep getting bigger, it's about to show up. I kinda in a thing of I don't wanna say like trying be tough cause I'm not at that point. I know my right leg's useless. I asked the MEMS guy if I had to get on the, I, I told him, I said I think it's sprained or something, it hurts. I know it hurts. I wanna go to Baptist Hospital. Do I have to get on that cot? Can you, can I just get you all to help me to the ambulance and I'll sit on the back of the ambulance and let you take me. Well, they told me no. They said, you, you don't need to walk on this. You need to get on here. I got on there, they wheeled me to the ambulance. Wade got on the ambulance with me. um, as I'm being wheeled to the ambulance it dawns on me that uh, I don't, I don't carry my phone in my load bearing vest because of just the way the pockets are it could fall out easily and should, you know, I be in a foot pursuit or anything really, I don't wanna lose my phone. So I keep it while I'm driving in the patrol car there's a little slot in these Explorers where the printer paper comes out and so I just keep my phone plugged in to the charger sitting right there. So if I need to grab it, call somebody whenever, I can just grab it without taking my attention off of what I'm doing. and I remember telling somebody, I don't know who I told, uh, that that's my car and my, my phone is on top of the printer. So someone could get a hold of my wife right then.

McCAULEY:

Did they go get your phone?

STARKS:

Yeah, they got my phone.

McCAULEY:

Do you know who that was?

STARKS:

I don't know. I have no idea.

McCAULEY:

Was is it a police officer?

STARKS:

Yes. Yes. I have, I have no idea who it was.

McCAULEY:

So they gave you your phone?

STARKS:

Yeah. Gave me my phone. Um, in fact I know Wade got it at, at somewhat, early on of me being in the back of the ambulance Wade had my phone and he uh, he told me he was contacting my

wife. He was gonna let her know that something had happened. I had been involved in something serious. I was hurt, but I would be okay. We were, my whole family is, was in the process of recovering from the flu last week. The last thing I wanted her to do is bring our small child, our sixteen month old child, to an emergency room full of sick people. I knew there'd be someone at the hospital that could drive me home later in the day. So I, so he told her just, just stay home. I'll keep you updated. If something changes and you need to be there, I'll let you know.

McCAULEY:

MEMS transported you?

STARKS:

Yes, to Baptist.

McCAULEY:

To Baptist?

STARKS:

Yes, sir. Can I put this up?

McCAULEY:

Absolutely. Um, Charles –

STARKS:

Yes, sir.

McCAULEY:

You all (inaudible)? I'll let you get situated.

STARKS:

It's just, that's, that's much better. Thank you so much. Okay.

McCAULEY:

So we kinda talked about the bird's eye. I wanna go back and talk about a few things with you. First of all, um, I printed out um, this

is a -

STARKS:

Yes, sir. Yes, sir.

McCAULEY:

12th and Rodney Parham.

STARKS:

Yes, sir.

McCAULEY:

Um, can you kinda point out to me where exactly what parking lot

you were in?

STARKS:

Uh, do you want me -

McCAULEY:

So this is 12th Street -

STARKS:

To write on this? Draw on it?

McCAULEY:

Not necessarily.

Okay.

McCAULEY:

We just wanna -

STARKS:

I came from West Park, which is just off of uh, your map to the east. I was traveling west on 12th, saw vehicles backed up here at the light facing westbound. Came around them into this entryway in front of the uh, detail shop and came in this direction right here.

The vehicle -

McCAULEY:

And I know these, the vehicles that are captured here are not the –

STARKS:

Yes.

McCAULEY:

The -

STARKS:

Correct.

McCAULEY:

Actual vehicles.

STARKS:

Correct, correct.

McCAULEY:

But you can kinda point or –

STARKS:

I specifically –

McCAULEY:

If you wanna put an actual, if you wanna put an X kinda where –

STARKS:

Okay.

McCAULEY:

You saw the car.

STARKS:

Okay. I specifically –

McCAULEY:

Backed in.

STARKS:

Okay. I specifically remember there being a large white SUV. I would say in the front quarter of, of all the parking spaces and that black vehicle being further but towards the back. Not in the very back, but further towards the back of, of these parking spaces. I

don't know which exact parking space -

McCAULEY:

Oh, no that's -

STARKS:

It was.

22. cd McCAULEY:

Fine. Can you just kinda circle or X or something -

STARKS:

Just the -

McCAULEY:

About where -

STARKS:

Area?

McCAULEY:

Where you think it was.

STARKS:

Okay. Is this, I'm asking this to you as it's gonna come back to me

saying I know for a fact that he was parked there?

**NEWCOMB:** 

Well, I think it's a -

McCAULEY:

Here's a, here's a more blown up photo of the actual parking lot. I'm just looking for a approximate. I know that you probably didn't count the parking spaces and know which parking

space it was in.

STARKS:

Uh, huh.

McCAULEY:

You might, but that -

STARKS:

I don't know.

McCAULEY:

Being said –

STARKS:

No.

McCAULEY:

I'm, I'm just more than anything I'm just wanting to specify that

this, not necessarily that you have to, to recreate –

STARKS:

Uh, huh.

McCAULEY:

But that you can just kinda point and show me in the vicinity of

where you were at.

**NEWCOMB:** 

Why don't we have the record reflect that this is his best estimate

after everything that's gone on. So you're not saying for certain that was where it was located, but it's just the best guess or

estimate -

STARKS:

Okay.

23

**NEWCOMB:** 

You can make today.

McCAULEY:

Yeah, but this is, more than anything, this is the parking lot that

we're talking about.

STARKS:

It absolutely is the parking lot -

McCAULEY:

Okay.

STARKS:

In question and these are the parking spaces that he was backed

into against that building.

**NEWCOMB:** 

Why don't we -

STARKS:

Yes.

NEWCOMB:

If I may suggest –

McCAULEY:

Sure.

NEWCOMB:

That we write uh, maybe in the lower right hand corner a 1 to

indicate this is the photograph he was saying that this absolutely is

the parking lot that, where there's no confusion.

McCAULEY:

Absolutely.

STARKS:

Okay.

McCAULEY:

So, Mr. Newcomb just for the record. You said that you just want

it written as -

**NEWCOMB:** 

Here, I, what I'm talking about is just where we put a 1 –

McCAULEY:

That's fine.

NEWCOMB:

On and I put a 1 and circled it just to identify the picture that we're

referring to -

McCAULEY:

Sure.

NEWCOMB:

Where there's no confusion since we, in the earlier one why don't,

I know this is backwards, I'm gonna put a 2 on it, which is a

broader area view that you were first talking about. Now we've -

STARKS:

Yes.

NEWCOMB:

Moved -

McCAULEY:

Okay.

**NEWCOMB:** 

To photograph number one and I'll be quiet.

McCAULEY:

No, you're fine.

STARKS:

Okay. Okay.

McCAULEY:

Absolutely fine.

STARKS:

So, so with that I, I, I would say I, I know for a fact that he was

further towards the south end of the lot.

McCAULEY:

Okay.

STARKS:

Uh, uh, I don't -

McCAULEY:

And -

STARKS:

I don't know which parking spot he was backed into. I remember

uh, it being further towards the south end of the lot though.

McCAULEY:

Okay. So, when you drove into the parking lot you, you park and

you, you had stated that you had parked kinda in front of him, but

only maybe half of his vehicle. Is that what you said?

STARKS:

Yeah, covering may, maybe half uh, maybe half of, of the front of

the vehicle with the -

McCAULEY:

So when you exited –

STARKS:

With my patrol car.

McCAULEY:

When you exited your vehicle which direction did you go?

STARKS:

Immediately around the door uh, door comes open, I get out, come around the door, shut the door and I immediately cross in front of the vehicle to immediately go, I mean, because uh, like, like I said about the passenger, I noticed immediate compliance to her, with,

with her.

McCAULEY:

When you got around to the side of the vehicle that you're at, was

that the driver's side?

Yes.

McCAULEY:

How close to the vehicle were you? I know you had mentioned

that you had kinda bladed your chest to the door.

STARKS:

Yes, squared it in order to have absolute coverage of my vest of, of, of vital areas. Uh, honestly I was closer to the door than I, than I should have been and then I've trained to been. More in a, more in an effort to avoid him quickly throwing the door open on me and taking off. Uh, because I want him to show me his hands and exit the vehicle as I tell him to. if I'm close enough to the door that I can grab the door as he's pulling the door handle, I, I can assit, not necessarily assist him in that, but ensure that this door isn't gappe as flying into me and he's telving off

isn't gonna go flying into me and he's taking off.

McCAULEY:

So, you, were you closer to the front windshield versus the, the

rear driver's side door?

STARKS:

I believe I was square on with him. On, on his driver's door.

McCAULEY:

Okay.

STARKS:

I, um –

McCAULEY:

So you were –

STARKS:

I -

McCAULEY:

Looking down. Were you looking through the windshield or

through the driver's window?

STARKS:

I'm looking through the driver's window at, at the beginning when I'm giving him the initial commands to show me his hands and get

out.

McCAULEY:

When you first made contact was the win, you, you had mentioned at some point the window came down, but was, was it down at that

point?

STARKS:

I don't know.

McCAULEY:

Okay. Were you talking to him through a, a closed window?

STARKS:

There's, uh, I don't, I, I don't know. And uh, I know I was giving very loud clear instructions on what I wanted him to do and I, I

know it was being received on the inside of the car because the female was compliant immediately and through the entire thing.

McCAULEY:

What um -

STARKS:

And she was further away from me than he was.

McCAULEY:

Are you, just for the record, are you right handed or left handed?

STARKS:

Right.

McCAULEY:

And you say that your gun, previously you had stated that your gun

was drawn?

STARKS:

As I, as I got out of the vehicle to perform a felony a, a, a felony

takedown on a stolen vehicle, absolutely I, I get out with them at

gunpoint.

McCAULEY:

Was that your city issued firearm?

STARKS:

Yes.

McCAULEY:

What kind of gun is that?

STARKS:

It's a Glock 22.40 cal.

McCAULEY:

Okay. Um, do you carry a backup?

STARKS:

No.

McCAULEY:

Okay. So that was the only firearm on your person?

STARKS:

Absolutely.

McCAULEY:

Okay. So you approached the vehicle, when you approach the

vehicle you stated previously that your gun was out.

STARKS:

Yes.

McCAULEY:

Okay. So, so this is where I really wanna get specific. You're

giving him commands. Please correct me if I'm wrong.

STARKS:

Yes, sir.

McCAULEY:

I'm just gonna try to repeat basically where we are to this point

from your previous statement.

Yes, sir.

McCAULEY:

How long had the contact been when you saw him put the car into

gear?

STARKS:

I don't wanna guess.

McCAULEY:

And I don't want you to –

STARKS:

And, and it wasn't -

McCAULEY:

Assume anything.

STARKS:

A matter of that like I was counting seconds or anything, but it,

it's, it's a matter of, of, of, of seconds.

McCAULEY:

So, was the car in park?

STARKS:

I, I'm absolutely positive that that car was in park because I, I

remember seeing his hand on the shifter moving down.

McCAULEY:

Okay. So it moved down. Did the, did the vehicle start rolling at

this point? Did it start moving at this point?

STARKS:

I don't, I don't think so. I'm, I'm almost positive that as, as you know, obviously his foot has to be on the brake to put it in gear. That it's stationary for a, for a brief moment there before, after his

hand comes off I start backing away.

McCAULEY:

You said that at that point he said, you're gonna have to shoot me

or something to that point?

STARKS:

I, I don't want it to say that that was the exact quote, but I vividly remember him using very aggressive language with it in which it was just fucking shoot me or you're going to have to fucking shoot me. it, it wasn't some, the manner in which he said it you could tell it wasn't out of him saying as if you, as if I would say please don't shoot me or I'll do what you're saying. Just, just don't shoot

me. It was you're going to have to kill me.

McCAULEY:

So you're backing up. You said that at what point in that, that

exchange did, did the car actually hit you?

STARKS:

As I'm backing away it begins to start roll, as I'm backing away I see the tires are turned and it starts, it, it comes forward and, and

bumps me, bumps, I remember it hitting the left side first and, and it wasn't that it hit it incredibly hard or like a, like I said a violent acceleration, but it hit it and at that point I knew he, that wasn't a mistake. He's, his full intent is to get out of here.

McCAULEY:

So the vehicle struck your left leg.

STARKS:

At the very –

McCAULEY:

Or-

STARKS:

Beginning.

McCAULEY:

Or at least made contact with you.

STARKS:

It made, I wouldn't say struck because it, it was, you know, but, but yes it made contact with my, with my left side, my left leg at, at, at the beginning.

McCAULEY:

Where was your right leg at that point?

STARKS:

I don't know. I would, I would, I would say it would be safe to assume since I'm stepping back to the south, like I said the southwest, more, more west at that point than south. Uh, that, that it was moving uh, behind or to take, to take another step.

McCAULEY:

So-

STARKS:

Is what I would assume.

McCAULEY:

When you first felt the pain in your, in your right leg were you still to the side, the driver's side of the car?

STARKS:

I don't know.

McCAULEY:

When was it that you felt that pain? Do you, do you recall -

STARKS:

I remember –

McCAULEY:

Where you were at in –

STARKS:

I -

McCAULEY:

In correlation with his vehicle?

It would have to be in, it would absolutely have to be somewhere between the front driver's side tire to the front bumper. Just a, not the entire bumper. Like I'm in the middle of the car or anything, but just that front corner. Because I, I had not had time to, to make movement enough to get all the way in front of the car or all the way away from his car and behind my car. I, I, that pain hit me when, when his car hit me, my knee just the right way. Uh, and—

McCAULEY:

Was that before or after it made contact with your left leg?

STARKS:

After.

McCAULEY:

So, it made contact with your left leg.

STARKS:

Made, made contact with my right, immediate pain, gunfire.

McCAULEY:

Okay. So, when, when you felt the pain in your leg that is when

you shot.

STARKS:

Yes. Because when I felt the pain in my leg, I, I absolutely knew

that I was not going to be able to, to retreat safely on this.

McCAULEY:

I guess this is what I'm not understanding. I understand where your right leg was when the car made contact with your right, right

leg.

STARKS:

I, I can't pinpoint the exact location on the vehicle that, that struck my right leg. I, I know it hit my right leg. There was that sharp pain, continuation of that sharp pain, an immediate weakness in that leg that lead me to believe that I, I'm about to go, I'm about to

go down and get run over.

McCAULEY:

What was your backdrop at this point?

STARKS:

Uh, the wall of this uh, detail shop. The, the outer wall of the

detail shop that's on the uh, east side of the building.

McCAULEY:

Could you have gotten out of the way of this car?

STARKS:

No. Not in the manner, not in the, the amount of time I had. I, I

had, no.

McCAULEY:

Why did you go from the driver's side of that car to the front of

that car?

I know my patrol car is parked, like I said, relatively close to halfway across the front of the car. If he's coming up with a firearm, if he's coming up with a firearm or with the intent of roll, running me over, my goal was retreating back while having him at gunpoint, retreating back around the front of my car and being behind my patrol vehicle. They teach us in the academy and over and over and over that the, the most secure place if you're having to use your, a, a vehicle for cover find a way to be behind that engine block. There's not a lot that's gonna penetrate that. My goal is to be back and, and around the front of this, this car. So I have cover from one, run over. Two, if he comes up with a gun and, and I'm not, I'm not sure on how far forward we were at that point. I, I don't know. When I say how far forward, I guess I should say how far west or how close I was to my patrol unit at that point.

McCAULEY:

So in the moment that that car it begins rolling, in your head the

best course of action is to get in front of that car?

STARKS:

To get in front of –

McCAULEY:

From the side of the car to the front. Let me ask you this. Let me ask you this. Were, were you on the side of the car or were you on the front of the car when you started shooting?

STARKS:

There is a possibility that I was at the front what I would call a corner. It's not a corner. But from the quarter panel to where it goes from the quarter panel to the bumper. But like I said, when it hit my knee and I felt that pain I don't know my exact location. I know I had a definitive clear view of him through the windshield. Going through the passenger's side was absolutely not an option. It would be a, it, it, there's no way I could have gone that route. It was through the windshield. I had a clear view of him through the windshield from where I was. That's what I remember. My exact location on that vehicle, I don't.

McCAULEY:

And correct me if I'm wrong. But your intent was to cross over the front of this car while you were afraid that it was gonna try to run you over to get back to your car for cover?

STARKS:

If he has a firearm I'm have nowhere to go here. Nowhere. I have absolutely nowhere to go. While yes I'm absolutely terrified of being run over by a car, I don't wanna get shot either. My car provides me cover for both. I mean, I don't, I don't -

McCAULEY:

Did you ever, did you see a gun?

No.

McCAULEY:

When you first went into that parking lot where was, did, do you recall, do you remember with the radio traffic where, where the nearest unit was to you? Did you even, were you even aware if a backup unit was coming to you?

STARKS:

So I knew when Officer Tyler backed towards the beginning of all this on, on Northwest P Common he told the SID officer I'm wrapping up helping another officer on an accident up on Cantrell. I knew where that accident was because not a long time before that she had called me and asked if I could swing by and drop off my ticket book to her. Her printer wasn't working. She didn't have her ticket book.

McCAULEY:

Is there a particular reason why you entered that parking lot without waiting on your backup?

STARKS:

I, so this car is, when he tells me it's backed into a parking spot, it's stationary. It's raining. I know from what Officer Tyler had said that it was gonna be a minute even if he was in route. He's coming from Cantrell and Miss or Cantrell and University in the rain. It wasn't pouring, but in the rain on wet pavement. He would be coming down University or to Cantrell and Mississippi and all the way down. That, that's not a close jog even, even, even if you're moving. Even if you're traveling at a decently high rate of speed. Uh, that, that's not close. And with it raining, with it, where this car is backed in as I come around the corner it automatically dawns on me that if I just pull my car in front of him, this is over with. There's no, there's, there's nothing else that that can take place from this because there's not gonna be a pursuit if, if, if I'm able to block his car in. I get him in custody. It's, it's right there. It's done.

McCAULEY:

In the context of this -

STARKS:

If, if I -

McCAULEY:

This stop –

STARKS:

Wait, if, sorry, sorry.

McCAULEY:

I see, I see what you're saying there.

STARKS:

Okay.

McCAULEY:

That being said, my question was you entered the parking lot. You

thought that would end the, the, the chance of a pursuit.

STARKS:

Absolutely.

McCAULEY:

Okay. So, do you know how many units were coming to you?

STARKS:

No. I knew as soon as I keyed up on main channel and said I was out at 12th and Rodney Parham with a stolen car, I don't know how many and I don't know who, but there were people coming and they're coming quick from wherever they are. If they're not tied

up on something, they're coming to me.

McCAULEY:

Can you describe the vehicle in detail for me?

STARKS:

It was a black new body style, what I call a new body style Nissan Sentra. The body style before this was more what I would call bubbly. A short, round at the top, this is just a little, a little bit more elongated than the, the tradition, what I think of as a, a

Nissan Sentra. It's a new body style Nissan Sentra.

McCAULEY:

How fast was that car moving when you were backing away from

it before the initial contact on your left leg?

STARKS:

I don't know. I don't know. Like I said, it wasn't a an, it wasn't a, just a hammer of the gas pedal, but it's moving fast enough that when it, when it hit me I, I absolutely knew if something didn't change the course of this action immediately I'm getting run over.

McCAULEY:

Do you know how many bullets you fired?

STARKS:

No idea. I know it had to have be less than uh, seventeen because

my, my slide wasn't locked back.

McCAULEY:

You mentioned at one point you saw uh, a bullet strike to the right

STARKS:

Left.

McCAULEY:

I'm sorry, uh, to the passenger's side windshield.

STARKS:

Yes.

McCAULEY:

Was that your shot?

STARKS: Yes, there was no other, there was no other gunfire that didn't

come from me and that was before the part that I can't remember.

So there's no way that that came from in the middle of that.

McCAULEY: Outside of your attorney, have you talked to anyone else about this

incident?

STARKS: No. My, my wife and that's, I mean, just, just, she knows that I

was uh, uh -

McCAULEY: Have you seen, uh –

No.

STARKS: With us.

STARKS:

McCAULEY:

McCAULEY: Have you seen the MVR footage of this incident?

STARKS: No. I, that's why I was requesting through him to be able to watch

That we, uh, other than what we haven't provided you?

it. Especially to fill in that void cause I don't know, I don't know

what happened.

McCAULEY: Aaron.

ONCKEN: Um, when they had put that broadcast out on the uh, stolen vehicle

what kind of description did they give on that car?

STARKS: Initially, initially uh, I'm actually glad you asked that. Initially he

said a black Nissan and gave the tag number. Immediately I thought, well there's fifteen different types of Nissan's. Are we talking about a truck, a van, a small sedan, a Maxima, a Sentra. You know? What are we talking about? And so, I know there are at least two other occasions while I'm in route to go try to intercept this vehicle that I said, give me a description of that car again. And, and at one point on there I even said, what kind of sedan? There are different sedans. And that was purely for the, the reason of I don't wanna misidentify a car. and it pull over or you know whatever, and I've got whoever a gunpoint doing a felony traffic stop on them on the side of 12<sup>th</sup> Street and it's not even a stolen

car.

ONCKEN: Uh, huh. Did they give uh, anything specific about the car? Like

besides your generic -

Black Nissan Sentra.

ONCKEN:

Yeah.

STARKS:

He gave the tag number. I don't, I don't remember.

ONCKEN:

Okay.

McCAULEY:

Did you know the passenger?

STARKS:

No.

McCAULEY:

Did you know the driver?

STARKS:

No.

McCAULEY:

You never had any kind of police contact with either one of them?

STARKS:

Not that I know of.

McCAULEY:

What about personal contact?

STARKS:

No.

ONCKEN:

When you come up to the uh, you've got him at gunpoint. I'm just gonna skip up to where we, you have him at gunpoint. You come around to the driver's side and um, what was the driver doing at

that point?

STARKS:

He, he's sitting there. Uh, and he's not, I know what he's not doing. he's not doing what I'm telling him to do and that's show me his hands and in a clear definitive way so I know you are absolutely just as the passenger, you are absolutely no threat to me. And then all I'm, I'm gonna do is have you get out of the vehicle so I can place you in handcuffs and this is over.

ONCKEN:

So I mean, he was just sitting there not doing anything or was he moving around or what was he -

STARKS:

I, I know he was moving –

ONCKEN:

Do you remember?

STARKS:

I knew he was moving around, but it wasn't anything where he's just like violently digging. You know? Or anything, but he's moving his hands around. He, he keeps, he'll respond to me in, in, in uncompliant fashion verbally and he says something to her. And then when the, you know, that's not necessarily all that unusual in the fact of you know, I'm, I'm performing a felony takedown on somebody. It's not all that unusual for, for a brief moment them not register what's going on and not, you know, not do what I'm telling them to. But normally there's a pretty quick

transition to okay.

McCAULEY:

Charles, I, I wanna revisit this. This is a deadly force incident.

STARKS:

Yes.

McCAULEY:

And we gotta ask these hard questions. Okay?

STARKS:

Yes.

McCAULEY:

And this is what I'm trying to wrap my mind around. You didn't see a gun, but yet you go from the side, the driver's side with an open parking lot to going into moving and positioning your body to the front of this vehicle trying, as you said, trying to go towards your patrol vehicle. I have a hard, because you didn't see a gun, I'm having a hard time understanding why breaking off to the east here wouldn't have been -

STARKS:

Just because I don't see a gun -

**NEWCOMB:** 

Excuse me a minute.

STARKS:

Doesn't mean -

**NEWCOMB:** 

You said the east and at -

STARKS:

South. South.

McCAULEY:

Sorry, the south. This would be towards the east, the east side of this building. Is that correct?

**NEWCOMB:** 

Yeah, that's a solid –

McCAULEY:

12<sup>th</sup>, 12<sup>th</sup> Street goes west.

**NEWCOMB:** 

Yeah.

McCAULEY:

So, this would be, so what I'm saying is you, you were on the, the southeast side of this parking lot.

36

Yes, yes sir.

McCAULEY:

You were on, you were bladed yourself against the side of, of this car. The driver's side and your course of action was to move from the side of that to the front of a rolling vehicle. And you said that you're concerned about this gun that you never saw. I'm not understanding why you would go to the front of this vehicle that was rolling. I don't understand that.

STARKS:

He's not complying right off the bat. His, his, his hand is already gone down near his right side where it is commonly known that, that firearms are kept in vehicles so they are readily accessible.

McCAULEY:

But you didn't see a, you didn't see a gun.

STARKS:

I did not. But absolutely my training tells me that, I'm trying to think of how to word this. My training tells me that just because I don't see one doesn't mean there isn't one. Officers get shot and killed, I'm not gonna say daily, but very often by guns that they don't see beforehand until it's too late. I know from knowing this area and this parking lot if he has a gun and I'm going that way, if my vest doesn't catch it I'm getting lit up.

McCAULEY:

And you pointed back towards the southeast?

STARKS:

Yes, uh, the south, the southeast. I'm, I'm gonna get shot if it, so with the chance of, of, of there being a gun in play I'm going behind my patrol car.

McCAULEY:

And you can't recall if you started shooting on the side or the front of this vehicle. Or can you?

STARKS:

The, the front, I don't know how to explain. The, the front side. You know what I'm saying? Like, I'm not –

McCAULEY:

I know you're not –

STARKS:

Way up here on the quarter panel close to the driver's door. But I don't know if I'm at the front corner of this car because it is turning towards me. The tire is turned towards me. So, naturally the angel of this vehicle is going to turn to —

McCAULEY:

So you're saying the tire was turned –

STARKS:

Towards me.

McCAULEY:

To the left.

STARKS:

Yes.

McCAULEY:

Is that what you're -

STARKS:

Yes.

McCAULEY:

Okay.

STARKS:

And so this vehicle is, is, is starting to roll and it's rolling towards me. So I don't know if I'm still on what would be considered the quarter panel of that car. It'd be the very front out of the quarter panel or if I'm dead on in front of the car when I start firing.

McCAULEY:

For, for the record I wanna say that I said the tires turned to the left

cause you had moved the paper to -

STARKS:

To the left.

McCAULEY:

The left.

STARKS:

Yes.

McCAULEY:

Okay.

STARKS:

Yes, yes.

McCAULEY:

I don't wanna put words in your mouth.

STARKS:

No, I, I totally understand.

McCAULEY:

Do you know where all your, well, you said your backdrop was

the, the building.

STARKS:

Yes.

McCAULEY:

You mentioned uh, the bullet strike to the right, well it would have

been the passenger's side of the windshield.

STARKS:

Yes.

McCAULEY:

What was your backdrop there?

STARKS:

I wasn't aiming for that at all. It, it was a rapid succession of rounds where my backdrop was this building. There was, there

were no windows, doors behind this vehicle. It's a rapid succession of rounds on my target. That round I don't know if was a squeeze of the trigger mid recoil or as I'm going back. I know it's at, I'm not going to say is the last round because I don't know that it was the last round. I know at the, at, to, at, like I said it's very rapid situation but it's at the end that I catch this hole over here and I have no idea how I went because I, I see all the holes on, what I would say on target here right in front of me. Nowhere near the passenger that's been giving me complete compliance from, from the get go.

McCAULEY:

So you, you stated in your, your previous statement here that

you were laying or on the hood of the car.

STARKS:

Not, not necessarily on it, over it.

McCAULEY:

Over it.

STARKS:

Over it.

McCAULEY:

So where were your legs? What were they doing?

STARKS:

In front of the vehicle, not out. Uh, I wasn't so far up it that my legs are up off, you know, like up behind me and everything. But in front of the, in, in front of the vehicle. Uh, I mean, if he can, in, in a manner that if I can't get up and out of the way there as he continues to accelerate and or I are

continues to accelerate, under I go.

McCAULEY:

When you came off that hood where, where were you?

STARKS:

I don't know. That's, that's where uh –

McCAULEY:

You don't know if you went off the left side of that hood or the

right side of that hood?

STARKS:

Oh, no, no. I, I, I know I didn't go off like roll all the way across it and come off on the passenger's side of the car. I mean, it wasn't anything like that. But I don't know if I was knocked down and back or if I was able to gain my footing and retreat back. I don't know. That's, that's where the, just the lapse of I, I don't know

what happened.

McCAULEY:

So you don't know –

STARKS:

(Inaudible).

McCAULEY:

You don't know what side of that vehicle you ended up on?

STARKS:

Just from, from where I was it, it would, I would think it would

have to be the driver's side, but I, I, I can't say that I absolutely

know that.

McCAULEY:

Aaron.

ONCKEN:

I don't have anything.

McCAULEY:

Lieutenant?

ALLEN:

The only thing that I have, this is Lieutenant Allen.

STARKS:

You described her hands, you were saying that her hands were up

in the air showing compliance.

on where his hands were. Can you be a little more descriptive? The audio doesn't necessarily pick up where his hands are.

You were showing descriptive –

McCAULEY: We're resuming the interview with uh, Charles Starks. Again, this

is in relation to 2019-22984 and the time is 1254. Um, Mr.

That, that's, that's putting me in, in the dan, in, in the line of being run over and killed. Not, not this car just driving straight. If it's driving straight, the whole passenger's side of it is just gonna collide with my patrol car and there we are. It's turning into me. that, that's what I'm trying to portray here when, when I was trying to explain

to you that I didn't, I wasn't trying to retreat and then just decided, you know what I'm gonna stand in front of this car. I'm, that, that's not what was happening there at all. It was I'm, I'm trying to get to a position of cover. This vehicle is moving towards, this vehicle's moving west and then southwest. It, it, and at some point, like I said, I don't know exactly where it was, but at some point in that motion of me going back to get to my cover and him going southwest with the vehicle moving forward, out paths crossed.
