On April 17, 2019, Camden Fairview School District (CFSD) received correspondence from the Arkansas Department of Education (ADE) confirming that CFSD is not required to participate in school choice under the Public School Choice Act of 2015 during the 2019-2020 school year. The purpose of this letter is to request that you comply with the directives of the ADE by denying school choice applications for students who reside in CFSD.

Regarding the school choice application of Logan Landry, it is my understanding from the application that Logan is a sibling of Brooklyn Landry. Because Brooklyn is attending via a school choice transfer application accepted by Smackover for the 2018-19 school year and approved by Judge Hickey in her January 17, 2019 order, CFSD does not object to Logan's enrollment pursuant to Ark. Code Ann. § 6-18-1904(c)(2), assuming Smackover has the capacity to accept Logan "without adding teachers, staff, or classrooms or exceeding the regulations and standards established by law."

I ask that you continue to notify CFSD of any school choice applications you receive from CFSD residents. Thank you very much for your attention to this matter.
