This Agent and Agent Bacile spoke with the owner David Bass on the sidewalk outside of Shotz, another club owned by Mr. Bass. This agent explained the issues I was continuing to see with persons congregating around the bar and not properly social distancing. Mr. Bass stated his capacity was at 45 percent already. This agent explained his capacity needed to be where he and his staff could control the flow of the patrons and if it was 45 percent, it still appeared directives weren't being followed. Mr. Bass stated he had closed the previous weekend and lost at least a thousand dollars in sales. This agent commented that he wasn't asked by this agent to be closed. Mr. Bass said if he lowered his capacity any lower than he might as well be closed that the situation was just ridiculous. Mr. Bass asked if he would be getting a violation and I stated he had already been given a warning for the same directive issues two weeks before. Mr. Bass was visibly upset with me and said he wasn't wanting another trip to Little Rock and the governor said they could do 66 percent. I commented if directives could be followed at 66 percent then it would be fine but that's not what I was seeing. After Agent Bacile and I walked away to check other establishments we noticed his security employees were following us around seeing if we were checking others. I believe this tactic was out of anger for the issues at Mr. Bass's businesses.
