Investigator Narrative

At 0505 hours I received a call from Kelly Hayes RN with Baptist Medical Center North Little Rock regarding a police-involved shooting death. The decedent was admitted on 6-23-21. I contacted Senior Deputy Coroner Josh Hollis and responded to the hospital.

Upon arrival to the emergency department, I was directed to bed 16 where the decedent was viewed by this office and identified by the nursing staff. I was met by Special Agent Christiana McKibben with the Arkansas State Police. Special Agent McKibben advised that she didn't have much information on what happened at the scene since she was sent to the hospital. Special Agent McKibben did inform that she got some information from a deputy with the Lonoke County Sheriff's Office. She advised that a Sergeant with the Lonoke County Sheriff's Office conducted a traffic stop on State Highway 89 and Tower Loop Road when the decedent got out of the vehicle and "got something out of the back" and started coming towards the Sergeant, that is when the Sergeant fired his weapon. S.A McKibben informed me that she did not know if the decedent was the driver or a passenger in the vehicle and she was unsure where the decedent "got something out of the back".

With the help of S.A McKibben, the decedent was placed in a yellow body bag and transported to the Pulaski County Morgue to await transport to the Arkansas Medical Examiners Office. Decedent placed in cooler 1 with tag number #048404.

An empty brown wallet was retained by this office and placed in locker 2.


