DOWNTOWN DEVELOPMENT - TO STIMULATE AND ENCOURAGE THE MODERNIZATION AND DEVELOPMENT OF THE CENTRAL BUSINESS DISTRICT OF THE CITY OF LITTLE ROCK, AR IN ORDER TO PREVENT URBAN BLIGHT AND DECAY, REDUCE UNSAFE AND UNSANITARY CONDITIONS FOR THE BENEFIT OF THE GENERAL PUBLIC. THE COMPANY CREATED A MAIN STREET REVITALIZATION COMMITTEE TO ASSIST WITH "TURNING THE CORNER ON MAIN STREET". THE COMMITTEE PARTNERED WITH THE CITY OF LITTLE ROCK IN THE REVITALIZATION EFFORTS.
