Since our telephone call this morning, I met with Mr. Betton and Mr. Hogan – the two lawyers on my staff who have been involved with Chief Humphrey. I also spoke with Bill Mann this morning – he is in St. Louis at the moment. Later, Mr. Betton, Mr. Hogan, John Wilkerson of AMLDP and Mark Hayes, the Executive Director of AML, discussed the situation we know about since Mr. Laux's email to the federal court.

This office believes that it would be inappropriate at this time for anyone directly from the City to discuss this recent development with Chief Humphrey, Mr. Laux, or any attorneys hired by AMLDP in associated cases. If the situation changes, we will be in touch.

Not to discuss the issue includes any telephone conversations with parties or attorneys. If a discussion is requested, then attorneys of record in the litigation should contact AMLDP so the discussion can be set up in a manner that protects the best interests of the City, and all City personnel.
