Medical request made on dates at jail (Hamilton County) 4/8/22, 4/14/22, 4/15/22, 5/4/22, 7/7/22, 9/19/22, 10/31/22, 10/5/22, 11/8/22, 11/19/22, 10/14/22, 10/18/22, 10/28/22, 11/8/22, 11/5/22, 10/28/22, 11/2/22, 11/3/22, 11/4/22, 12/5/22, 12/11/22. W/O any results. Request also made to Nurse Watkins, Nurse Rowe, Nurse Watkins, Nurse Linda, and all other's EtAl. Name's unknown at current time. Grievances on 12/7/22, 12/6/22, 12/5/22, 12/25/22, 11/22/22, 11/18/22, 10/24/22, 10/21/22, 8/19/22. And many many more filed but due to Facility hiding the # on kiosk I'm currently unable to copy.

10/2021 CANT recall exact day medical request made To Medical STAFF to my recollection Nurse Rowe About my Stomach pain, and possible cancer pending observation by specialist, And Nurse Linda And also two MRI'S released pertaining specifically to my stomach pain And possible cancer Approximately 2-3 release's of my signature OF MRI for possible cancer pending specialist diagnosis. From Erlanger, And Stomach pain MRI from "PackRidge Memorial". Nothing ever resulted and in pain still to date AS OF Oct 1/2021 I have not ever been given anything for pain or Any other of my multiple medical condition's.

10/2021 SAME request's made to Nurse WATKIN'S AND Nothing ever done for my medical condition's.

10/2021 Request pertaining specifically to medical condition's, and staff made x2-3 to "Sheriff Jim HAMMOND'S" And I never got A response from "HAMMOND'S". HAMMOND'S know's knowledge of my request and medical condition's but has not addressed it to his staff, Administration etc.

CO/Bell, AND RO COX has harassed plaintiff due to grievance's filed against STAFF AND several specifically filed Against Bell.

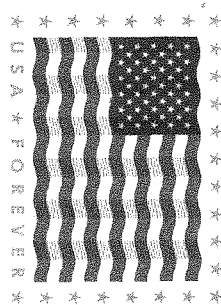
