
AFFIDAVIT OF COMPLAINT In the General Sessions Court of Hamilton State of Tennessee vs. GREENE, HAROLD R

The undersigned affiant, after being duly sworn according to the law, GREENE, HAROLD R whose name is otherwise unknown to the affiant, committed the offense of KIDNAPPING in the above county at (Location) 3410 AMNICOLA HWY on or about 1/23/2023 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

ON 01/24/2023 AT 03:01 HOURS, INV. MCCLARD (#961) WAS NOTIFIED OF A RED 1995 GMC SIERRA C1500 (526BKRL TN, VIN1GTEC14Z9S2503911, NIC V554703569, #23-008026) BEING LOCATED AT 1227 E MAIN ST., CHATTANOOGA, TN 37404. THIS GMC WAS STOLEN IN THE AREA OF 860 I-75 NORTHBOUND NEAR WHERE THE DEFENDANT IN THIS AUTO THEFT/KIDNAPPING WAS LAST TRACKED BY CHATTANOOGA POLICE K9 UNIT ON THE SAME DATE AND SAME TIME FRAME. 
AFFIDAVIT OF COMPLAINT In the General Sessions Court of Hamilton State of Tennessee vs. GREENE, HAROLD R

The undersigned affiant, after being duly sworn according to the law, GREENE, HAROLD R whose name is otherwise unknown to the affiant, committed the offense of KIDNAPPING in the above county at (Location) 3410 AMNICOLA HWY on or about 1/23/2023. Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

EP AT THE WHEEL CAUSING HIM TO REAR-END A VEHICLE ON I-75 (23-007970). AFTER WAKING UP TO THE WRECK HE FLED THE SCENE ON FOOT. HE STATED HE EXITED THE WOODS ONTO OLD LEE HWY BUT DID NOT RECOGNIZE WHERE HE WAS EXACTLY. HE STATED HE WAS WALKING AND CAME UPON A "TRAILER PARK" AND BELIEVED HE WOULD BE ABLE TO STEAL A VEHICLE THERE. 


