The undersigned affiant, after being duly sworn according to the law, state that FUSILIER, JALEN whose name is otherwise unknown to the affiant, committed the offense of CRIMINAL HOMICIDE in the above county on or about 3/25/2023

Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his / her information is believable concerning said facts are as follows:

On 03/25/2023 at approximately 1856 hours, Chattanooga Police were dispatched to 2431 Williams St. on a Person Shot. Upon arrival patrol units locate two parties suffering from apparent guns hot wounds. Patrol units rendered aid until medical personnel arrived. Patrol units then secured the crime scene and contacted Violent Crimes Bureau.

On 03/25/2023 at approximately 1940 hours, I, Detective Wilkerson #1071 and Detective Slaughter #1019 arrived on scene. At that time, Detectives conducted an initial walk through of the crime scene and were able to locate video footage. In the video footage, Detectives were able to observe two male parties arrive on the third floor and walk to the door of room 319. Once both parties are at the door of room 319, one party remains in camera view during the shooting and appears to be standing in the doorway interacting with other parties. The SUSPECT, later identified as JALEN FUSILIER, entered the room and exits the camera view as shots were fired. As shots were fired, Detectives are able to observe approximately four to five people running out of room 319 away from the gunfire. Detectives are then able to see the SUSPECT flee the room and go to the elevator hallway. Ashort time later, the SUSPECT is observed getting off of the elevator on the first floor, exiting the hotel building, and entering a blue company van before fleeing the scene. Detectives then spoke with witnesses who stated that the SUSPECT entered room 319 upset about his wallet being missing. Witnesses stated that the SUSPECT believed parties in room 319 stole the wallet, and that he immediately entered the room making statements about the wallet. Witnesses stated that it appeared the SUSPECT was not acting normal and began being hostile towards parties in the room. Witnesses stated to Detectives that once the SUSPECT was in the room, he pulled out a firearm and began shooting.

While on scene, Detectives learned that the SUSPECT called police in Giles County and wished to turn himself in. Police in Giles County then made contact with JALEN FUSILIER and observed the SUSPECT in a blue van matching the suspect vehicle description. FUSILIER stated to Giles County Police that he shot a party in Chattanooga, TN in self-defense. Giles County Police then detained FUSILIER and recovered a firearm from his persons. Chattanooga Detectives subsequently responded to Pulaski Police Department in Giles County, TN and interviewed FUSILIER. FUSILIER stated that the incident began over his missing wallet. FUSILIER advised after noticing his wallet was missing, he went to room 319 to confront the parties he believed stole his wallet. FUSILIER advised once he was in room 319, a male party pulled out a firearm and "racked" the firearm towards FUSILIER. FUSILIER stated that at that time he was fearful that the male was going to shoot him, so FUSILIER pulled out his firearm and began shooting. FUSILIER stated that he shot at the victim until he had no more rounds left, and he believed he shot approximately six times.

After interviewing witnesses inside of room 319, no parties were able to cooperate FUSILIER'S story. Witnesses stated no other parties were argumentative with FUSILIER and that no other firearms were visible at the time of the shooting.

After further investigation, Detectives are charging FUSILIER with Attempted Homicide x2 and Unlawful Possession of a Weapon.
