AFFIDAVIT OF COMPLAINT In the General Sessions Court of Hamilton State of Tennessee vs. VAUGHN, MALLORY A

The undersigned affiant, after being duly sworn according to the law, VAUGHN, MALLORY A whose name is otherwise unknown to the affiant, committed the offense of DRUGS GENERAL CATEGORY FOR RESALE in the above county at (Location) 3901 WEBB OAKS CT on or about 7/6/2022 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

ON 07/06/2022 AT 22:42 HOURS, OFFICER A. ABBETT (79561) RESPONDED TO A WEAPON LAW VIOLATIONS AT 3901 WEBB OAKS CT. DURING ROUTINE PATROL POLICE OBSERVED A WHITE VEHICLE ON WEBB OAKS CT STOPPED. AS POLICE PASSED THE VEHICLE IT TURNED ITS HEADLIGHTS OFF AS IT WAS SITTING IN THE INTERSECTION. POLICE MADE CONTACT WITH THE VEHICLE AND FOUND A BLACK MALE IN THE DRIVER SEAT AND A BLACK MALE EXITED THE PASSENGER SEAT AND WENT TO THE FRONT OF THE VEHICLE. THE PASSENGER, LATER IDENTIFIED AS MR. BRANDON M POINTER, WENT TO THE HOOD AND PROPPED IT OPEN AS IF THE VEHICLE WAS BROKEN DOWN. POLICE MADE CONTACT WITH THE DRIVER, LATER IDENTIFIED AS MR. MALLORY VAUGHN, WHO ADVISED THE VEHICLE WOULD NOT START. WHILE ATTEMPTING TO HELP WITH THE VEHICLE POLICE OBSERVED A BLACK SCALE AND A BLACK HANDGUN ON THE FLOORBOARD NEXT TO MR. VAUGHN'S FEET. POLICE HAD MR. VAUGHN EXIT THE VEHICLE. POLICE ASKED BOTH PARTIES FOR THEIR INFORMATION. MR. POINTER ADVISED HIS NAME WAS BRANDON POINTER BUT GAVE A FALSE BIRTHDAY AN SOCIAL SECURITY NUMBER. MR. VAUGHN ALSO GAVE POLICE A FALSE LAST NAME BUT POLICE WERE ABLE TO IDENTIFY HIM THROUGH HIS VEHICLE REGISTRATION. POLICE FOUND THE SOCIAL SECURITY NUMBER MR. POINTER GAV - CONT. NEXT PAGE

The undersigned affiant, after being duly sworn according to the law, VAUGHN, MALLORY A whose name is otherwise unknown to the affiant, committed the offense of DRUGS GENERAL CATEGORY FOR RESALE in the above county at (Location) 3901 WEBB OAKS CT on or about 7/6/2022 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

E POLICE WAS 415-56-4662 WHICH COMES BACK TO A MR. JAMES RICHARDSON. POLICE HAD BOTH PARTIES STAND WITH ANOTHER OFFICER WHILE SEARCHING THE VEHICLE. UPON SEARCHING THE VEHICLE POLICE FOUND A LOADED SMITH AND WESSON .40 CAL HANDGUN (HRH3734), A BLACK SCALE, AND A SMALL AMOUNT OF SUSPECTED FENTANYL INSIDE THE VEHICLE. POLICE FOUND THE SUSPECTED FENTANYL IN THE MIDDLE PORTION OF THE VEHICLE. POLICE WENT TO DETAIN THE PASSENGER, MR. POINTER, AND AS POLICE PLACED HIS WRIST INTO THE HANDCUFF MR.
