

The undersigned affiant, after being duly sworn according to the law BALDRIDGE, BRETT MICHEAL whose name is otherwise unknown to the affiant, committed the offense of ASSAULT in the above county at (Location) 150 RIVER ST on or about 11/07/202 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

ON 11/07/2023 AT 18:05 HOURS, OFFICER A. BEARD (78424) RESPONDED TO A AGGRAVATED ASSAULT AT 150 RIVER ST. AT APPROXIMATELY 1759 HRS I, OFFICER BEARD, ALONG WITH OTHER OFFICERS WAS DISPATCHED TO COOLIDGE PARK FOR A DISORDER LOCATED AT 150 RIVER ST. DISPATCH ADVISED THAT A SECURITY OFFICER WAS CALLING IN STATING THAT THERE WERE SEVERAL PARTIES SKATEBOARDING IN THE PARK THAT THEY HAD TOLD TO STOP. THEY ADVISED DISPATCH THAT THEY WERE REFUSING, WOULD NOT LEAVE, AND WERE BEING DISORDERLY. WHILE IN ROUTE TO THE CALL A PARK RANGER ADVISED THAT HE WAS FLAGGED DOWN BY SOME PARTIES WHO ADVISED THAT A SECURITY GUARD HAD ASSAULTED THEM, THEIR TEN YEAR OLD CHILD, AND TOOK THEIR CHILD'S HOVER BOARD. I FIRST MADE CONTACT WITH THE PARK RANGER WHO DIRECTED ME TO THE PARTIES BY THE OUTDOOR BUILDING WHO WERE WAITING TO SPEAK WITH ME. THERE I SPOKE WITH PAULETTE HADEN AND HER TEN YEAR OLD DAUGHTER, [REDACTED]. WHILE THERE, OTHER OFFICERS IDENTIFIED THE SECURITY GUARD INVOLVED AS BRETT BALDRIDGE. WHEN I SPOKE TO THE MOTHER SHE EXPLAINED THAT THEY HAD COME TO THE PARK FOR HER CHILD'S BIRTHDAY. ONE OF THE PRESENTS WAS A GREEN JETSON HOVER BOARD WORTH 450. SHE ADVISED THEY TOOK THE BOARD INTO THE PARK TO LE - CONT. NEXT PAGE





The undersigned affiant, after being duly sworn according to the law BALDRIDGE, BRETT MICHEAL whose name is otherwise unknown to the affiant, committed the offense of ASSAULT in the above county at (Location) 150 RIVER ST on or about 11/07/202 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

T THE CHILDREN PLAY ON IT. MS. HADEN THEN STATED SHE WAS APPROACHED BY THE SECURITY GUARD WHO TOLD HER THAT IT WAS NOT PERMITTED INSIDE THE PARK AND THAT IF THEY WANTED TO RIDE IT, THEY WOULD HAVE TO DO SO IN THE STREET. SHE STATED THAT SHE COMPLIED WHEN FIRST SPOKE TO AND DID AS SHE WAS TOLD. SHE STATED HOWEVER SHE THE LATER OBSERVE OTHER SEVERAL PARTIES WITHIN THE PARK DOING THE SAME THING, BUT SECURITY WAS NOT TELLING THEM STOP. SO MS. HADEN TOOK HER CHILDREN BACK INSIDE THE PARK TO CONTINUE TO RIDE THE HOVER BOARD BECAUSE OF WHAT SHE OBSERVED. 

N SHE DID THIS, THE SECURITY GUARD PULLED AWAY FROM HER, STRUCK HER ON THE BACK OF THE HEAD WITH THE HOVER BOARD, AND PUNCHED HER SEVERAL TIMES IN THE FACE BEFORE OTHER BYSTANDERS INTERVENED AND SEPARATED THEM. AFTER WHICH THEY LOCATED THE PARK RANGER AND ASKED THAT HE CALL POLICE. I DID SPEAK TO [REDACTED] WITH MS. HADEN'S PERMISSION, AND WHILE SHE WAS PRESENT. [REDACTED] COLLABORATED THE SEQUENCE OF EVENTS THAT HER MOTHER SPOKE OF. I DID OBSERVE THAT BOTH WERE INJURED. MS. HADEN HAD SCRATCHES AND ABRASIONS ON HER ARMS. [REDACTED] VISIBLY COULD BE SEEN LIMPING AND FAVORING HER LEG STATING HER ANKLE HURT AS WELL AS HER HEAD. I SPOKE TO A PARTY WITH OUTDOOR CHATTANOOGA, A CITY EMPLOYEE, WHO IDENTIFIED HERSELF AS SARAH ASHER WHO STATED THAT SHE WAS A WITNESS. PULL IT OUT FROM UNDER HER OR PUSH HER. HE STATED THAT WHEN HE DID THIS, HE WAS THEN ASSAULTED BY MS. HADEN AND ANOTHER UNKNOWN FEMALE PARTY SO HE DEFENDED HIMSELF. DURING THE COURSE OF THE INVESTIGATION I FOUND THAT SECURITY OFFICERS HAVE NO LEGAL AUTHORITY TO CONFISCATE ANYONE'S PERSON PROPERTY EVEN IF THEY ARE VIOLATING PARK RULES. I ASKED MS. HADEN IF SHE WISHED TO PRESS CHARGES AND SHE STATED THAT SHE DID. DUE TO THE VICTIM AND WITNESS TESTIMONY I HAD ENOUGH PROBABLE CAUSE TO DETERMINE THAT THE SECURITY OFFICER WAS THE AGGRESSOR AND ACTED OUT OF THE SCOPE OF HIS AUTHORITY. I PLACED BRETT BALDRIDGE IN CUSTODY, THEN TRANSPORTED HIM TO THE SILVERDALE DETENTION CENTER WHERE HE IS CHARGED WITH AGGRAVATED ASSAULT, SIMPLE ASSAULT, AND THEFT. THE DEFENDANT DID NOT ADVISE ANY CHILDREN WOULD BE LEFT ALONE OR IN DANGER DUE TO HIS ARREST. NO FURTHER.
