Valerie is a jewel. She has kept me informed by telephone, sent me mail and each copy of the Crossville Chronicle. Valerie adds so much because she is so dedicated and sincere about her job and our City Government.

Fred has called frequently with updates, especially the budget.

I also wish to commend Sandy Gruber for her professionalism. She has been so helpful with all that goes with an employee out with medical problems.

I've had conference calls with our economic development team-Billy Loggins, Kevin Dean, Valerie Hale, Don Napier, and David Simcox.


