




MR. HOOD WAS THE PASSENGER IN THE VEHICLE THAT WAS IN AN ACCIDENT AT 2100 HAMILTON PLACE BLVD. HE EXITED THE VEHICLE AND APPROACHED THE OTHER DRIVER AND TRIED TO BRUSH THE ACCIDENT OFF AND THE OTHER DRIVER WANTED A REPORT. MR. HOOD ADVISED IN AN UNRULY MANNER THAT HE DIDNT HAVE TO ABIDE BY WHAT THE OFFICER REQUESTED. MR. HOOD RUBBED UP AGAINST THE OFFICER AND TOLD THE OFFICER HE RAN INTO HIM AND THEN HE SWACKED THE FLASH LIGHT OUT OF THE OFFICERS HAND AT THAT TIME HANDS WERE PLACED ONTO MR HOOD AND HE JERKED AWAY.
