OFFENSE OCCURRED IN KNOX COUNTY, TENNESSEE.



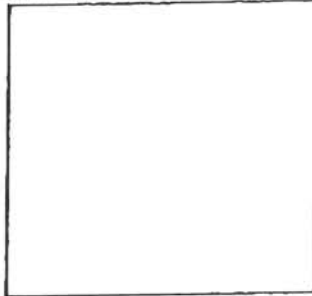
