(Chattanooga, TN) JUDICIAL POLL. In furtherance of the policy considerations stated in subsection (b) of this article, the Board of Governors shall conduct a referendum in November, 1983 and in November of every fourth year thereafter as to the judicial competence of all incumbent judges of the City of Chattanooga and Hamilton County, and of the State of Tennessee sitting at Chattanooga, and of the United States sitting at Chattanooga. 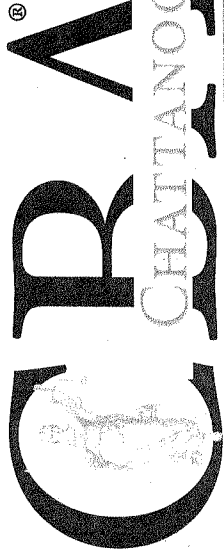

- 747 Polls were mailed in November of 2011
- Received 128 – 17.14% of the membership

- Therefore, of the 128 ballots received, 113 were valid for tabulation – 15.13% of the membership
