

## AFFIDAVIT

I, Gregory A. Grammer, after being duly sworn, state as follows:

1. My name is Gregory A. Grammer. I am more than 18 years of age and am competent to testify to the facts set forth in this Affidavit.
2. I make this affidavit of my own free will and based on my personal knowledge of the events which occurred on July 23, 2012 (hereafter, "the night of the alleged incident").
3. I have been in a romantic relationship with Susan Calfee Elliott.
4. Ms. Elliott and I were present 2471 Cumberland Trace, Cleveland, Bradley County, Tennessee on the evening of July 23, 2012.
5. I was emotionally distraught that night having recently lost my job. Furthermore, I was very emotionally upset about my on-going divorce.
6. I had been drinking alcohol that day and at some point that evening. I am unclear as to how much alcohol I consumed that day.
7. I believe that my thinking was impaired due to my consumption of alcohol on the night of the alleged incident.
8. I passed out several times while at Ms. Elliott's residence.
9. At some point, Ms. Elliott and I got into an argument on the night of the incident.
10. At no time during the night of the alleged incident did Ms. Elliott swing a baseball bat or paddle in my direction.
11. At no time during the night of the alleged incident did Ms. Elliott strike me with a baseball bat or paddle.
12. However, I do remember falling down and seeing a baseball bat on the floor of Ms. Elliott's residence and I may have fallen on the bat.

13. I was angry with Ms. Elliott the night of the alleged incident.
14. I do recall playing with Ms. Elliott's young child while at her residence the night of the alleged incident.
15. At no time did Ms. Elliott instruct her child to bite me the night of the alleged incident. In fact, I state categorically that this did not happen.
16. Furthermore, I do hereby recant and disavow those statements regarding Ms. Elliott and her child related to the alleged incident in their entirety as attributed to me and reported by law enforcement in the affidavit of complaint filed against Ms. Elliott.
17. Given my emotional and impaired state, I do not recall making any criminal accusations against Ms. Elliott to any law enforcement officer the night of the alleged incident.
18. I did not knowingly intend to mislead or deceive any law enforcement officer about the events of the night of the alleged incident.
19. I understand that this Affidavit could potentially expose me to criminal investigation or criminal prosecution, but I feel it necessary to tell the truth as I recall it.
