Dear Mr. Attorney General:
The purpose of this letter is to request a federal criminal investigation of the Chattanooga Housing Authority (CHA) in relation to its apparently irregular and illegal methods of attempting to sell the Harriet Tubman Housing site in Chattanooga, Tennessee, which is owned by the United States of America, Department of Housing and Urban Development.

The request is made by The People Coalition for Affordable Housing in response to a unanimous vote of its board, which directed that the enclosed newspaper articles be enclosed to indicate the urgent need for a criminal investigation. Members of the board will cooperate fully with such and will provide personal testimony regarding public and private meetings they have had with the board and staff of CHA.

Copies of this letter are being sent to the persons noted below to expedite the investigation, and hopefully, to elevate the public's opinion of our federal government.
