HOW VIOLATION(s) OCCURRED

- Rule # 1: Aveus Bailey was arrested on 04/10/2014 and charged with Evading Arrest (GS# 1542998) and Carrying a Dangerous Weapon with Intent to go Armed (GS# 1542999). These charges are pending in Hamilton County General Sessions Court and a Court date is currently scheduled for 04/29/2014. The affidavit will be submitted in an addendum once it is made available.
- Rule #2: Mr. Bailey has failed to immediately report this arrest to his supervising Officer as required.
- Rule # 3: Mr. Bailey was allegedly in possession of a dangerous weapon at the time of his arrest.
- Rule # 4: Mr. Bailey has failed to provide any verification of employment since being released to probation.
- Rule # 6: Mr. Bailey has failed to report to the probation office since 01/08/2014.
- Rule # 7: Mr. Bailey is charged with Evading Arrest, which indicates that he failed to comply with consent to search his person, property or place of residence by a law enforcement officer.
- Rule \$ 9: Mr. Bailey currently owes \$295.99 in supervision fees.
- Rule # 14: Mr. Bailey is a validated member of the Rollin 60 Crips street gang.

HISTORY OF SUPERVISION

On 03/29/2010 in Hamilton county Criminal Court Division 1, Aveus Bailey pled guilty on case 271335, Count 1 to Robbery and was sentenced to three (3) years in the Tennessee Department of Correction (TDOC) to serve. He pled guilty on Count 2 to Robbery and was sentenced to three (3) years in TDOC, suspended on three (3) years of supervised probation, consecutive to Count 1. He was granted a Judicial Release from TDOC on 08/30/2011 and began reporting to supervised probation on 09/02/2011.

On 03/26/2012 Mr. Bailey was arrested by the Chattanooga Police Department and charged with Aggravated Robbery and Theft of Property. Due to these new charges, as well as a charge of Driving on Revoked (Collegedale), failure to report the arrest and having a positive drug screen (marijuana), a violation report was filed with the Court on 03/30/2012. On 07/16/2012 the charge of Aggravated Robbery was dismissed. Mr. Bailey pled guilty on 07/16/2012 to Theft of Property (case 284280) and was sentenced to 11 months and 29 days in the County Workhouse, to serve. On that same date, the revocation on case 271335 was sustained and Mr. Bailey was ordered to serve 11 months and 29 days and that return to intensive supervised probation.

On 12/15/2012 Mr. Bailey was arrested and charged with Domestic Assault (dismissed 1/09/2013), Theft of Property (dismissed 1/09/2013), Reckless Endangerment (dismissed 9/26/2013), Reckless Driving (dismissed 9/26/2013), Evading Arrest, False Reports, Criminal Impersonation (dismissed 9/26/2013) and Tampering with or Fabricating Evidence. Due to these new charges as well as failure to provide employment verification, failure to report/absconding and failure to pay supervision fees, a violation report was filed with the Court on 05/20/2013. On 09/26/2013 Mr. Bailey pled guilty on case 287039 Count 3 to Evading Arrest and was sentenced to serve 11 months and 29 days in the County Workhouse. He pled guilty on case 287039 Count 4 to False Reports and was sentenced to two (2) years in TDOC, suspended on supervised probation for two (2) years after serving 11 months and 29 days. He pled guilty on case 287039 Count 6 to Tampering with Evidence and was sentenced to three (3) years in TDOC, suspended on supervised probation for three (3) years after serving 11 months and 29 days.

Mr. Bailey was released from custody on 12/17/2013 and reported back to probation on 12/18/2013. He reported again on 01/08/2014, however he has not reported since that date. Mr. Bailey has not provided any employment verification since being released to probation and he currently owes \$295.99 in supervision fees. Mr. Bailey is a validated member of the Rollin 60 Crips street gang. He did attend the Violence Reduction Initiative call-in on 03/20/2014 as instructed. However he did not make any contact with Officer Fielding after that meeting to schedule an appointment.

Aveus Bailey was arrested on 04/10/2014 and charged with Evading Arrest (GS# 1542998) and Carrying a Dangerous Weapon with Intent to go Armed (GS# 1542999). These charges are pending in Hamilton County General Sessions Court and a Court date is currently scheduled for 04/29/2014. Mr. Bailey has failed to immediately report this arrest to his supervising Officer as required. The affidavit will be submitted in an addendum once it is made available.
