On Sunday, May 11th, 2014, at approximately 14:00, I Deputy Teague #543, received a Dispatch to call Sgt. Carson, with the Calhoun Police Department, in reference to a possible Rape. At that time I placed a phone call to Dispatch and obtained Sgt. Carson's Telephone number. After doing so I placed several phone calls to Sgt. Carson, with each call going straight to Voice mail. I then left a message for Sgt. Carson, advising him I was Deputy Teague #543, with the Gilmer County Sheriff's Office, and to place me a call back when he got the message. Shortly thereafter I received another Dispatch, advising me that Sgt. Carson was on the telephone with them. At that time I placed a phone call to Dispatch, and was conference with Sgt. Carson. Upon speaking with Sgt. Carson, I was advised by him that he was at the Hospital in Calhoun with a [REDACTED]. He stated that [REDACTED] was at the Hospital, alleging that she had been raped earlier this morning, by multiple guys. Sgt. Carson stated that [REDACTED] was not disclosing who it was that raped her, only that at around 02:00, this morning, she passed out in the upstairs bathroom, at the residence of 20 Edge water Dr, in Coosawattee River Resort.

Sgt. Carson stated that [REDACTED] and several other males and females had evidently rented the residence for Prom night, from a Mr. and Mrs. Joe and Tammy Stewart, who's primary residence was also in Calhoun Ga. Sgt. Carson wasn't able to provide any of the suspects names, stating that [REDACTED] was unable to remember who had committed the crime. At that time I collected [REDACTED] full name [REDACTED] and her Date of Birth. I then obtained her current address, along with the address of where the crime had allegedly taken place. I then obtained from Sgt. Carson a telephone number for the property owners of 20 Edge water Dr. After doing so I advised Sgt. Carson that I would pass the information on to the on call Detective, and have him place Sgt. Carson a phone call. I then ended the conversation and had Dispatch inform the on call Detective to place me a phone call. Shortly thereafter I received a phone call from Detective Camp. At that time I informed Detective Camp of everything I had learned. I advised Detective Camp that I would do the Initial report and forward it to him. I then placed a telephone call to Sgt. Patterson #509, and informed him of all that had taken place.

Nothing further to report.
