for that the said accused in the County of Whitfield and the State of Georgia on the 9th day of March, 2014, while in the commission of a felony, to wit: Armed Robbery as alleged in Count 7 of this Presentment, caused the death of Dahyabhai Kalidas Chaudhari, another human being, by stabbing Dahyabhai Kalidas Chaudhari with a knife, contrary to the laws of said State, the good order, peace and dignity thereof.

*COUNT 7*

AND THE GRAND JURORS AFORESAID, in the name and on the behalf of the citizens of Georgia, charge and accuse

**SKYY RAVEN MARIE MIMS**

with the offense of

**ARMED ROBBERY**

for that the said accused in the County of Whitfield and the State of Georgia on the 9th day of March, 2014, with the intent to commit theft, she took property of another, to wit: United States currency and lottery tickets, the property of Birva, Inc., d/b/a Kanku's Express, from the immediate presence of another, to wit: Dahyabhai Kalidas Chaudhari, by use of offensive weapons, to wit: a knife and a pink and black Airsoft Smith & Wesson Chiefs Special .45 pistol, contrary to the laws of said State, the good order, peace and dignity thereof.

with the offense of

**BURGLARY IN THE 2<sup>ND</sup> DEGREE**

for that the said accused in the County of Whitfield and the State of Georgia on the 9th day of March, 2014, without authority and with the intent to commit a theft therein, entered and remained within a building, to wit: the gas station and convenience store business of Birva, Inc., d/b/a/ Kanku's Express, located at 3385 Airport Road, contrary to the laws of said State, the good order, peace and dignity thereof.

AND THE GRAND JURORS AFORESAID, in the name and on the behalf of the citizens of Georgia, charge and accuse

for that the said accused in the County of Whitfield and the State of Georgia on the 9th day of March, 2014, had on her person a knife having a blade of more than three inches in length during the commission of crimes, to wit: Murder, Aggravated Assault and Armed Robbery as alleged in Counts one through eight of this Presentment, said crimes being against and involving the person of another, to wit: Dahyabhai Kalidas Chaudhari, contrary to the laws of said State, the good order, peace and dignity thereof.

AND THE GRAND JURORS AFORESAID, in the name and on the behalf of the citizens of Georgia, charge and accuse

**SKYY RAVEN MARIE MIMS**

with the offense of

**THEFT BY BRINGING STOLEN PROPERTY INTO THE STATE**

for that the said accused in the County of Whitfield and the State of Georgia between the 30th day of January, 2014, and the 9th day of March, 2014, the exact date of the said offense being unknown to the Grand Jury, brought into this state property, to wit: a green 2012 Kia Soul, the property of Julie Ann Rose, said property having a value greater than five-thousand dollars (\$5,000.00) but less than twenty-five thousand dollars (\$25,000.00), which she knew and should have known had been stolen in another state, to wit: Michigan, contrary to the laws of said State, the good order, peace and dignity thereof.
