**AFFIDAVIT OF COMPLAINT** In the General Sessions Court of Hamilton State of Tennessee vs. RITCHIE, JEREMY SCOTT

The undersigned affiant, after being duly sworn according to the law, RITCHIE, JEREMY SCOTT whose name is otherwise unknown to me, committed the offense of RECKLESS ENDANGERMENT in the above county at (Location)

4250 MAY ROAD on or about 11/23/201 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

ON 11/23/2013 AT APPROXIMATELY 1735 HOURS, I DEPUTY JOHNSON WAS DISPATCHED TO 1536 LEE PIKE ON AN ASSAULT. I DEPUTY JOHNSON ARRIVED ON SCENE WHERE A CRYSTAL PERRY (11/01/1974) HAD WALKED TO THIS RESIDENCE AFTER JUMPING FROM A MOVING VEHICLE. MS. PERRY HAD OBVIOUS WOUNDS TO HER FACE AND BODY. MS. PERRY ADVISED HER BOYFRIEND JEREMY SCOTT PERRY (03/04/1975) AND SHE WERE COMING HOME FROM PIGEON FORGE WHERE THEY HAD EATEN AND HAD A FEW ALCOHOLIC BEVERAGES AT A RESTAURANT. MS. PERRY ADVISED JEREMY WAS MAD AT HER BECAUSE SHE HAD SMOKED AND TALK TO ANOTHER MALE AT THE RESTAURANT. MS. PERRY SATED THAT SHE AND JEREMY WERE ARGUING ABOUT THE INCIDENT AS THEY TRAVELED UP LEE PIKE WHEN JEREMY GRABBED HER BY THE BACK OF THE HEAD BY THE HAIR AND BEGAN TO SLAM HER HEAD INTO THE CENTER CONSOLE AND THE DASH MS. PERRY HAD A SWOLLEN LEFT EYE AND A SPLIT UPPER LIP AND WAS MISSING HER FRONT TEETH AND HAD OTHER MARKS TO HER RIGHT ARM, BACK, AND CHEST (PHOTOS TAKEN).

MS. PERRY IN ATTEMPTS TO GET AWAY FROM JEREMY JUMPED FROM THE VEHICLE AS IT WAS TRAVELING DOWN THE ROAD AND JEREMY AND THE VEHICLE CONTINUED ON.

The undersigned affiant, after being duly sworn according to the law RITCHIE, JEREMY SCOTT whose name is otherwise unknown to me affiant, committed the offense of RECKLESS ENDANGERMENT in the above county at (Location) 4250 MAY ROAD on or about 11/23/201 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows

MS. PERRY WAS ADVISED TO GO TO THE HOSPITAL AND GET CHECKED DUE TO HER INJURIES. MS. PERRY REFUSED EMS TRANSPORT BUT LEFT THIS LOCATION WITH HER MOTHER TO GO TO THE HOSPITAL.

AT 1743 HOURS, DEPUTIES WERE DISPATCHED TO 14250 MAY ROAD ON THE OTHER HALF OF THE ASSAULT. WITH JEREMY CLAIMING THAT MS. PERRY HAD ASSAULTED HIM. AS DEPUTIES ARRIVED ON SCENE AT THIS LOCATION JEREMY WAS INTOXICATED AND BECAME AGGRESSIVE TOWARDS DEPUTIES WHERE HE WAS THEN PLACED IN CUSTODY FOR PUBLIC INTOXICATION AND DISORDERLY CONDUCT (COMPLAINT # 13-042470).

DEPUTIES ON SCENE AT MAY ROAD ADVISED THE VEHICLE WAS AT THIS LOCATION AND HAD BLOOD ALL OVER THE INSIDE OF THE VEHICLE AND TEETH IN THE PASSENGER SEAT AS WELL AS DAMAGE TO THE CENTER CONSOLE OF THE VEHICLE. DEPUTIES ALSO ADVISED THAT JEREMY HAD A SWOLLEN RIGHT EYE AND MULTIPLE LACERATIONS TO THE TOPS OF HIS HANDS. JEREMY WAS TRANSPORTED TO THE HAMILTON COUNTY JAIL ON THE DISORDERLY CONDUCT AND PUBLIC INTOXICATION
