**AFFIDAVIT OF COMPLAINT** In the General Sessions Court of Hamilton State of Tennessee vs. LOWRY, RHASEAN

The undersigned affiant, after being duly sworn according to the law, LOWRY, RHASEAN whose name is otherwise unknown to me as the affiant, committed the offense of AGGRAVATED CHILD ABUSE in the above county at (Location) 1410 AMNICOLA HWY. on or about 8/26/2014 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

On 08/26/2014, I, INVESTIGATOR WILLOUGHBY, WAS NOTIFIED OF A THREE YEAR OLD VICTIM, TATIANA EMERSON, WHO WAS AT PARKRIDGE HOSPITAL AND THE ER STAFF WERE REPORTING THAT HER INJURIES WERE SUSPICIOUS FOR CHILD ABUSE. THE VICTIM WAS TRANSPORTED TO ERLANGER'S CHILDREN'S HOSPITAL DUE TO THE SEVERITY OF THE INJURIES. I RESPONDED AND SPOKE WITH SEAN LOWRY WHO STATED THAT HE LIVES AT 7421 BONNY OAKS DR. #203 (ECONO LODGE MOTEL) WITH HIS GIRLFRIEND, MELANIE EMERSON. MR. LOWRY STATED THAT HE TAKES CARE OF MS. EMERSON'S CHILDREN WHILE SHE WORKS. ON THIS DATE, MR. LOWRY WAS BABYSITTING ALL THREE CHILDREN, INCLUDING MS. EMERSON'S DAUGHTER/VICTIM, TATIANA EMERSON. HE STATED THAT WHILE SHE WAS IN HIS CARE, THEY WENT DOWNSTAIRS TO GET SOME MILK FOR BREAKFAST. WHEN THEY WENT BACK UP THE STAIRS, THE VICTIM TRIPPED WHILE AT THE VERY TOP OF THE STAIRS AND FELL BACKWARDS DOWN THE STEPS, STRIKING HER HEAD ON THE HANDRAIL AND THEN TUMBLING TO THE BOTTOM WHERE MR. LOWRY WAS STANDING. HE STATED THAT HE CARRIED THE VICTIM AND HER YOUNGER SIBLING TO THEIR ROOM WHERE HE NOTICED THAT THE VICTIM WAS BLEEDING FROM HER MOUTH. MR. LOWRY STATED THAT TATIANA KEPT SAYING THAT HER HEAD WAS HURTING. AFTER TENDING TO THE - CONT. NEXT PAGE

**AFFIDAVIT OF COMPLAINT** In the General Sessions Court of Hamilton State of Tennessee vs. LOWRY, RHASEAN

The undersigned affiant, after being duly sworn according to the law, LOWRY, RHASEAN whose name is otherwise unknown to the affiant, committed the offense of AGGRAVATED CHILD ABUSE in the above county at (Location) 3410 AMNICOLA HWY. on or about 8/26/2014 Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

VICTIM IN HIS ROOM, HE STATED THAT HE LEFT BOTH HER AND THE BABY WHILE HE WENT BACK DOWNSTAIRS TO GET SOME ICE. HE STATED THAT WHEN THE VICTIM FELL, SHE HAD A CUP OF MILK IN HER HAND AND IT HAD SPILT ON THE STEPS SO WHEN HE WENT BACK DOWN TO GET THE ICE, HE CLEANED IT UP AND THREW THE CUP AWAY. ONCE HE CAME BACK TO THE UNATTENDED CHILDREN, HE STATED THAT HE STRAIGHTENED HIS ROOM UP FOR HOUSEKEEPING AND THEN GOT THE CHILDREN IN THE CAR. HE STATED THAT THE VICTIM KEPT SAYING THE ENTIRE TIME THAT HER HEAD WAS HURTING SO HE KNEW HE HAD TO GET HER TO THE HOSPITAL. MR. LOWRY STATED THAT HE THEN DROVE FROM THE ECONO LODGE ON BONNY OAKS DR. TO PARKRIDGE HOSPITAL ON MCCALLIE AVE. HE STATED THAT ABOUT HALF WAY THERE HE REALIZED THAT TATIANA WAS UNCONSCIOUS AND HE CONTINUED DRIVING HER EVEN THOUGH HE HAD A CELL PHONE IN HIS POSSESSION TO SUMMONS EMERGENCY MEDICAL ASSISTANCE. ONCE AT THE HOSPITAL, MR. LOWRY PARKED THE CAR AND WENT INSIDE TO GET HELP. I THEN RESPONDED TO THE ECONO LODGE AND SPOKE WITH THE MANAGER, KANTI PATEL, WHO ALLOWED POLICE TO REVIEW THE MOTEL VIDEO SURVEILLANCE. VIDEO EVIDENCE SHOWED MR. LOWRY CARRYING WHAT APPEARED TO BE THE LIMP BODY OF TATIANA TO HIS CAR AROUND - CONT. NEXT PAGE



**AFFIDAVIT OF COMPLAINT** In the General Sessions Court of Hamilton State of Tennessee vs. LOWRY, RHASEAN

I, the undersigned affiant, after being duly sworn according to the law, LOWRY, RHASEAN whose name is otherwise unknown to me as the affiant, committed the offense of AGGRAVATED CHILD ABUSE in the above county at (Location) 1410 AMNICOLA HWY. on or about 8/26/2014. Further, affiant makes oath that the essential facts constituting said offense, the sources of affiant's information, and the reasons why his/her information is believable concerning said facts are as follows:

At 9:52AM, HE THEN DROVE AROUND TO THE FRONT LOBBY AND WENT INSIDE, LEAVING THE VICTIM AND HER BABY SIBLING IN THE CAR UNATTENDED. HE THEN MADE A TRANSACTION AT THE FRONT COUNTER WITH THE MANAGER, KANTI PATEL. MR. PATEL STATED THAT THE TRANSACTION WAS MR. LOWRY PAYING FOR ANOTHER NIGHT AT THE MOTEL. ACCORDING TO MR. PATEL, MR. LOWRY NEVER MENTIONED ANY MEDICAL EMERGENCY WITH THE VICTIM. AT APPROXIMATELY 10:00AM MR. LOWRY LEFT THE PARKING LOT IN HIS VEHICLE AND WENT EAST ON BONNY OAKS DR. TOWARDS I-75. AT APPROXIMATELY 10:25AM MR. LOWRY ARRIVED AT PARKRIDGE HOSPITAL. ACCORDING TO MR. LOWRY, THE VICTIM HAD NOW BEEN UNCONSCIOUS FOR AT LEAST 12 MINUTES BUT INSTEAD OF CARRYING THE THREE YEAR OLD INTO THE HOSPITAL, HE PARKED HIS CAR AND LEFT THE VICTIM AS HE WENT INSIDE TO GET HELP. DURING MR. LOWRY'S SECOND INTERVIEW AT THE PSC, THE DETAILS OF HIS STORY WERE NOT CONSISTENT. I SPOKE WITH DR. CHURCH WHO IS THE CHILD ABUSE SPECIALIST AND SHE ADVISED THAT THE SEVERE INJURIES THAT THE VICTIM SUSTAINED COULD NOT HAVE OCCURRED AS MR. LOWRY EXPLAINED. THIS OCCURRED WITHIN THE CHATTANOOGA CITY LIMITS IN HAMILTON COUNTY, TN. MR. LOWRY WAS CHARGED WITH AGGRAVATED CHILD ABUSE.
