Two weeks ago I sent you all a message reminding everyone to be mindful of how we publicly represent ourselves, particularly through social media. That original email is included below.

As citizens we all have a right to comment about social and political issues in public settings including social media. As law enforcement officers and as public servants we must be ever vigilant of the fact that what we say – and how and where we say it – reflects on the department, the city and the profession we represent. Social media is part of our everyday culture and is a tool we all can – and should – utilize. We are building relationships with community members and that relationship can and should be fostered in every medium. When engaging our community we should, as public servants, hold ourselves to the highest standards of behavior and professionalism. The public expects this. I expect this.

As stated in policy, employees shall conduct themselves at all times—both on and off duty—in such a manner as to reflect favorably on the Department.

## Section II. S. Unbecoming Conduct:

- 1. Employees shall conduct themselves at all times—both on and off duty—in such a manner as to reflect favorably on the Department. Conduct unbecoming a public employee includes conduct that is unlawful and/or brings the Department into disrepute, reflects discredit upon the employee as a member of the Department, or impairs the operation or efficiency of the Department or officer.
- 2. The above conduct includes representations made on and in all forms of social media. Social media includes, but is not limited to, Facebook, Twitter, MySpace and other public or private technologies that may emerge. This would also apply to both public and restricted profiles. Department personnel should assume that their speech and related activity on social media sites will reflect upon their office and this department.

When engaging with citizens by any means, whether in person or via social media, I have an expectation that all officers conduct themselves in a manner that reflects positively on our department, our mission and our values. Let me be clear, we will not tolerate any behavior by a Chattanooga Police officer that is abusive, harassing, threatening, profane or otherwise reflects unfavorably on the Chattanooga Police Department.

There are times when we may feel attacked in person or in media. How we respond will determine how well the community supports us. When we act professionally and treat people with dignity we build goodwill. When we build goodwill we will be supported by the community. Our goal is to develop partners. We endeavor to be a part of our community and not apart from our community.

You all respond every day to situations which are inflammatory and you do so with restraint, respect and compassion. You all go out of your way to reach out to our community and make them feel safe and appreciated by the police department. I see you do this privately and I see you share this in public. I am proud of the efforts you all take on a regular basis to represent the best of our profession and our department. We will continue to treat everyone in our community with respect and dignity, regardless of any difference of opinion.
