Dear Attorney General Slatery,

Greetings from the General Assembly. It was with incredulity that we heard of the latest overreach of this federal administration. They have no legal authority to direct schools to accommodate students with gender identity disorder at the expense of the mentally healthy enrollment.

When the constitution and/or the law do not result in the advancement of their far left social agenda, they seem to resort to their preferred tactic: bullying. Bullying through threats of withholding the legal return of our pass through dollars and bullying through their unique deployment of mobocracy seem to be interchangeable weapons in the arsenal used to achieve assumed unilateral authority.

We are asking you to challenge the legal authority of the federal government to enforce any "directives" or financial withholding threats contained in the guidance letter issued on Thursday, May 12, 2016.
