
AFFIDAVIT OF COMPLAINT

I, THE AFFIANT NAMED BELOW, AFTER BEING SWORN, STATE UNDER OATH THAT ON OR ABOUT FEBRUARY 08 2017 IN MARION COUNTY TENNESSEE, KELVIN PELL COMMITTED THE OFFENSE (S) OF VIOLATION (S), TCA 39-13-514 PATRONIZING PROSTITUTION

I FURTHER STATE UNDER OATH THAT THE ESSENTIAL, FACTS CONSTITUTING THE OFFENSE (S), THE, SOURCES OF MY INFORMATION AND THE REASONS WHY THIS INFORMATION IS BELIEVABLE AND RELIABLE ARE AS FOLLOWS:

On February 08, 2017, your affiant participated in an undercover operation in which the defendant acting as a licensed bail bondsman for Cumberland Bail Bonds, bonded a female out of jail for a second time. The defendant had previously bonded the female out of jail and then exchanged text messages with the female indicating that she was gorgeous and beautiful. During the event on February 08, 2017 the defendant walked the female from the jail to his office located at 200 Betsy Pack Dr, Jasper, TN 37347. Prior to the female leaving the jail, she was equipped with covert equipment that allowed your affiant to monitor and record her conversation with the defendant. While at bonding office the female indicated that she did not have money to pay for the \$1,000 bond. The defendant indicated that they could work out a deal and asked the female to show her breasts, and at one point the defendant also touched the female's breast without her consent. The defendant and the female then traveled to a hotel room in Kimball, Tennessee where they engaged in conversation regarding the trade of sex in exchange for the bond money that the female owed. The defendant agreed that they could work out a trade and preceded to take his pants, underwear, shoes and socks off. At that point Law Enforcement entered the room and took the defendant into custody. The defendant was transported to the Marion County Justice Center and interviewed by law enforcement. During the interview the defendant confessed that he has engaged in this type of activity with multiple females in the past and indicated that this type of activity is a common occurrence in the bonding industry.
