THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly kill D'Myunn Brown by the operation of a motor vehicle, the killing being the proximate result of conduct creating a substantial risk of death or serious bodily injury to another person, in violation of Tennessee Code Annotated 39-13-213, against the peace and dignity of the State.

Count 2:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly kill Zyanna Harris by the operation of a motor vehicle, the killing being the proximate result of conduct creating a substantial risk of death or serious bodily injury to another person, in violation of Tennessee Code Annotated 39-13-213, against the peace and dignity of the State.

Count 3:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly kill Cordayja Jones by the operation of a motor vehicle, the killing being the proximate result of conduct creating a substantial risk of death or serious bodily injury to another person, in violation of Tennessee Code Annotated 39-13-213, against the peace and dignity of the State.

Count 4:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly kill Zyaira Mateen by the operation of a motor vehicle, the killing being the proximate result of conduct creating a substantial risk of death or serious bodily injury to another person, in violation of Tennessee Code Annotated 39-13-213, against the peace and dignity of the State.

Count 5:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly kill Zoie Nash by the operation of a motor vehicle, the killing being the proximate result of conduct creating a substantial risk of death or serious bodily injury to another person, in violation of Tennessee Code Annotated 39-13-213, against the peace and dignity of the State.

Count 6:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly inflict mortal injuries on Keon'te Wilson by the operation of a motor vehicle, which resulted in the death of Keon'te Wilson on November 23, 2016, the killing being the proximate result of conduct creating a substantial risk of death or serious bodily injury to another person, in violation of Tennessee Code Annotated 39-13-213, against the peace and dignity of the State.

Count 7:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly cause bodily injury to Nire Yana Fortson, by use of a deadly weapon, in violation of Tennessee Code Annotated 39-13-102, against the peace and dignity of the State.

Count 8:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly cause bodily injury to Karrieun McGuire, by use of a deadly weapon, in violation of Tennessee Code Annotated 39-13-102, against the peace and dignity of the State.

Count 9:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly cause bodily injury to Zechariah Nash, by use of a deadly weapon, in violation of Tennessee Code Annotated 39-13-102, against the peace and dignity of the State.

Count 10:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly cause bodily injury to Izehia Stevenson, by use of a deadly weapon, in violation of Tennessee Code Annotated 39-13-102, against the peace and dignity of the State.

Count 11:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and recklessly engage in conduct which placed the public at large in imminent danger of death or serious bodily injury, by use of a deadly weapon, in violation of Tennessee Code Annotated 39-13-103, against the peace and dignity of the State.

Count 12:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, did unlawfully and knowingly drive a motor vehicle upon and over public streets and highways of Hamilton County, Tennessee, carelessly, heedlessly and recklessly, in a manner so as to endanger the life, limb and property of other persons, and in wanton and willful disregard of the rights and safety of other persons, in violation of Tennessee Code Annotated 55-10-205, against the peace and dignity of the State.

Count 13:

THE GRAND JURORS for the State aforesaid, being duly summoned, elected, impaneled, sworn and charged to inquire for the body of the County aforesaid, upon their oaths present:

That Johnthony K. Walker heretofore on November 21, 2016, in the County aforesaid, was a school bus driver operating a school bus as defined by TCA 55-8-101 in Hamilton County, State of Tennessee, and was unlawfully and knowingly using a portable electronic device when the vehicle was stopped for the purposes of loading or unloading one (1) or more children from vehicle in violation of Tennessee Code Annotated 55-8-192 (b), against the peace and dignity of the State.
